Notice is hereby given that the annual Taxes imposed by the Act of the Legislature of this Province, passed in the Session of 1894, entitled "An Act to impose certain Taxes on certain Incorporated Companies and Associations," are as follows:

On each of the Companies or Associations whose head office is not within this Province, namely: Fire Insurance Companies, \$100 Life or Endowment Insurance Companies, 150 Accident and Guarantee Insurance Companies, 25 Trust or Loan or Building Companies or Associations, 150 Telegraph Companies, 250

On each of the Banks, whether the head office is in this Province or not, namely: If with not more than one office in this Province, \$50 If with more than one office in this Province, 100

The above taxes are payable semi-annually, on the 1st June and 1st December in each year, to the Provincial Secretary. The first payment will be due on 1st June, 1894.
