

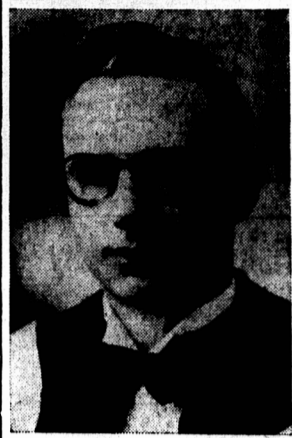
Wedding Today At Zion Manse

Death Caused By Accidental Gun Discharge

A coroner's jury empanelled to inquire into the circumstances surrounding the death of Mr. George T. Hardie, Charlottetown business man, brought in the verdict that the deceased came to his death as the result of the accidental discharge of a pump shot gun to which he was endeavoring to make repairs, on Monday, June 26. The inquest was held yesterday afternoon in the City Hall and presided over by the Coroner, Dr. I. J. Yeo. Mr. J. P. Nicholson represented the Crown. Members of the jury were Messrs. Frank Acorn, foreman, Maurice Block, D. A. MacCannell, W. B. LePage, Samuel Kennedy, Allison Horne and J. P. Murphy. Earl Reardon, Southport, who operates an electrical shop on Great George Street, testified that his office was in the same building as that of the deceased and that about 11:45 Monday morning he had occasion to go to the wash-room. The washroom was open to all tenants with keys. As witness was approaching the door he noticed that a key had been left in the lock. After coming out of the washroom he remarked in the hallway that some one had left their key in the door to which Mr. Hardie replied from his office, in a very normal tone, "It is not mine." Mr. Reardon said that the door to the office of the deceased was closed but not latched and that he could not see the man. He went down the hallway to the Electrolux office where he spoke to the stenographer, Miss Isabel Farquharson. He continued downstairs and about the time he reached the bottom of the stairs he heard a shot and a loud moan. He stated that Miss Farquharson screamed and shouted his first name. He ran upstairs and banged in Mr. Hardie's door. Then he saw the deceased sprawled on the floor in a pool of blood. He said that the body was lying on the back of a chair. Witness said he phoned Dr. Pierce and sent Miss Farquharson for Howard Hobbs, an employee of Kennedy's Men's Wear. As far as witness knew deceased was alone at the time of the shooting. Dr. H. H. Shaw, Provincial Pathologist, who conducted the autopsy, stated that the cause of death was compatible with massive hemorrhage from the aorta (large artery) leading from the heart) and lung tissues. There was a small exit in the back where the shot had gone through. From the nature of the wound it appeared that the gun had been very close to the body. Mr. Jones' Evidence Stewart Jones, operates Simpson's Agency in Charlottetown, testified that he personally knew the deceased and that he had seen him in his (Simpson's) store last Friday. He first learned about the accident when Sgt. L. A. MacInnis phoned him and asked him to tell Mr. Hardie's wife about the accident. He produced a letter from Mrs. Hardie, which stated that she had been in Montreal where her mother is seriously ill, but had returned to Charlottetown last Thursday. She found a gun in Mr. Hardie's work room on her return and learned from the deceased that it had been poorly cleaned last fall. She had seen Mr. Hardie working on the gun a number of evenings through the winter. The letter stated that the gun would not operate as it was rusty. Two children, a nephew and a niece, were expected to arrive at the Hardy home this week and the room in which the deceased had been working would be the place in which the children could sleep. Mrs. Hardy, in cleaning up the room, asked the deceased to fix the gun once more and if he failed he would send it away to a gunsmith. He said the gun was obviously jammed. Mr. Jones quoted from the letter to the effect that the deceased had been seriously ill several times and twice in the past few years he had been given up as dying. He stated that Mr. Hardie had had a major operation last summer and had been in excellent health ever since. He said the deceased took clothes to the dry cleaners Monday morning and planned on taking them home in time for a party Thursday evening. On Monday morning he took some magazines to a sick man and phoned his wife a short time after eleven to inquire about dinner. At the same time he laid plans with his wife to go out shopping at 3:30 that afternoon. Dr. H. H. Pierce testified that he received a call to attend Mr. Hardie shortly before noon on Monday. He found that the deceased was dead when he arrived and that the chair was standing upright near Hardie's feet. In his opinion the deceased had been standing when he was shot.

Rhee Says Russia's Truce Plan Is "Unacceptable"

PUSAN, Korea, June 26 (AP)—President Syngman Rhee today blasted Russia's truce plan for Korea as "entirely unacceptable," then conferred with Gen. Matthew B. Ridgway, supreme Allied commander. Ridgway himself seemed somewhat skeptical of the Russian proposal when he talked with reporters at the Pusan airfield shortly before going to see the President of the Republic of Korea. "I would want an iron-clad agreement," he said in response to a question about the cease-fire situation. "However, I'm not willing to take a bill of goods." Back in Tokyo, a secret memorandum circulated at Ridgway's headquarters questioned whether the Russian plan was a "political move" designed to place the enemy in a better position militarily. Ridgway's flying trip to the temporary South Korean capital produced some speculation that he had come to suggest that Rhee play a less-outspoken role in the cease-fire drama. Ridgway brought to Rhee's residence a bulging briefcase. He was overheard saying: "Mr. President, I have been instructed to tell you..." the remainder of the remark was not heard. Rhee has opposed vigorously any settlement that would leave Korea divided. His latest statement was in this vein: "It was described officially as also expressing the unanimous opinion of Rhee's cabinet. The deliberations of the convention will be mostly technical. Case Settled Out of Court

The case of Alexander Glydon Moore, plaintiff, versus Premier J. Walter Jones, defendant, which was to have been heard in the Supreme Court today, has been settled out of court. The plaintiff is a consulting engineer of Montreal who alleged that in 1947 he made a survey of electrical requirements in the Province. He further alleged that he made a report for the defendant but was never paid for it. The claim was for \$1,000. The defense held that the report was valueless and that, in any event, the Government, and not the Premier personally, should have been sued. LONDON (CP)—Two high-speed elevators that travel 800 feet a minute will be installed at Hampstead, the deepest station on the London underground railway. Jakob Malik, Russian delegate to the United Nations, had suggested that the "belligerents" discuss a cease-fire and withdraw their forces from the 38th parallel, the old boundary between North and South Korea. Rhee said "if the United Nations accept the peace proposal it will mean that the Soviet leaders are seeking to beat the U. N. at its own game..."

Grain Subsidy Figures Released

The Federal Government has paid a subsidy of \$8.85 a ton for the movement of Western feed grain into Prince Edward Island for stock and poultry feed since 1941. It has recently been announced in Ottawa, Agricultural Minister Gardiner. A total of 401,629 tons of feed grain have been moved into the Province at a cost in Federal assistance of \$3,554,080.65. The assistance for Nova Scotia farmers has amounted to \$8.79 a ton. 1,419,281 tons have been imported into that province at a cost of \$12,481,868.90. The cost for Newfoundland has been \$20.66 a ton. For all of Canada, a total of 27,067,452 tons have been moved at a cost to the government of \$155,327,272.55 or an average of \$5.74 per ton.

Japs On Small Island May Be Ready To Quit

GUAM, June 26 (AP)—A naval plane crew back from remote Anatahan Island today reported it spotted a white flag flying there, indicating 18 Japanese holdouts of the Second World War may be ready to surrender. Farther down the coast they passed over a group of about 10 Japanese. They reported the Japanese waved white flags. The plane circled low and dropped leaflets in Japanese telling the holdouts a navy ship would come June 30 to pick up those wishing to surrender. The holdouts have been dominated by a fanatical Japanese who refuses to believe the war is over. He has threatened to kill any of his comrades who try to surrender. The Japanese have been on Anatahan, in the Central Marianas, for seven years.

The secretary, Mrs. Dan Bradley read the financial statement which showed the sub-division had a very successful year, the sum of \$1,692.13 having been raised for parish work.

Mr. Jones' Evidence

Stewart Jones, operates Simpson's Agency in Charlottetown, testified that he personally knew the deceased and that he had seen him in his (Simpson's) store last Friday. He first learned about the accident when Sgt. L. A. MacInnis phoned him and asked him to tell Mr. Hardie's wife about the accident. He produced a letter from Mrs. Hardie, which stated that she had been in Montreal where her mother is seriously ill, but had returned to Charlottetown last Thursday. She found a gun in Mr. Hardie's work room on her return and learned from the deceased that it had been poorly cleaned last fall. She had seen Mr. Hardie working on the gun a number of evenings through the winter. The letter stated that the gun would not operate as it was rusty. Two children, a nephew and a niece, were expected to arrive at the Hardy home this week and the room in which the deceased had been working would be the place in which the children could sleep. Mrs. Hardy, in cleaning up the room, asked the deceased to fix the gun once more and if he failed he would send it away to a gunsmith. He said the gun was obviously jammed. Mr. Jones quoted from the letter to the effect that the deceased had been seriously ill several times and twice in the past few years he had been given up as dying. He stated that Mr. Hardie had had a major operation last summer and had been in excellent health ever since. He said the deceased took clothes to the dry cleaners Monday morning and planned on taking them home in time for a party Thursday evening. On Monday morning he took some magazines to a sick man and phoned his wife a short time after eleven to inquire about dinner. At the same time he laid plans with his wife to go out shopping at 3:30 that afternoon. Dr. H. H. Pierce testified that he received a call to attend Mr. Hardie shortly before noon on Monday. He found that the deceased was dead when he arrived and that the chair was standing upright near Hardie's feet. In his opinion the deceased had been standing when he was shot.

Bisley Team Out For Workout

BISLEY, England, June 23 (CP)—All 18 members of Canada's Bisley Rifle Team turned out today for workouts over the camp's widely-scattered ranges despite drizzling rain and unseasonably cold weather. Since the team's arrival last weekend for the matches starting July 2, every member has been out on the butts for brief practice shoots but today was the first time they had ventured out in full force.

Sgt. L. A. MacInnis, City Police Force, stated that he and Sgt. Duncan MacPhail went to the Tanton Building on Great George Street shortly before noon on Monday. They found the deceased in a prone position on the floor with a shot gun lying alongside his left leg. He removed the shell from the gun and found that the shell was well saturated with oil. An oil can, wrench, gas chamber and cleaning rod were lying on the table, he testified. He stated that he did not see any sign of shot gun shells in the office. Isabel Farquharson stenographer, in the Electrolux Office in the Tanton Building testified that Mr. Hardie came to her office about 11:40 Monday morning and inquired about the key to the wash room. A few minutes later Mr. Reardon came alone, and after he went downstairs she heard the shot, she testified. She stated that she did not see Mr. Hardie with a gun at any time. Dr. T. A. Laidlaw, physician testified that he lived in an upstairs apartment adjoining that of the deceased on the North River Road. The last time he had seen the deceased was on Sunday morning when he spoke to him for a moment. He stated that on the night of June 12, the deceased was working on the gun and asked him (Dr. Laidlaw) if he knew anything about guns. Witness stated that he did not but would help him if he could. Dr. Laidlaw said that the deceased had stated that he had not used the gun since last fall and was trying to put it in shape. He remarked that it must be rusty but could not understand why. Magistrate K. M. Martin, friend and family solicitor, testified that the deceased had been in his office several times, the last being Friday, June 22. He stated that Mr. Hardie and several associates owned some private property and Mr. Hardie was concerned over putting up posters on ponds for shooting. Witness said that the deceased at that time was entirely normal and in evident good health and spirits. He stated that as far as he knew there was nothing troubling him in a financial way and added that a recent judgement brought against the Hardy Agency in a dispute did not affect the deceased.
