REPLACED ENERGY.—We are very glad to see the city snow plough going through the streets after a snow storm; but if it cannot go both in the middle of the street and on the sidewalks, would it not be better to break the latter and let the sleighs break the roads? To be sure it would require those marvelous posts, erected for the inconvenience of the public to be cut down; but then we should have a path on the sidewalk. From this time on, we suppose it will be like last winter, and on some of the principal streets there will be a rabbit track of the unfortunate pedestrians.

FIRE—NARROW ESCAPE.—The dwelling house owned by Mrs. Whelan, (widow of the late Hon. E. Whelan) and occupied by herself and Mr. D. M. Fraser, was burned to the ground on Wednesday morning last. A friend and neighbor of the afflicted lady supplies the following particulars:—'About a quarter to four on Wednesday morning, Mrs. Whelan awoke up, and feeling a suffocating sensation, roused the servant girl, and directed her to see if the house was on fire. The girl got up; but was unable to detect anything burning and went to bed again. Mrs. Whelan, however, remained restless, and shortly afterwards got up herself. By this time it was apparent that the house was on fire; and she instantly roused Mr. and Mrs. Fraser. The former ran down stairs and found the lower rooms in a blaze. He called to Mrs. Whelan to get out as soon as possible; and seizing one of his own children while his wife carried the other, he ran into the street, followed by the rest of the inmates. It is thought that he had the alarm been given ten minutes later, they could not have been saved. A small hand engine managed by boys was the first on the ground; but, as the hose belonging to it barely reached from the pump, in the middle of the street to the front door, it was of little use. The next was a "Tremont" hand engine, which was out of repair, and could not be worked at all. Fully an hour elapsed before the scattered men could be got together, and the new steam engine, the "Hillsborough," was ready to play on the fire. Then a heavy stream was poured upon it and the adjoining houses were fortunately saved. The Chief of the Fire Department—Mr. McKinnon—Dr. Strickland, and the firemen generally, nobly exerted themselves at the time; but it is to be regretted that the hose and other material required was not immediately available. Under less favorable circumstances the result might have been disastrous. Mrs. Whelan sustains her last great loss with becoming fortitude.

"NOT WORTH HIS SALT."—The Canadian News, published in London, England, remarks:—

'Elsewhere we publish a correspondence which has recently taken place on the Oka Indian Reservation. Mr. Laird, as will be seen, expresses his regret that the Aborigines Society should, on the strength of a mere newspaper report, have troubled him and the Imperial Government by occasioning such unnecessary correspondence. It is only natural that a newspaper report should be a very significant matter in the eyes of the Minister of the Canadian Interior. We have never known a British Minister connected with an important department, and who was worth his salt, who did not set a high value on newspaper reporting when conducted in the public interest.'

The self-evident deduction from the above is that—judged by that standard of British Ministers who are worth their salt—Mr. Laird is not 'worth his salt.'

A FAMOUS HUNTER KILLED.—Jackson Frailey, known throughout the State as the 'Deerslayer,' and the Nimrod of the Canogaago, was killed in a fight with an immense catamount on Welsh Mountain, near Martinsville, Penn., last week. His body, when found, was terribly lacerated; and the clothing completely torn from him. It is surmised that after shooting the animal and supposing him to be dead, he placed his gun against a tree and approached the catamount to turn him over, when the beast sprang upon him and a terrible fight ensued. Frailey is said to have killed over 2,000 deer, 200 bears, twenty catamounts, three panthers, and numberless wolves and foxes. In his tenth year he killed one bear and six deer. His experience in the woods equaled many hunters; he had contests with bears and wounded bucks, from all of which he came out victorious, and his body was covered with scars the result of his battles. He was only forty years of age, but followed the calling of hunter and trapper for thirty years.

LATEST NEWS BY TELEGRAPH.

OTTAWA, Jan. 6.—Nelson Mills, who was stabbed by an enraged tenant yesterday, at Hamilton, is not expected to recover. Michael McConnell, his murderer, has been sent to prison to await his trial.

The returning officer has declared Mr. Fellows elected Mayor of Ottawa for the ensuing year. The Earl of Dufferin is expected here to-morrow.

LONDON, Jan. 7.—Tribunal reports that the Porte has ordered all iron clads to be in readiness to start for the Black Sea and the Albanian Ports.

A colossal brass statue of Gratian was unveiled with appropriate ceremonies, at 2 o'clock to-day, on the College Green in front of the old Parliament House, Dublin.

The Prince of Wales has reached Bonares. Ex-Queen Isabella of Spain, was worse yesterday.—Five steamer loads of armed Turks landed at Kioek.—The report that Germany endorses the American Note relative to intervention in Cuban affairs, lacks confirmation.—A Papal Consistory—fixed for the 7th inst.—is postponed until after the 15th.—Count Androssy's project for reform in the insurrection district of France has been favorably received by Turkey and Italy.

NEW YORK, Jan. 6.—The working men of Albany, New York, en masse called on the Mayor yesterday, and asked for relief. Steps are being taken for their aid.

OTTAWA, Jan. 7.—Premier Mackenzie will address the electors of North Renfrew next week, in favor of the Ministerial candidate. Dr. Trupper will also be present in the interest of Mr. White.

MONTREAL, Jan. 7.—Dr. Foster, (Liberal) was defeated to-day, in Chamby County, by Mr. Breit, by a majority of one hundred.

HALIFAX, Jan. 7.—A man named Silver was poisoned here, last night, by eating canned peaches, and narrowly escaped death.

LONDON, Jan. 7.—The Austrian Ambassador to Turkey has been officially communicated to the Vizier, Count Androssy's scheme in the Turkish Provinces. The Grand Vizier in reply, is represented to have rejected the idea of a foreign mediator—and to have said that the Sublime Porte will give all necessary guarantees for reform.

BRANCH RAILWAY.

THE PROPOSED BRANCH TO CAPE TRVERSE—A ROUTE SUGGESTED.

Sir,—It appears that there is some probability of a railroad being constructed to connect Cape Traverse—the Island starting point of our winter ferry—with other parts of the Island. At the Bedouque meeting, on the subject, a line was proposed connecting Cape Traverse with the Main Trunk line at Free Town Station, and this would, no doubt, be the shortest line that could be built, and would suit parties travelling to or from either Charlottetown or Summerside equally well. The Crapandians who are always on the lookout for something good, have started a scheme for bringing the branch road from Cape Traverse by way of Tryon, from Cape Traverse, should follow on thence by way of DeSable, Bonshaw, and the valley of the West River, and so across the proposed bridge over the North River at Dorkendorff's, to Charlottetown direct.

Bret Harte was lecturing in Pennsylvania a short time ago. At one of his appointments he felt very much depressed. It is a peculiarity of humorists, we are told, to be unaccountably melancholy and gloomy at times. Harte was in this mood now. One of the committee went in back of the scenes to see him, and the depressed humorist welcomed him as a gleam of unusual sunshine. They shook hands—Harte earnestly and the committee man decorously.

'Mr. Harte,' he said gravely, 'you will find this an unusually healthy city.'

'Ah!' said the pleased humorist.

'Yes. The death rate is only one a day.'

At this juncture Harte took the committee-man by the arm and hurriedly asked:—

'Is he dead?'

'Dead!' ejaculated the committee-man.

'Who died?'

'Why the man for to-day,' was the grave reply.

The committee-man stared with all his might into the immovable face of the lecturer.

'I am sorry, Mr. Harte, to disturb you,' he said; 'but I could not get that information earlier. It is all right. The death-rate I spoke of was merely the average.'

How ENGLAND IS SUPPLIED WITH FOOD.—The English food supply is an increasingly interesting subject for American farmers as it is likely to be drawn more from American sources. England is increasing her grain product by higher manuring and better methods of tillage; but aside from this tendency in ordinary times is to devote more and more land to stock growing and feeding. Just now the foot and mouth disease is doing sad mischief in this branch of food production and the result will probably be, for the next year or two, a decrease in amount both of cereal and meat as food.

During the past year appears by statistics recently published, 1,068,166 animals of all kinds were imported into the United Kingdom. The animals are epitomized as follows: 119,808 oxen and bulls, 38,013 cows, 85,040 calves, 758,918 sheep and lambs, and 118,380 swine. The total quantity of dead meat imported into the United Kingdom was 968,102 cwt. as compared with 875,349 cwt. in 1875, and 828,255 cwt. in 1874.
