**W**HEREAS the Government of this Island hath devolved upon me, agreeably to a Warrant under the Royal Sign Manual, dated at Balmoral the Nineteenth day of September, 1868.

I have thought fit, by and with the advice of Her Majesty's Executive Council of this Island to issue this Proclamation, hereby requiring and commanding all officers, civil and military in this Government, to continue in the regular and due execution of the duties and powers of their respective offices.

And I do further require and command all and singular, Her Majesty's officers, ministers and loving subjects of this Island and all others whom it may concern to take due notice hereof and give their ready obedience accordingly
