About Wrecks.

OTTAWA, Jan. 1.

It is stated that the Dominion Government will ask that Canada be included in the arrangement just made between the British and French Governments as to the disposal of the proceeds of wrecks on the coasts of British and French possessions. This arrangement provides that when any ship belonging to the subjects of one of the contracting States is wrecked or stranded on the coast of the other, that the local authorities shall at once bring the matter to the knowledge of the consular agent nearest to the spot where the wreck or stranding has taken place. All operations relative to salvage of British vessels wrecked or stranded on the coast of France shall be directed by British consuls or agents, and vice versa. When French vessels are wrecked in British waters, the operations shall be superintended by the French Consul, and in his absence, or until the arrival of the consular agent the local authorities are bound to take all necessary measures for the protection of the persons who may be on board the wreck, and for the preservation of articles which may be saved. It is further stipulated that the merchandise and articles shown are not to be subject to customs duties unless intended for home consumption.

Destroyed by Fire.

BRUSSELS, Jan. 1, 5 p. m.

The royal palace at Lacken, a suburb of this city, is burning. All the royal art collection was destroyed. The fire was prevented from reaching the king's private rooms. As soon as the fire at Lacken was reported the king and queen suspended the New Year's Day reception, hastened thither and witnessed the total destruction of this magnificent palace, their usual summer residence. It is said that the fire was caused by a defective stove in the officers' quarters. The loss is immense as to money value, and as to the destruction of art treasures that cannot be replaced. Princess Clementine, daughter of the King, had a narrow escape from being burnt to death. Her governess was burned.

Ottawa News Notes.

OTTAWA, Jan. 1.

The entire debt on the Ottawa Protestant Orphans Home, amounting to \$45,000, has been paid off by Mr. Brodson, Liberal M. P. P. for this city. Colonel White, ex-Conservative M. P. P. for Sussex, has been elected Mayor of Windsor. He ran on the Annexationist ticket. The New Year's levee held by the Governor-General to-day was largely attended.

Steamers Collide.

LONDON, Jan. 1.

While proceeding up the Mersey to Liverpool this morning the Inmars, steamer City of Paris, from New York, collided with an outward steamer. The City of Paris lost her bowsprit and the other steamer one of her masts. The passengers on the City of Paris were greatly alarmed, but nobody was hurt. A heavy fog prevailed.

Making Ready.

ST. JOHN, Jan. 1.

Politicians are already hard at work in election preparations. In addition to Premier Blair's published card to the electors of the Province, Provincial Secretary McLellan has issued a card to the electors of the city and County of St. John, in which he deals at length with the acts of the Government and its policy, touching on St. John and harbor improvements.

The Women Speak Out.

At a regular meeting of Union Lodge, I. O. G. T., Marshfield, 31st Dec., the following resolutions were presented by the sisters, and carried unanimously:

Whereas, Rumors in all places, men or women, have been the means of alienating the affections and ruining the characters of our loved and respected husbands and brothers changing them from being the best-hearted and noblest of men, to objects only of pity and contempt, and
Whereas, A rumseller in the city, unworthy the name of woman, has been lawfully imprisoned for the breach of an enactment supported by public opinion, and necessary to the preservation of the happiness of our homes, and the representation of our country, and
Whereas The breach of said enactment consisted in selling a poisonous beverage which demoralizes all classes, from the City Councilors, as is evident, down to the poor man Godfrey, whose untimely death cries to heaven for vengeance, and
Whereas, The King of all the earth declares "Woe unto them that decree unrighteous decrees," "Woe unto them that call evil good, and good evil, and "woe unto him that giveth his neighbor drink."
Therefore resolved, That in our opinion, and we believe the opinion of all the women of P. E. Island, that the City Council, sympathizing by their resolution with one who has demanded her sex by the lawless sale of soul-destroying beverages, have thereby insulted womanhood, defied the law, made a mock of the people they are supposed to represent, labelled the religious teachers of the land, and consequently are unfitted for the office they hold; and having justly forfeited their position, should either be deposed therefrom to make room for men whose characters are not debased by drink, and with sufficient moral courage to boldly stand for the right, or have a competent instructor placed over them to teach them their duties.
We would also call on every woman of our Island to rise in holy indignation and demand that the sympathy of our representatives be righteously bestowed on the true sufferers by meeting on the full and just penalty of the law upon those who defy God and bring a curse upon our homes by the illegal traffic.
