The Northern Light left Pictou for Georgetown at 5:45 this morning, and arrived in Georgetown at 1 o'clock. She leaves again for Pictou at daylight to-morrow morning.

COMMERCIAL depression in Stockholm has reached a crisis. The number of failures is steadily increasing. The gravity of the situation has not been equalled since the panic of 1857.

JOHN J. TRAINOR and Phillip Curley were examined before the Stipendiary Magistrate this forenoon for violating the Scott Act. The charge against Trainor was not proven and his case was dismissed, and Curley's was held over until Thursday next.

THE ladies of the P. E. I. Hospital Bazaar Committee tender their thanks to the young gentlemen for their tasteful and commodious arrangement of the Market Hall and other assistance rendered by them, materially contributing to make the bazaar a grand success.

WE were shown this forenoon the exhibit of tobacco prepared for the Colonial and Indian Exhibition, by Mr. T. B. Riley, Water Street. The exhibit consists of five cases of the best quality of smoking and chewing tobaccos, manufactured by Mr. Riley. The tobacco is neatly packed in hand-some boxes, each one of which has the name of the manufacturer and other information conspicuously printed thereon.

A MEETING of Presbytery was held in Zion Church to-day. The business chiefly consisted in disposing of calls from different congregations. Calls have been extended from the Church at Summerside to Rev. John Murray, at present in Sydney, but who was formerly stationed at New London; and from Mount Stewart, to Rev. James McLellan; and from East St. Peter's to Rev. Mr. McKENZIE. Mr. McKENZIE has accepted the call and will be inducted in a fortnight.

THE facts have been learned of a number of disasters in the South Pacific Islands. The scho. Navigator, which left San Francisco several months ago for a cruise among the Samoan Islands, was struck by a heavy sea, capsized and became a total loss while bound from Apia to another Samoan port. The crew and seven passengers were saved. The scho. Darmittia, cruising among the Sandwich Islands, was discovered bottom up in the Hawaiian Channel. She had on board a crew of six men and one passenger, all of whom it is believed are lost. The vessel was valued at 6,500. On Jan. 28th, the steamer Planter, bound from Kanai to Nihau, Sandwich Islands, struck on a rock near the latter place and was completely wrecked. No lives were lost. She was valued at \$75,000 and insured.

WE understand that the members of the Union Dramatic Club of this city intend giving a performance in Summerside on St. Patrick's Night. The entertainment will be under the auspices of St. Vincent de Paul Society, of Summerside, and the programme includes the popular Irish drama, "More Sinned Against than Sinning," and the laughable farce, "Should This Meet the Eye." Both drama and farce were twice performed in the Academy of Music last winter, and on each occasion the Academy was crowded and the performance a grand success. The scenery used in the drama was painted expressly for the Club, and is very handsome and appropriate. We assure our Summerside friends that a rich treat is in store for them, and bespeak for the Club a crowded house.

AFTER their trial in the Stipendiary Magistrate's Court yesterday forenoon for the larceny of Dr. Bagnall's coat, the two Brown boys were removed to the Police Station and placed in a cell. After being in the cell about two hours they complained of the cold and asked permission of Policeman Costello, who was the only officer in the station at the time, to be allowed to go out to the stove and warm themselves. This officer at first refused to do so, but at length he took pity upon the two boys and let them out to the stove. Here they warmed themselves thoroughly, all the while glancing about for some avenue of escape. John, the elder, espied the back door open and putting on a grand burst of speed started in that direction. The fence enclosing the yard was speedily climbed, and the noble Buckley was numbered with the lost. As there was no officer in the Station but Costello at the time of the escape, he had to put Andy and another prisoner in their cells before he could start in pursuit. Brown's escape was easily effected. Costello, when spoken to on the subject, shakes his head and sagely remarks that he "will never let another prisoner out of a cell to warm himself even if he has a wooden leg!"

DOMINION PARLIAMENT HOUSE OF COMMONS.

NEW BILLS.

OTTAWA, March 1. The House met at 3 15 p. m., after presenting petitions, bills were introduced as follows: Act to declare it a misdemeanor to leave unguarded and exposed holes cut in the ice on navigable or frequented waters. A bill to further amend the law of evidence in criminal cases. A bill to further amend the Consolidation Railway Act of 1879.

DEBT OF CANADA. Mr. McLellan stated that the gross debt of the Dominion at the present date is \$38,314,532, and that the assets are \$72,731,837; leaving a net debt of \$208,522,695.

GOOD NEWS FOR LOBSTER PACKERS' Foster said it was not the intention of the Government to impose prohibitory regulations on the Lobster fishery for canning purposes, around Prince Edward Island.

C. P. R. Depot Burned. WINNIPEG, March 1. A few minutes after two o'clock this morning fire broke out in the baggage room of the Canada Pacific Railway depot, and half an hour later the fire was beyond control, and the handsome structure was destroyed. The building was valued at \$150,000, and its furnishings at \$20,000. Insurance only \$40,000.

Stormy Weather. ST. JOHN, March 1. The weather has been stormy for three days, and many disasters are reported along New England's coast. The steamship State of Maine, which arrived last night, had a very rough passage. Trains are blockaded in all directions. The northern division of the Intercolonial has been blockaded since Saturday.

Horrible Murder. ST. CATHERINE'S, Ont., March 1. A horrible murder was committed here this evening. Walter Tyrrell, colored, murdered his brother's wife by beating her with a club. Tyrrell had shown signs of insanity for some time. He is now under arrest.

Lord Randolph Eulogistic. LONDON, March 1. Lord Randolph Churchill has written a letter to the Grand Master of Orangemen, in Belfast, eulogizing last Monday's demonstration, in the writer's honor, against Home Rule.

Moncton Happy. MONCTON, N. B., March 1. The new post office and custom house building was occupied to-day for the first time.

In May last the Duke of Marlborough made an offer to the National Gallery of eleven of the best pictures in the collection at Blenheim palace for £367,000. This offer was made subject to the permission of the Court of Chancery. This has now been obtained, and an auction sale of the Blenheim art collection, with the exception of some family portraits, is sanctioned to take place next June. The Times, commenting on the Duke's offer at the time, admitted that the sum demanded was high, but hoped that the calamity of the pictures being lost to the National Gallery would be averted. "The pictures," it said, "are of unique historical interest and should be acquired for the nation." The collection contains some of the masterpieces of Titian and Rubens, and the sale will complete the despoiling of the earthly paradise which was presented to the victor of Blenheim by a grateful nation.
