The Reserved Bill.

We are informed by telegram that the Patriot that the reserved bill has been referred to the Lieutenant Governor. It is possible that this news may be true, even though its source is so questionable. The remission of the bill was anticipated. The bill is, nevertheless, dead. Its reservation was tantamount to the refusal of the assent of the Crown. We have to assume that the Leader of the Government killed it,—for he has not resigned the position of responsible adviser to the Lieutenant Governor, by whose act the deed was done. Compunctious may, indeed, have seized hold upon him. Perhaps he regretted the disgraceful scenes, behind closed doors, in which the bill was enacted. Perhaps the very crookedness of the gerrymander gave him a fright when he saw it portrayed in THE EXAMINER. Or perhaps his courage failed at the last moment to carry him to the sticking point of disfranchising those of his fellow-citizens who hold positions in the civil service and railway service of Canada. Or it may be that he feared to rob honest farmers of their political influence by the enactment of the mortgage vote. We can easily imagine that a man of stronger nerve and determination than the Leader of the Government might fail, at the supreme moment, to carry out atrocious schemes involving high political crimes. "Conscience makes cowards of us all." We are loath to believe that the "still small voice" has lost all its influence over the Leader of the Government. But for the statements made by Mr. L. H. Davies in Parliament, the public would never have doubted that the Leader of the Government had repented, in time, of the evil that he contemplated when he forced the bill through the Legislature, and that he authorized the Lieutenant Governor to reserve it. If he did not so authorize the representative of the Crown, the people will have to thank the Lieutenant Governor for the manly stand which was made against the enormities of the reserved bill. More than that, they must beware of another and perhaps a successful attempt to enact its villainous provisions. Eternal vigilance is the price of liberty. If the people of Prince Edward Island desire to maintain freedom and fair play in elections, they ought to give such expression to that desire that their representatives of both parties may know exactly how they ought to vote when the Bill shall be again submitted to the legislature.

Notes and Comments.

The Earl of Winchester, speaking at York, in January, on the proposed National Agricultural Union, said he believed in universal Free Trade, if they could get it—(cheers)—and as to the means of getting it, he believed the eventual solution towards which people in this country ought to work was a great Imperial Federation. The Montreal Gazette says:—"The grant to the Trappists by the Quebec Legislature of 6,000 acres of land in the Lake St. John district is being quoted in some Western papers as evidence of the rule of the Monk in Quebec politics. Usually public grants to religious corporations are not commendable. In this case, however, the Monks in question are going into the forest to show how it can be reclaimed. If they re-inhabit the habitant with the old pioneering spirit, and help to make glad the waste places of the north country, their work will pay for their land, even if another 0 was added to the total of the acres."

The revenue of Canada for the month of January amounted to \$3,213,576, making for the seven months of the current fiscal year a total revenue of \$21,772,000, an increase in revenue for the month of \$249,504, and for the seven months an increase of \$806,545. The expenditure for the seven months on account of consolidated fund amounted to \$19,180,893, a decrease of \$678,432 compared with the expenditure for the seven months of the previous fiscal year. Thus, taking into consideration the increase in revenue and the decrease in expenditure, the consolidated fund statement shows a betterment of \$1,485,977 for the seven months of the current fiscal year. The expenditure on capital account during this period was \$2,276,364, compared with a capital account expenditure of \$2,104,419 during the first seven months of the fiscal year 1892.

Only one nation in the world, France, has more gold than the United States. The United Kingdom has \$100,000,000 and Germany \$50,000,000 less. The New York Press says that it is nonsense to talk of a scarcity of gold in the United States. It is nevertheless true, as Henry Clews remarks, that the net stock of gold in and out of the Treasury fell from \$121,000,000 on the 1st of January to \$108,200,000 on the 1st of February. A further loss of \$10,000,000—which might but too easily occur in the event of continued exports of specie and from the straightened revenue resources of the Treasury—would send the Treasury gold reserve below the 100 million requirements. In view of the scramble for the great European banks for gold, there can be no assurance that such an inroad on the gold stock of the States might not arise. The States are thus verging very uncomfortably close upon a condition in which the Treasury might find it necessary to sell bonds; and that is a matter not to be ignored.

The Home Rule Bill.

THE HOME RULE BILL is now before the Parliament of Great Britain and Ireland. According to the meagre telegraphic reports which have been received, it provides an Irish Legislature of two branches. There is to be a Legislative Council and there is to be a House of Assembly. Both are to be elective, the first for a term of eight years, the last for a term of four years. It does not appear that half the Legislative Councilors are to be elected at one time and half at another. But in other respects the constitution of the proposed Legislature seems, in its main features, to be very much like that of this Province. One of the extraordinary provisions is that, in case of a deadlock, the two assemblies shall be required to come together and the fate of the measure involved, be decided by the joint vote of both. Certain incapacities are, of course, imposed upon this Legislature. These concern the crown or regency, the maintenance of peace, the declaration of war, defence, treaties and negotiations with foreign nations, titles, treason, aliens, and coinage. There is to be one system of legislation in respect to trade for all three kingdoms, and this system is to comprehend the levy of customs and excise duties, and the management of post offices and telegraphs. It thus appears that, in respect to all essential points of international importance, the supreme authority of the Imperial Parliament is conserved.

Concerning the important question of the control of the constabulary—about which some of Mr. Gladstone's English supporters were protesting—the bill ingeniously proposes a gradual relinquishment of the power heretofore held by England. Ultimately, the Irish constabulary is to be replaced by policemen under Irish authority. In the meantime, during the period of transition, the control of the constabulary is to be vested in the Viceroy. The appointment of the Viceroy is to be for a period of six years. Every power of the Crown shall devolve upon him while he remains in office, and the office is to be entirely deprived of party character. Judges are to be appointed as at present, and are not to be removed except for cause. Two Exchequer judges are to be appointed under the Great Seal to control the financial business of Ireland. Ireland is to continue to be represented in the British Parliament.

Mr. Gladstone contends that the bill secures the autonomy of Ireland, as well as perfect freedom of religion and person to its people. The legislation and administration of Ireland is, according to Mr. Gladstone, to be distinct from and independent of that of England and Scotland upon the following conditions: First—That the Irish do nothing inconsistent with imperial unity, as far as the convictions and intentions of the government are concerned. Secondly—That the equality of the kingdoms be borne in mind. Thirdly—That equitable reparation be made to the imperial charges. Fourthly—That every practicable provision for the protection of the minority be adopted.

Mr. Gladstone, concluding his speech in explanation of the measure, said:—"The plans of government are inspired by a desire to redeem the character of the country and its political genius from the old and inveterate dishonour, and to magnify the strength, greatness, glory and union of the empire. Either this plan or something closely resembling it must shortly become a law. The alternative would be a demand for a repeal of the union. Ireland no longer asks severance from the imperial power, and that being so, the sooner the deed is signed and sealed the better. Certainly I could be no party to the bequeathing to my country the continuance of this heritage of discord which has been handed down from generation to generation with hardly a momentary interruption, and let me entreat the house even if it were with my latest breath to let the dead past bury its dead, and to cherish, love and sustain one another through all the vicissitudes of human affairs in the times to come."

OTTAWA NOTES

Sedgewick Judge of the Supreme Court.

OTTAWA, Feb. 16. The one topic around the corridors yesterday was the Budget Speech and the Tariff changes. With the exception of few ultra-grits, both sides of the House pronounce Mr. Foster's speech one of his best efforts. But when it comes to his treatment of the tariff, there is a great divergence of opinion. Robert Sedgewick, Deputy Minister of Justice, was cited and accepted the appointment of Judge of the Supreme Court of Canada yesterday. He will probably be appointed to-day.

Mystery of the Sea.

LONDON, Feb. 16. The captain of the Grace Darling reports that he sighted a bright light yesterday morning and heard the screams of women and the shouts of men. Then the light disappeared. He searched four hours but failed to see any sign of a vessel or of human life. He believes that the light was a sinking steamship.

Ten Persons Cremated.

UDA PESTH, Feb. 16. At a carnival dance on Monday, in the Deutsch Pereg, a child playing in the cellar of the building ignited a cask of petroleum. An explosion followed, which tore up the dance floor. Ten persons fell into the cellar and were burned to death. Many others were injured.

President Hearst.

A CHARLOTTETOWN MAN AGAIN SUCCESSFUL IN THE WEST.

Mr. John Hearst, who was born and brought up on a farm at North River, now stands at the head of one of the most successful (if not the most successful) labor organizations in our land, the Bricklayers' and Masons' International Union. In Baltimore, Maryland, on Jan. 23, 1893, he was elected for the fourth year to the presidency of the above honorable body of breadwinners. At the annual convention this year, in Baltimore, he called to order and presided over the representatives of forty thousand men. Mr. Hearst is a well-known and respected citizen of Denver, Col., where he has resided for many years. He is at present treasurer of the local union, No. 1, in which capacity he has faithfully served for six years. The election of Mr. Hearst is regarded by his fellow-workmen, not only as a well-deserved personal compliment, but as a recognition of the well-directed efforts of organized labor in Denver.

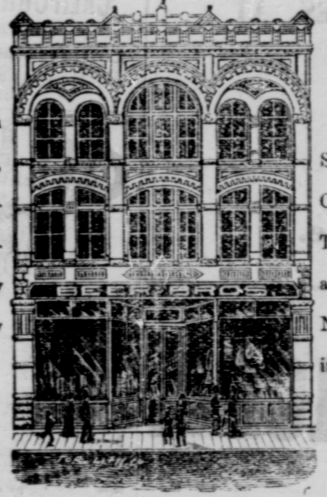
