WAR NEWS.

[By Telegraph to Reading Room and Daily Examiner.]

LONDON, Feb. 22.

Lord Northcote, in the Commons this afternoon, said the result of the negotiations with Russia, is with this understanding—that Russia is not to occupy any portion of the Peninsula of Gallipoli or Bontair Lines, or the Asiatic side of the Dardanelles, England undertaking not to land any troops at Gallipoli or on the Asiatic side of the Dardanelles.

The "Times" Rome correspondent says: "In the Antonelli Will Case the Court has decided that the plaintiff—Countess Lambertini, deceased Cardinal's alleged daughter—should be permitted to introduce evidence in support of her case, and condemned the defendant—Count Antonelli—to pay the costs of this first stage of proceedings."

The Manchester "Guardian" has a Pera despatch, saying Suleiman Pasha has been placed under arrest, and will be court-martialed.

In the House of Lords, this afternoon, Lord Derby stated that the difficulty as to the place of the meeting of the Conference has been removed, and Baden-Baden has been chosen.

It was proposed that the meeting take place the first week in March, but the Government objected to the shortness of the time allowed.

England will not deviate from the usual course of sending an ambassador.

The Times' St. Petersburg dispatch says: Among those who expected Germany to give Russia active diplomatic support, Prince Bismarck's speech caused disappointment; in official circles, however, it has produced no impression whatever, being precisely what was anticipated. Several days ago, indeed, its general scope and tenor were confidently predicted by people whose prophetic inspiration was probably derived from an official source.

The Paris correspondent of the Times says: The chief thing remarked here is Prince Bismarck's desire to absolve Germany from all responsibility, and to maintain a just equilibrium between Russian and Austria.

After this speech people are more than ever discussing the policy of England.

Advice from officers operating against the Kafir conveys state there is a strong impression that the backbone of the insurrection is broken. There may be a sort of guerrilla warfare for some time; but it is not believed there will be another regular engagement.

OUR OTTAWA DESPATCH.

(Special Despatch to Daily Examiner.)

OTTAWA, Feb. 21, 1878.

Young, of Waterloo, said that owing to the present Dominion duty on malt, the United States threatened to place prohibitory duty on it. This would prevent Canadians benefitting of United States market.

Cartwright said, to avoid this the Government proposed to reduce the duty.

Decosmos made a charge that McKenzie had broken faith with British Columbia in the matter of the Esquimaux graving dock. He occupied most of the afternoon in probing such charges.

Cartwright will deliver the budget speech to-morrow.

OTTAWA, Feb. 22.

Decosmos, in moving for the Pacific Railway correspondence, said that the Government had violated the bargain respecting the grant of two hundred and fifty thousand dollars for the graving dock. He read letters from Tilley and Langevin and telegrams from McKenzie, showing the nature of the bargain, and claimed it had been violated by the present Government.

Mr. Bunster attacked the Government on the same point, and urged the buying of Alaska.

Mr. Blain moved that an address be presented to Her Majesty praying an amendment of the British North America Act, giving the Canadian Parliament power to fix, from time to time, the number of the Commons and Senate; he said on the present basis we would have 2,291 members when our population equalled that of the United States. He believed the present number large enough, but the smaller would be better. He argued that the bargain with the smaller Provinces respecting representation was unconstitutional and could not be carried out. Representation by population was the principal of the British North America Act, yet British Columbia was entitled to but one member.

Mr. Masson said the people had not asked for a change. He believed in the English principle of leaving well enough alone, and would meddle with the Constitution only when necessary.

The Premier said the power of fixing representation should be in the Canadian Parliament. No fear that in our time our number will increase very considerably—not more than ten and twelve with each census. He advised the withdrawal of the motion.

Mr. Mitchell explained the principle of representation at the Union, showing that the members of the House did not necessarily increase with increase of population, as the representation of this Province was fixed and that of the others was regulated thereby. The country was prospering under its Constitution, notwithstanding hard times and bad government, and changes should not be made. Why excite feelings

by such obstructions? The motion was withdrawn.

OTTAWA, Feb. 22.

O'Donovan Rossa, the liberated Fenian, is announced to lecture in Toronto. Telegrams anticipate disturbance on the occasion.

Anticipations concerning Mr. Cartwright's budget speech are rife to-night. Except the reduction of duties on malt announced to-day, nothing has transpired regarding the tariff.

The Ottawa Liberals held a mass meeting to-morrow night.

Mr. Demond introduced the Dominion Alliance Deputation to-day.

Messrs. Stewart and McLaren briefly stated the object of the deputation, which was in effect to obtain the passage of a permissive bill, which would, as passed from the Dominion Parliament, obviate the difficulties which now interfered with the Dominion Act, which, being a Municipal or Provincial legislation, had not worked effectually. It was represented that any delay in passing such a bill was undesirable.

Mr. McKenzie, while he assured the gentlemen that it was the desire of the Government to do all in their power to promote the temperance cause, said he could not promise anything further than that, during the present session, such legislation would ensue as would meet with the approbation of the temperance people.

The Rev. lecturer predicted a brilliant future for the Dominion—instancing many of its great natural advantages, and the wide fields now being opened up for the development of native talent. A vote of thanks was unanimously tendered to the lecturer, which he appropriately acknowledged.

THE REV. DR. O'BRIEN delivered a splendid lecture on "Pagan and Christian Rome" in Georgetown, on Thursday night. The Advertiser says: "The Town Hall was crowded with people last night to hear the Rev. Dr. O'Brien deliver a lecture on 'Pagan and Christian Rome.' After a few introductory remarks by the Chairman, the lecturer came forward and was greeted with a round of applause. Having entered upon his subject, the most praiseworthy attention—we might say stillness—permeated the whole building to the close. About two hundred were present, among whom we recognized the most influential portion of the townspeople of all denominations, including the clergy, besides a respectable number of ladies and gentlemen from Cardigan and Montague Bridges, and some from Grand River. It is a pleasure to witness the reciprocal feeling and social harmony which form such a prominent feature in the temperance movement. Dr. O'Brien ably sustained the distinction he has won as a brilliant speaker and charming lecturer, and the graceful and comprehensive oral discourse which he treated his audience to last night was fully as eloquent as any of his former efforts."

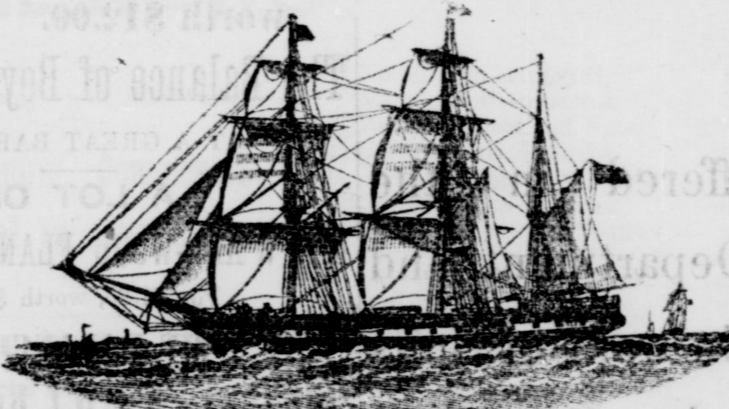
