BY virtue of a writ of Statute Execution, to me directed, issued out of Her Majesty's Supreme Court of Judicature, at the suit of James Arthur, William Arthur, William Wingate and William Ogalvie, against Henry Haszard, I have taken and seized as the property of the said Henry Haszard, All the right, title and freehold interest of the said Henry Haszard, in and to all and singular the following tracts, pieces and parcels of Land town lots or parts of town lots, and pasture lots and parts of pasture lots, with the appurtenances, that is to say: 1st.
