FREE OR TAXED RAW MATERIALS.

One thing that Mr. Laurier has specifically said that he will do in respect to the tariff is that he will "tax raw materials." The Government have understood Mr. Laurier's statement and have promptly and emphatically accepted the issue raised by the Opposition in respect to this point. They have decided to accept drawbacks to the extent of ninety per cent. of all duties paid upon the raw materials used by Canadian manufacturers in goods exported. That is to say, they intend to practically permit the importation of raw materials actually used in manufacturing free of duty, and thus add materially to the protection afforded our manufacturing industries. It is gratifying to know that there is one feature of the tariff about which the issue between the two parties is clearly and definitely formulated and understood. Free Raw Materials or Taxed Raw Materials—which? That is one of the questions to be considered by the voters.

It is pleasing to note that those who read the Guardian, and are influenced by what it says, will be constrained to vote for the Government candidates. The Guardian refers to the decision of the Government to remove the burden of taxes on raw materials used in manufacturing, and says: "It may not be a Massey-Harris victory, but it is a victory for the Canadian people and a distinct defeat for the principle of trade restriction."

There is, upon this point, clearly an endorsement of the protective principle maintained by the Government. The Massey-Harris Company found that there was greater protection for them under the Senate tariff of the United States than under the Canadian tariff, and they consequently threatened to leave this country and go to the Great Republic. But the Canadian Government have now decided to put the Massey-Harris Company and other manufacturers in even a better position, as to the tariff, than they could occupy in the States; and the Guardian applauds its action. It may be that when the Leader of the Opposition shall have further developed his policy and the National Policy shall be better understood by our contemporary, the Guardian will throw all its weight and influence in favor of the Government. However this may be, we feel sure that intelligent men and women will do so.

They can justly claim the words of the poet:—'A monarch here crossed three long ago on a throne of rock.'"

Paralyzed by Earthquakes. The People of Mexico Get Terribly Excited and Pray for Remission of their Sins.

There has been a great scare in Mexico over a shock of earthquake. Thirteen people were killed. In the theatres impassioned prayers were made for forgiveness and confession of errors. Plays were generally abandoned and the audience remained in their seats kneeling in prayer. Traffic was completely abandoned at the first pronouncement. Drivers deserted the street cars, and coachmen their hacks, to kneel in prayer with the throngs seeking supplications. In the palaces and humble homes nothing but prayer was to be heard. The threatened destruction was made more solemn by the ringing of bells in every church tower. In Belen and other prisons many desperate criminals are confined. As the walls swayed and earth cracked, threatening to entomb the imprisoned inmates, the convicts without exception, fell upon their knees or grovelled on the floors of the cells with loud voices crying out prayers and supplications. Many supposing the end had come, shouted out confessions of past crimes. This may be of use to officers of law in unravelling a number of mysterious crimes in Mexico. The supply water pipes were broken and the greater part of the city is in danger of a water famine unless connection is soon restored, which will take some time.

The British Columbia sealing fleet this year took 27,272 seals, compared with 70,000 in 1893, though fewer schooners went out than for some years.

SCHOOL BOARD MEETING.

At the regular meeting of the City School Board last evening several complaints were heard from teachers relative to the scarcity of books among a certain per centage of their pupils, and it was agreed that citizens having second-hand books at their disposal be asked to kindly hand them to the principal or to the Secretary, who would distribute them among those scholars requiring them. Messrs. George Carter & Co. agents for the C. P. R., have kindly supplied "Round the World" Maps to each department of the city schools. In this connection, the secretary reported that he had also obtained guides and maps for each department from the agents of the Grand Trunk and Intercolonial Railways. These will be a great aid in the teaching of geography. Miss Lena Macdonald who had previously taught as a substitute for nine months in the Prince Street School was appointed to fill the vacancy caused by the resignation of Miss Eliza Macneil.

DEATH OF THE CZAR.

The Nihilists Will Begin an Agitation for an Open Rebellion.

Advices from Berlin state that an imperial decree has been published in the army orders commanding the observance of a period of two weeks' mourning in the army. The decree says: "The army will thus testify that it shares the deep sorrow which is felt for my true friend and sincere protector of the peace in Europe." A similar decree is published in the navy orders and the warships were ordered to display mourning flags for one day and to fire 21 guns on the day of the Czar's funeral.

The Russian population of the east side of New York city, which is largely composed of Hebrews and a few nihilist refugees, are rejoicing over the death of Czar Alexander III. All Hebrew papers issued special editions on Friday last, in which the event was referred to as a blessing and a brighter era for Russia, and particularly for the Jews in Russia, was predicted. It has been decided to hold a public meeting in rejoicing over the Czar's death. A representative of the Associated Press had an interview with Stepanik, the Russian Nihilist, a few days ago. He utterly repudiated the Nihilist manifesto recently published, and called exclusively to the Associated Press on Wednesday last. Speaking of the present situation, Stepanik said: "The future cannot be foretold, but I am firmly persuaded that the new czar will direct the country in a better way than his late father. Mind, I have no illusions regarding the new czar. He may not be superior to his father. In any case, he cannot be worse. His father's only good point was that he was a foreigner, and he has done a kind thing in dying, so we won't be severe on him. His death is the opportune moment for a move in a liberal direction and for constitutional changes, for which the country is ripe. We nihilists have decided upon an immediate, fresh and widespread propaganda. This may be revolutionary, but not in the sense of dynamite. The reign of bombs and dynamite is ended. Although a few fools may advocate it, all thinking and responsible nihilists repudiate it. We want a powerful, but legal agitation of an open revolution, which in my opinion would be more effective than the propaganda. We intend to agitate society by the pressure of public opinion and not by explosives. A move in the right direction has just been made by the Russian government official of liberal views who had drafted a scheme for a democratic constitution, including the establishment of elective, local and provincial parliaments. Stepanik concluded by saying: "I wish to say to my friends in America, now that Russia is entering a new phase, that Americans ought to think of the outrage against liberty that has been committed by concluding an extradition treaty with Russia. It is unworthy of a great nation like the United States for its government to support such a government as that of Russia, and I trust that the earnest efforts of George Kennan and other friends of Russia will lead to its repeal."
