Khrushchev Claims U.S. Missed Moon

MOSCOW (AP) — Premier Khrushchev has claimed the United States rockets have never hit the moon.

The Soviet premier did not mention by name Ranger 4 which the U.S. launched at the far side of the moon April 26.

But he said: "The Americans have tried several times to hit the moon with their rockets. They have proclaimed for all the world to hear that they had launched rockets to the moon, but they missed every time."

Khrushchev made the statement at a Kremlin meeting of transport workers in honor of the Soviet Union's national railway day.

The Ranger 4, a complex spacecraft, was launched from a site in California two weeks ago. It proved a disappointment because a mechanical failure made it impossible to conduct sophisticated moon measuring experiments.

American scientists hailed the feat as a major step in space research. They said that the fact that Ranger 4 hit its target, without guidance along the way, indicates future spacecraft could be shot moonward with accuracy.

Labor Policy Is Outlined In Social Credit Booklet

OTTAWA (CP) — The Social Credit party says that, if elected, it will set up a special tribunal, whose decision will be final, to arbitrate labor disputes which might harm the national economy or security.

The proposal was contained in a booklet made public outlining the party's labor platform in the June 18 general election.

The 12-page booklet says a Social Credit government would set up a labor-management advisory council. Fact-finding, conciliation and mediation facilities would be provided to solve any disputes which fall under federal jurisdiction.

"Disputes which might harm the national economy or security, or which create an emergency threatening the life, well-being or safety of any segment of the Canadian public, will be referred to a special tribunal whose decisions will be final, but only when normal procedures fail."

Social Credit recognized the importance of "properly organized and conducted unions in providing security for the working man, but rejected union control from outside Canada and the system of the 'company check-off'."

About two-thirds of Canadian union members, the booklet says, have no effective voice in the management of their own affairs because they

formed only a small, minority section of the "huge and dominating U.S. counterpart."
