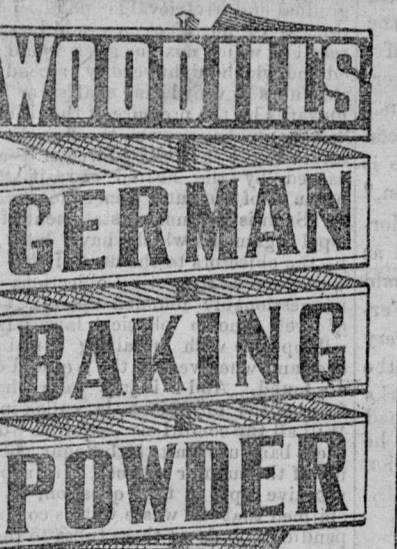

## Y. M. C. A.

The adjourned annual meeting of the Charlottetown Young Men's Christian Association, on Monday evening last, was fairly well attended. The chair was occupied by the President, John T. Mellish, Esq. Following is a brief abstract of his report for the year 1889:—

The operations of the Association were carried on during the year for the most part in the usual manner. An excellent musical concert was given last winter, at which a number of ladies and gentlemen assisted in a praiseworthy manner. A new feature was a course, or rather two courses, of lectures on the evidences of Christianity, given in the Hall last summer by Professor Braden, of the United States. The lecturer is a specialist, and much good resulted from his lectures. The Sunday afternoon meetings were suspended as usual for some time in the warm weather. A large quantity of religious tracts was distributed on board ships in port during the summer months. Thanks are due to several of the city clergymen for assistance in conducting these meetings and the weekly Bible Class. The attendance at the reading room during the year was large, the number of readers being on the increase. The receipts from the sale of tickets during the year, amounted to \$680. The repairs and alterations made in the reading room early last winter have rendered the apartment most attractive and comfortable. We have reason to be proud of the fact that we have the best-equipped reading room in the Maritime Provinces, the supply of reading matter, both as regards quality and quantity, being first-class in every respect. The yearly cost of this reading matter is over \$200, and access to it is within the reach of anyone on payment of the very small sum of \$2 a year, or less in some cases. The late Professor T. A. Lepage bequeathed a valuable gift to the reading room during the year—the Encyclopedia Britannica in fifteen volumes. As it has been decided no volume of this work shall be removed from the reading room, it will serve as a permanent reminder of a member whose death was so deeply lamented, and will prove of valuable aid to all classes of readers. The room used as a gymnasium is still open, but at present there is no instructor. Mr. R. M. Barratt has been at work the greater part of the year as permanent Secretary, Mr. Leigh having resigned, and is instant in season and out of season in seeking to promote the welfare of the Association. It is doubtless well known that the institution is not self-supporting, in other words the receipts from the sale of tickets, rent of hall, offices, &c., are not sufficiently large to defray the necessary expenses. Every year persons benevolently disposed generously make up the deficiency. Within the past month over \$300 has been cheerfully given in this manner. This is a most encouraging fact. The Associations in other cities are supported in a similar manner, many persons contributing very large sums every year to this worthy object. The President strongly recommended the publication of an annual report, with a view to affording the public fuller information as to the condition, work and objects of the Association. H. J. Cundall, Esq., read the financial statement, which showed a balance on hand of about \$60.

## Ebenezer School Examination, and Other Notes.

The semi-annual examination of Ebenezer School, New Glasgow Road, took place on the 30th ult. There were present Rev. James McLennan and Mrs. McLennan, Rev. Mr. Kirby, Mr. George Arthur, of Dalhousie College, and some thirty local visitors, many of whom were ladies. The pupils were examined thoroughly in the various branches taught in the schools, and their proficiency and good behavior were subjects of general remark by the visitors.

At the close of the examination a short entertainment was given by the pupils, which was very interesting. Up to this point the exercises were probably more interesting to the visitors than to the pupils, but now the conditions were reversed. Pleasant expectation, which gives so much zest to juvenile life, was plainly to be seen upon fifty happy faces, as it was announced that the presents from the Christmas Tree would now be distributed. In a few minutes kind hands had stripped the tree of its holiday attire, and the pupils were happy in the possession of their gifts, not one pupil present being overlooked. The rev. gentlemen then addressed the assemblage in complimentary terms, and after singing the National Anthem the meeting dispersed.

It had been arranged to hold the above exercises on the 23rd ult., but owing to the sudden death of one of the pupils they were postponed for a week. The scholar whose death was so greatly regretted by his parents, teacher, fellow-pupils and many others, was Master Cyrus J. Boundy, son of Mr. John Boundy, one of the Trustees of the School. He was a good boy and a bright scholar. Although only eleven years old, he was well advanced in all the subjects of Grade V., and was a general favorite with all his schoolmates on account of his unselfish nature and sunny temperament. His career on earth was very brief; but who can say that his death may not have a greater influence for good, than even a long life would have. Dickens has somewhere said, in effect, "that nothing good and beautiful ever dies and is forgotten. The child of an hour, dying in its mother's arms, lives again in the lives of those who loved it here; and that if every holy desire, and noble deed could be traced to its source, how many would be found to have had their growth in dusky graves." The parents have the sympathy of their many friends in their bereavement.

Northern Light Division is in a prosperous condition, and has lately been much strengthened by the addition of several new members, among whom may be mentioned the Rev. James McLennan and Mrs. McLennan. This gentleman and his amiable partner are always to the front in every good word and work; and have, since their arrival here, won the respect and esteem of all who have had the pleasure of their acquaintance.

The forthcoming election does not seem to cause much commotion in this locality. Probably the present tranquility is only the deceitful calm which usually precedes a storm. No doubt in the seclusion of their homes, the politicians are manufacturing ammunition for the coming campaign.  
The post office established here last spring is proving a great boon to the people. The amount of business done is surprising for so small a place. Mr. Alex. McCallum, the courteous and obliging postmaster, gives entire satisfaction.

CHEESE.—The cheese trade between America and England is a very large one, says the Pall Mall Gazette. Last year 138,000 hundredweight from the United States and 688,000 hundredweight from Canada was imported. This year the figures promise to be as large.

FIRE AT CARDIGAN BRIDGE.—The building occupied by Mr. William Minto, at Cardigan Bridge, as a shop and warehouse was destroyed by fire early on Tuesday morning, the 14th inst. When the alarm was given the fire had complete possession of the building, and no efforts could be used that would save the stock in it. The wind was blowing a gale from the north-west at the time, but fortunately no other buildings caught, although a warehouse owned by Mr. George F. Owen was saved with difficulty. No cause can be given for the outbreak of this fire, as everything was all right at 10 o'clock on Monday night. The building was insured for \$400 in the Glasgow and London Company, and the stock therein for \$2,000 in the Western and \$1,500 in the North British and Mercantile.
