HENRY HASZARD.

BY virtue of a Writ of Statute Execution, to me directed, issued out of Her Majesty's Supreme Court of Judicature, at the suit of James Arthur, William Arthur, William Wingate and William Ogalvie, against Henry Haszard, I have taken and seized as the property of the said Henry Haszard.
