# Canadian Club To Hear 'Space Age Scientist'

The Space Age will be brought into sharper focus for members of the Prince Edward Island Canadian Club when they hold their monthly meeting on Monday.

One of Canada's leading space authorities, Dr. J. J. Green, MBE, Ottawa, will address the club when it meets at the Charlottetown Hotel.

Dr. Green, chief superintendent of the Canadian armament research and development establishment, will have as his topic "Satellites and Space Travel".

Dr. Green is currently president of the Canadian Aeronautics and Space Institute, and in this capacity deals with certain aspects of space technology. He attended the September launching of the Canadian satellite Alouette at the Vandenberg Air Force Base in California.

Born in Portsmouth, England, Dr. Green led his graduating class at London University in 1928 and later won his doctor's degree in physics from the same university.

Leaving England, Dr. Green joined the National Research Council in Ottawa and in 1943 won the MBE for public service in the field of science.

During the Second World War he served in the Royal Air Force with the RCAF and was awarded the King's Commendation for valuable service in the air.

Following the war he served with the Air Transport Board, Defence Research Board of Canada and served in the Canadian Embassy in Washington as defence research attaché.

He assumed his present position in 1959.

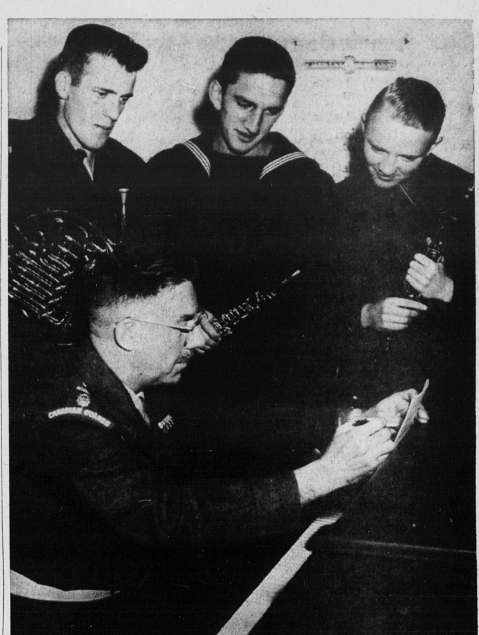

# New Brunswick Man Fined \$100 On Care, Control Count

Convicted on a charge of having care and control of a motor vehicle while his abilities were impaired by alcohol, Peter Henry Lovelock, 45, of St. John's, N.B., was fined \$100 and costs or 10 days in jail by Magistrate James B. Johnston, Q.C. in a special session of Queens County magistrate's court last week.

In a case called prior to the Lovelock case, a charge of failing to stop at the scene of an accident was withdrawn against Hollis S. MacKay, French Rivier, at the request of the crown.

In both cases the crown was represented by Alan K. Scables and the defence by the late John P. Nicholson.

Two police witnesses, Const. Robert J. Haffax, sergeant, and Const. Allan D. Burchill of the RCMP testified for the crown in the Lovelock case.

Const. McCann, told of finding a 1958 Dodge car stopped partly on a travelled portion of the highway near St. Dunstan's school on the night of Oct. 9, 1962.

**FOUND ASLEEP**  
He said he had found the accused asleep behind the wheel, and that he had detected an odor of alcohol coming from the accused's breath, and that his eyes were glassy, his speech

slurred and his walking unsteady.

He stated that later Consts. Burchill and Johnston arrived at the scene of the accident, and that they had removed a passenger from the Lovelock car and taken to a hospital.

Both men were placed in Const. McCann's patrol car and taken to the Queens County Jail, where Lovelock was taken inside and booked, while his passenger, Frederick Killam, had been transferred to Cast. Burchill's car and taken to a hospital in Upper Hillsboro street.

Const. Burchill corroborated Const. McCann's testimony, and stated that he and Killam had been in the car when the accident occurred, and that they had been driving without due care and attention, despite the fact that they were waiting for garage assistance in New Brunswick before crossing the island on the 6 p. m. ferry.

He said that the car had broken down near Charlottetown, and that they were unsuccessful in getting it restarted, and that they had dozed off in the car while waiting for garage assistance.

He said that Killam had been thrown by himself to do the driving, and that he had not at any time done any driving himself. He declared that the only reason he happened to be on the driver's side of the front seat was because he had been waiting to find out what was the trouble by crawling under the dashboard.
