## PROPOSED AMMENDMENTS TO THE UPEI STUDENT UNION INC CONSTITUTION TO BE VOTED ON AT THE GENERAL MEETING OF THE UNION OCTOBER 5, 12:00PM IN THE PIT

### (ARTICLE IV: MEMBERSHIP)

(A) 2) The following shall be Associate members:

Students who have registered for instruction at UPEI in less than three (3) courses per semester and have paid the current and full Student fees, appropriate for Associate members, as prescribed by agreement between the Council and the Mature and Part time University Students (MAPUS) Association.

#### PROPOSED CHANGE

(A) 2) The following shall be Associate members:

A) Students who have registered for instruction at UPEI in less than three (3) courses per semester and have paid the current and full Student fees, appropriate for Associate members, as prescribed by agreement between the Council and the MAPUS.

B) Students who have registered in either provisional part time, or full time UPEI graduate program and have paid the current and full student fees appropriate for associate members, as prescribed by agreement between the Council and the UPEI Graduate Student Association.

B) Every member shall be eligible to participate in any of the activities of the UPEI SU. Only Active members, as defined in this Article, shall have the right to vote or assume any elected position. However, Associate members shall have the right to vote for one (1) designated position on the UPEI Senate. This position is to be filled by an election from the Mature (as defined by the University) and Part time (Associate member) Student population of the University.

#### PROPOSED CHANGE

B) Every member shall be eligible to participate in any of the activities of the UPEI SU. Only Active members, as defined in this Article, shall have the right to vote or assume any elected position. However, MAPUS shall have the right to vote for one (1) designated position on the UPEI Senate. This position is to be filled by an election from the Mature (as defined by the University) and Part time (Associate member) Student population of the University.

### Article V - MATURE AND PART TIME UNIVERSITY STATUS (MAPUS ASSOCIATION)

The UPEI SU recognizes the Mature and Part Time University Students (MAPUS) as an associate organization (as distinct from a Suborganization) of the UPEI SU.

#### PROPOSED CHANGE Article V - ASSOCIATE MEMBERS

A) The UPEI SU recognizes the MAPUS as an associate organization (as distinct from a Suborganization) of the UPEI SU.

B) The UPEI SU recognizes the UPEI Graduate Society Association as an associate organization (as distinct from a suborganization) of the UPEI SU.

### Article VI - STUDENT UNION FEES

A) 2) The Student Union Fees for Associate members shall be determined and set by agreement of the UPEI SU Council and the MAPUS Association. The Student Fees for Associate mem-

bers shall be refunded in full if a student withdraws from the University before October 15 in the first semester or February 15 of the second semester.

#### PROPOSED CHANGE

A) 2) The Student Union Fees for MAPUS shall be Determined and set by agreement of the UPEI SU Council and the MAPUS Association. The Student Fees for MAPUS shall be refunded in full if a student withdraws from the University before October 15 in the first semester or February 15 of the second semester.

### Article VI - STUDENT UNION FEES

B) 2) The Student Fees for Associate members shall be collected in a manner agreed upon by the UPEI SU Executive and the MAPUS Executive.

#### PROPOSED CHANGE

B) 2) The Student Fees for MAPUS shall be collected in a manner agreed upon by the UPEI SU Executive and the MAPUS Executive.

### Article VII - UPEI SU COUNCIL

6) No faculty or school shall have less than one (1) elected Representative on Council.

#### PROPOSED CHANGE

6) One (1) Representative from the Graduate Student Association to be elected in the Fall UPEI SU Elections.

7) No faculty or school shall have less than one (1) elected Representative on Council.
