Schlitz Co. Bid For Labatt Appears Certain to Succeed

LONDON, Ont. (CP) — The Jos. Schlitz Brewing Co., which bills itself as the beer that "all Americans know," appears almost certain to succeed in its bid to take over effective control of the Labatt Brewing Co. of Canada's third largest brewery.

The American company has offered \$24,000,000 for 500,000 shares of the 136-year-old Labatt. The Labatt directors have accepted the bid last Friday. The offer, for \$24 a share, expires Feb. 18, but early indications are it will be met easily.

If the Schlitz will end up with about 35 per cent of Labatt's outstanding stock—plenty for effective control.

The offer has renewed debate about the question of take-overs of Canadian firms, especially U.K.-owned ones.

Adding fuel to the debate is the fact that at least three Canadian companies are reported to have expressed interest in the Labatt shares, including one firm from the extension of non-resident ownership and control.

Defence Lawyers Declare Kidnapping Of Sinatra Hoax

LOS ANGELES (AP) — A trio of defence lawyers claimed in court here that the kidnapping of Frank Sinatra Jr. was a publicity hoax.

After the three lawyers had emphasized this theme in their opening statements, the government began to present its witnesses.

The prosecution claims the defendants kidnaped young Sinatra Dec. 7, 1962, when he had a singing engagement, and released him 56 hours later in the Los Angeles area.

If West fails to lead the jack of hearts, declarer makes a 1-8-8-8 contract, but with that lead, South must go down one.
