GLOOMY PROSPECTS.—The French Ambassador to Constantinople has returned to Paris. He brings a gloomy account of the condition of affairs in Turkey, and represents the Government as disintegrating and absolutely falling to pieces from the weight of official corruption. The English Consul-General at Constantinople, who has recently arrived here, brings information to the same effect.

The "British Workman" for April contains a short notice of the career of Sir John A. Macdonald, under the title of "The Farmer's Son who is Prime Minister of Canada." In conclusion, it tells Sir John to so use his great influence to have the duty on magazines repealed which has been pressing on the circulation of the "British Workman" in Canada. The duty in question has been repealed and the "British Workman" is now free under the amended tariff.

The extended credit system which has long prevailed has given rise, as was natural, to many schemes of the nature of collection agencies. Bad debts or doubtful debts continue to be made, we regret to say, so numerous as to make one doubt whether the business community are growing wiser in this respect as they grow older. The desperate nature of some of the debts permitted to be contracted is the only explanation for the big percentages offered for their recovery or the risks run in the choice of collectors.

CLEMENCY TO BE ABANDONED.—Gen. Melickoff has become satisfied that the policy of conciliation towards the malcontents is a failure. Many prisoners have been released, indictments against others quashed and, altogether, every lenient disposition was shown, but the effect has been the reverse of favorable; 20 Nihilists annihilated on the 19th, immediately rejoined their confederates and were found aiding in the programme of the conspirators. This so incensed General Melickoff that he has determined to make no further attempts at conciliation, and will henceforth pursue a vigorous policy of prosecution.

Sir Charles Gavan Duffy has arrived at Paris from Australia. It is believed he will be offered an Irish constituency. [Sir Charles Gavan Duffy will be remembered as one of the Irish agitators of '48 who was tried with O'Connell, for treason and sedition, but acquitted. He afterwards represented New Ross in Parliament. In 1856, he emigrated to Australia, where he became Minister of Public Works in the first Administration under responsible government, in Victoria. He filled various portfolios until 1871, when he became Prime Minister. One year later, the "traitor" of '48 was offered, but declined, a Companionship of the Order of St. Michael and St. George. Twelve months later, Her Majesty conferred on him the Knighthood, and May 31st, 1873, he was gazetted Sir Charles Gavan Duffy.]

In an article on the late King of Italy, Signor Luigi Monti says that once, in a moment of irritation, Victor Emmanuel so far lost control of his temper as to exclaim to the Ambassador of Louis Napoleon: "Who is this man, this last comer among the sovereigns of Europe! An intruder among us! Let him remember what he is and what I am,—the head of the first and most ancient race that rules in Europe!" The diplomatist having rejoined: "Am I to understand your Majesty's words as official?" The King, recalled to himself, replied: "No; there is no occasion for you to report them." The ambassador then wrote to his master: "Our ally, though biting the bit, still obeys the orders from Paris." It was rarely that the King, who was, perhaps, as democratic as a sovereign could well be, allowed his pride of birth to get the better of him. On another occasion, we learn from the same authority, he said that if he lost his crown, he should not have a coat left to his back nor a name to call himself by unless it were "Mr. Savoy."

To the Editor of the Examiner.

DEAR SIR,—Referring to the letter of Mr. S. G. LAWSON in yesterday's EXAMINER, I beg to say:

1. That the design of my letter was not to defend Mr. Harper, but to defend myself against certain statements and insinuations made by Mr. Lawson.

2. I was not aware that the Argus had assailed me, and that Mr. Lawson was defending me.

3. If Mr. Lawson did not attack me my defence was unnecessary. My disclaimer of attack upon any of the persons referred to does not seem to be called in question. Neither can my disavowal of the defence of others who can conduct their own defence, if they so desire.

4. The affairs of my church are not subject to all the high authorities which Mr. Lawson has cited. The rules of the Presbyterian Church, and those of common sense, are the principles which we profess to respect. Of these, the Presbytery, and not the general public, are the judges. If our proceedings in a congregational affair are to be called in question, Mr. Lawson is aware that he can take his case to the Presbytery, and afterwards to the Synod and General Assembly. I am prepared to defend my ecclesiastical proceedings in these Courts, the only ones that have jurisdiction in such matters. It is "hateful" to drag these matters before the general public who have no special interest in them. The secular newspapers have their own Province; in Church affairs we have ours. Does Mr. Lawson understand this?

The British Cabinet.

LORD HARTINGTON was summoned to Windsor Castle on the 22nd inst., where he had a long interview with the Queen. On his return he called Mr. Gladstone, Earl Granville, and other leading Liberals together, and informed them of the result of his long interview with the Queen. He is reported to have said that Her Majesty utterly refused to submit the formation of the new Government to Mr. Gladstone, and that no arguments or suggestions from them availed in the least to alter her determination on that point. Lord Hartington added, however that she had proposed to solve the problem by raising Mr. Gladstone to the Peerage, and thus affording to him recognition of his recent victory. His Lordship further remarked that by the Queen's authority he now repeated his proposition and submitted it for consideration as one way out of the difficulty. The Ministry, it is now thought will be thus constituted—First Lord of the Treasury, the Marquis of Hartington; Lord High Chancellor Lord Selborne; President of the Council, the Duke of Argyll; Chancellor of the Exchequer, Right Hon. Mr. Childers; Home Secy, Earl Granville; Colonial Sec'y, Sir Chas Dilke; First Lord of the Admiralty, Right Hon. Mr. Goschen; Secretary of War, Right Hon. Edward Cardwell; Vice-President of the Committee of the Council, Right Hon. Mr. Foster; Postmaster General, Right Hon. Lyon Playfair; President of the Board of Trade, Mr. Chamberlain.

A \$15,000 Robbery.

A despatch from Montreal says:—On Friday night, Mr. Turner, bookkeeper for McNamee & Co., contractors, was proceeding to Buffalo with \$15,000 with which to pay the workmen employed on a contract the firm has in that city. He deposited the money in a valise in the Pullman car and stepped on the platform to converse with Mr. McNamee. When he returned to the car the valise was missing. No clue to the thief has yet been discovered. The detectives were immediately notified of the robbery.
