The following frightful statement as to the spiritual ignorance and woe now existing in Liverpool was lately made at a meeting of the Town Mission there:—There are 60,000 adults who never enter a place of worship, except at a marriage or a funeral; 12,000 adults cannot read; 14,000 families have not a solitary fragment of the Word of God; 25,000 go to no school whatever, and the Town Missions can employ, with its present inadequate resources, no more than seventeen agents.

CHURNING MADE EASY.—We are sure that the good housewives who have in charge the several home departments of many well-ordered households to which our paper is a regular and, we trust, an acceptable visitant, will thank us for bringing to their notice the following recipe for lightening the labor of what is often one of the most fatiguing and vexatious of all the tasks of housekeeping. The advice comes from a practical and experienced source, and is very easily put to the trial. Every good housewife knows that at times, from some peculiar causes, (most generally extra sourness or bitterness of the cream,) much difficulty is experienced in making the cream into butter. A lady writer in the Indiana Farmer recommends the following course in such cases. We have, says the Western Farmer, for years, used soda or saleratus for the same purpose, and found them usually successful. "I wish to inform my sister butter-makers of the means I used, which so successfully removed the difficulty. I churned perhaps three hours to no purpose, and then tried to think of something that I had read in the Indiana Farmer, or some other periodical. I could not remember precisely, but I recollected the reason stated was the cream being too sour. I then thought of soda, (pearlash, I presume, would do as well) and dissolved a large spoonful in a pint of warm water, and as I poured it in, churning at the same time, it changed in a moment, and gradually formed into a beautiful solid lump of sweet butter."

CHARLES JAMES FOX.—The gaming at Almack's, which has taken the pas of White's, is worthy the decline of our empire, or commonwealth, which you please. The young men of the age lose five, ten, fifteen thousand pounds in an evening there. Lord Stavordale, not one-and-twenty, lost eleven thousand there last Tuesday, but recovered it by one great hand at hazard. His cousin, Charles Fox, shines equally there and in the House of Commons. He was twenty-one yesterday evening, and is already one of our best speakers. Yesterday he was made a Lord of the Admiralty. The House of Commons is embarked on the ocean of Indian affairs, and will probably make a long Session. I went thither the other day to hear Charles Fox, contrary to a resolution I had made of never setting my foot there again. It is strange how disuse makes one awkward; I felt a palpitation, as if I were going to speak there myself. The object answered. Fox's abilities are amazing at so early a period, especially under the circumstances of such a dissolute life. He was just arrived from Newmarket, had sat up drinking all night, and had not been in bed. How such talents make one laugh at Tully's rules for an orator, and his indefatigable application. His laboured orations are puerile in comparison to this boy's manly reason.—Horace Walpole's New Letters.

PARTY SPIRIT.—The New York Aurora makes the following just and sensible remark:—"The very spirit of party is adverse to truth and honesty. It is a continual struggle for certain advantages—for place, honors and money. We hear tell of the integrity of this or that party leader, but all amounts to nothing. The wire-pullers yell and scream about the rights of the people, and then cheat the people before their eyes. Nor is this all—getting into the habit of practising favoritism, and applauding their own party, right or wrong, all their actions are tinged with the same character; and a thorough obliquity of mental vision renders them unworthy of confidence on any occasion."

By the Mail which arrived last evening we have received our usual files of American and Colonial Newspapers—they are, however, entirely destitute of News of any description.

We have devoted a considerable portion of this day's paper to the correspondence which has lately passed between Lord Falkland, Lieut Governor of Nova Scotia, and the Hon. Messrs. Uniacke, Howe and McNab, on the subject of the resignation by the latter of their seats in the Executive Council, &c. Though rather lengthy, we have no doubt these documents will be perused with interest by many of our readers, tending, as they do, to exhibit in a striking point of view, the practical working of that system of Colonial Government for the establishment of which the Liberals of Nova Scotia have been so long contending.

BANKRUPT LAW.—A synopsis of the Bankrupt Law lately passed by the Canadian Legislature will be found in our fourth page to-day. We have been induced to give publicity to this document, at the present moment, under the impression that it may possibly afford our legislators some useful hints in the preparation of a similar measure for this Island—the necessity for which has again been pressed upon their attention by His Excellency the Lieut. Governor, in his opening speech, and against which we have heard no valid objections raised in any quarter.

Yesterday, about one o'clock, Duncan Maclean, Esq., being in attendance, the Hon. the Attorney General addressed the Court at considerable length, in reply to the several objections offered by Mr. Maclean, in arrest of Judgment, in October last, moving that the Rule nisi, granted in this case, be discharged. Mr. Maclean, made a few observations in reply; after which the Court decided that none of the objections offered by Mr. Maclean were of such a nature as to affect, in the slightest degree, the validity of the proceedings on the late trial. Rule ordered to be discharged. The Hon. the Attorney General then stated, that he was commanded by His Excellency the Lieut. Governor to say, that as this action was not commenced from any vindictive motive, or with any intention or disposition to circumscribe the right of the public freely to comment upon the acts of the Executive, provided this were done in a constitutional manner, His Excellency was perfectly satisfied that the matter should proceed no farther. The Attorney General having also stated that it was not the intention of the Crown Officers to move for Judgment, the defendant was discharged from further attendance, and so the matter drops!

PROFESSOR MACKINTOSH.—This Gentleman sailed in the Steamer for England on Wednesday last. He has the prayers and good wishes of many in this City, who rightly appreciate his scholastic attainments and piety. Before his departure, he received a complimentary address from the Minister, Elders, Committee of management, His Worship the Mayor, and others in connexion with St. Andrew's Church.—Nova Scotian, Jan. 7.
