Summerside police have recovered fifteen cartons of cigarettes stolen in a week-end break at the Island Motor Transport bus terminal in Summerside. Other merchandise including a number of watches and cigarette lighters were not recovered.

The value of the watches and lighters would be between \$50 and \$100.

Two or three Summerside men suspected of being implicated in the break made a hasty departure from the Island before they could be picked up by police.

Electric Plant Workers Seek Wage Increase

A bargaining meeting was held on Tuesday evening between a committee of the Town Council and a delegation of the Electrical Workers Union which recently organized the employees of the Summerside electric light plant.

The union representatives presented their application for a wage and hours agreement which would include a wage increase of fifteen per cent and a forty-four hour week.

The council took the matter under consideration and it will be discussed by the full council in the near future.

Worms Attack New Districts In Nova Scotia

HALIFAX (CP) - Ramping army worms spilled over into two previously untouched districts of Nova Scotia Wednesday and one farmer reported they devoured an entire 17-acre field of oats.

Mounting concern over the inroads of the crop-destroying pest coincided with a run on stocks of poisons at points as widely separated as Sydney in Cape Breton and Digby on the west coast.

The pillaging worms showed up Wednesday in the Glace Bay district of Cape Breton county, thus completing in encirclement of the province's lush agricultural areas. Farmers in Richmond and Victoria counties have been under siege for several days.

Another region invaded Wednesday was Digby county which adjoins hard-hit tracts in Yarmouth county. The northern Nova Scotia counties of Cumberland, Pictou and Colchester have been battling the source for days.

17 ACRES GONE IN HOURS

Bruce Read, a farmer in the Bear river district of Digby county reported the worms demolished a 17-acre field of oats in a matter of hours. Neighbor Fred Read lost 10 acres of oats.

Recent reports have told of the worms depositing from the usual pattern and attacking the tops of crop roots like turnip in addition to grains.

Farmers were fighting the worms with a poison mixture consisting largely of paris green. In Cape Breton, the demand for supplies was so great that fresh supplies were hastily distributed from Sydney.

The worm is believed to have been finally spotted by one of the three RCAF C-54 aircraft from the Maritime, who would have radioed the news to the ground headquarters.

Rich Harvest of Irish Moss Reported Ashore In Tignish Area Yesterday

Irish moss came ashore in fairly large quantities at "The Green" in the Tignish area yesterday brought in by the high winds and heavy rolling seas of the past two days.

Gatherers of the moss were on the beaches long before daylight and lined the shores with vehicles of all descriptions including dump carts, single and team wagons, trucks, tractors and trailers.

The moss was loaded and hauled to the homes for drying and bleaching or in some cases stockpiled on the beach.

Several vehicles were driven right into the surf where they were loaded with good clean moss before it reached the sandy shores.

At the Kildare shore a large crowd waited patiently all day but the expected influx did not occur.

Thirty vehicles were counted at the Kildare shore in the afternoon. It was thought a heavy harvest was expected.

Up to a hundred dollars worth can be gathered by two persons in a day if the supply is plentiful. Black moss (dried a day or two) brings six and a half cent with bleached (white moss) about ten cents a pound.
