Discuss Serious Problem Of Juvenile Delinquency

Summerside Police Court yesterday morning was the scene of a lengthy discussion on the juvenile delinquency problem existing in Summerside.

Participating in the discussion which took place during the trial of two 18-year-old youths were Magistrate E. H. Strong, Q.C., prosecutor D. O. Stewart, Q.C., and Chief of Police Peter R. White.

The three men were in unanimous agreement that a serious juvenile problem existed in Summerside; that juveniles should be segregated from older prisoners, but agreed that facilities in the Prince County jail did not permit this to be done; and that the establishment of an industrial farm on the Island would provide healthy, useful, and reforming environment for many youths who had personalities that would permit them, with proper guidance, to develop into citizens who would lead good constructive lives.

It had been expected that consideration would be given to the matter of summoning parents of juvenile offenders to appear before the court, but this expected procedure was not discussed.

It was felt that if an industrial farm home were available the present situation would be greatly alleviated.

Western Canada's Example Chief White said that Western Canada had been using a "home" system for juveniles when he was doing police work there in 1914.

He said he believed that the Attorney-General believed in the value of establishing such a home for P. E. I. juveniles.

Both Chief White and Crown Prosecutor Stewart stressed the fact that citizens are becoming alarmed and critical at the prevalence of petty thievery by juveniles, and they agreed that something must be done to cope with

the situation. Mention was made of one Summerside man who publicly announced that everything had been stolen from his garage that could be taken, and that it was therefore pointless for thieves to go there again.

Magistrate Strong cited several cases in which various merchandise was stolen by juveniles and sold to adults, and he contended that they (the adults) were contributing heavily to delinquency by making such purchases.

He cited a specific case that had appeared before him in which stolen property had been sold to an adult by youths who later stole the same items from him and tried to sell it to him a second time. The magistrate said if there had been some way of doing it he would have sent the man to jail who had bought the items from these youths who obviously were selling stolen goods.

Need Agreed Upon All three men agreed that there should be some place on P. E. I. where these youths could be sent other than to mix with the older prisoners in the Prince County Jail, and Magistrate Strong told Mr. Stewart and Chief White that the realization of such a home for

boys might some day be the result of men like themselves who fully realized the need for such a home. He could foresee good and industrious citizens resulting from the training that would be received by boys like the ones before the court.

The two youths in question, who had each been involved in previous thefts were sentenced to four months in jail for breaking, entering and stealing eggs, cake, and cigars from Robinson's Bakery.

In the only other case before the court yesterday morning a young man from Summerside was charged with operating a motor vehicle on an Ontario chauffeur's licence. The Magistrate imposed a fine of \$10 and costs after telling the man that it was not legal for him to remain on P. E. I. and drive a P. E. I. taxi under an Ontario chauffeur's permit. — S.
