AMOUNTS DUE THE BANKS.

The published bank statement to the 30th September shows that at that date the loan of the Merchants Bank of P. E. Island to the Provincial Government amounted to \$28,397,001.

It is probable that parts of these amounts are owing by the Government of Nova Scotia; but we believe that by far the largest proportion is due to the Government of P. E. Island.

A terrible tragedy occurred here this morning. A man named Richard Savage, shot his wife and child and then killed himself. His wife and child had been living here three months, she having left her husband in New York on account of his cruelty to her. The husband came here yesterday and remained with his wife all night. He tried to persuade her to return to New York, but she refused. About nine o'clock this morning, without warning, he drew a revolver and shot his wife and child, then turned the weapon on himself. The boy is dead, and the woman and man will not live many hours.

GENERAL TELEGRAPHIC NEWS.

OTTAWA, Nov. 5.--The Trade and Commerce Department has issued an important circular calling attention of manufacturers and shippers to or through Great Britain to the British Merchandise Marks Act, which is very stringent in its provisions, and non-compliance renders goods liable to confiscation. Shippers will do well to study the circular, save trouble and annoyance, if not loss of property.

LOXDOX, Nov. 5.--A fleet signal made at Portsmouth to-day said that while a party from the British warships at Rio Janeiro were ashore procuring sand, a powder magazine exploded near them. Lieut. E. B. Monbray, of the Sirius, and Lieut. Godfrey Otway Tupper, of the Racer, are missing since the explosion. Boatswain Harris and a seaman from the Sirius were killed, and five seamen injured. The date of the explosion is not given.

JOLLETTE, Nov. 5.--John R. Hooper was this afternoon indicted to stand his trial before the court of Queen's bench for poisoning his wife on the 18th of Sept. last. The last witness heard was Miss Alice Stapely, who was courted by Hooper. She repeated the story she has already told at Port Hope. Hooper was calm and smiling to the last. He will be detained here until his trial commences. The term of the court opens on the 15th of December, and an effort will be made to have the trial before Christmas.

OTTAWA, Nov. 5.--Pursuant to the new interpretation and requirement relating to masters and mates of steam vessels under one hundred tons, plying and registered in Canada, nine persons being in command or officers of such steam vessels, lighters and tug boats in Halifax and along the coast have come forward, passed prescribed examination and have been awarded certificates of service. Capt. Mills of Grandville Ferry has made application for a certificate of service.

QUEBEC, Nov. 2.--There is a little rebellion how in progress at Charlebourg, one of the ancient capital's most charming suburbs. The malcontents had a split with their parish priest over the purchase of a new cemetery, and when the cardinal archbishop was informed of the trouble his eminence promptly put the ban on the would-be rebels. Yesterday an interment was held, but the Rev. Mr. Hoffman refused to give the body the usual Catholic rituals. He proposed to place the body in the church cellars pending the decision of the parish council, but the body lay in the church several hours until the parents felt so indignant that they bore it to the cemetery and buried it themselves.
