Ordered. That the following Resolutions, adopted by the House this day, be inserted once in all the Newspapers published in Charlottetown:

JOHN McNEILL, C. H. A.

Resolved. That the sum of Three thousand pounds be granted and placed at the disposal of the Government, to be advanced in sums not exceeding four pounds to any one individual, to parties whose circumstances of destitution are such, that they cannot obtain or purchase sufficient Seed Grain for their farms. The same to be divided as follows: Nine hundred pounds to each County, and Three hundred pounds in hands of the Government, to meet special cases and emergencies; one or more Committees to be appointed in each Road District, to whom shall be entrusted the distribution of the amount allotted to the District. The repayment of the several sums advanced to be secured by joint notes, payable to the Treasurer, with interest at six per cent., on the first day of December next, and the several amounts, when due, to be payable to such person or persons as the Government, from time to time, shall appoint. The Lieutenant Governor in Council, if they think fit, may raise the said sum of Three thousand pounds by issuing Debentures, chargeable on the Public Funds of this Island, payable at such time as the Government shall appoint, and bearing interest at a rate not exceeding six per cent. per annum.

Resolved. That the sum of Nine hundred pounds, granted by the last preceding Resolution, to be distributed in each County, to assist destitute persons in purchasing Seed Grain, be divided between the several Road Districts thereof, as follows:—

QUEEN'S COUNTY.

AFTER an unusually long and severe winter, the ice in our harbors is at length beginning to break up, and in the course of a few days, the course of navigation will be free to be resumed. The Mall steamers are being repainted, and otherwise prepared for their summer duties. In addition to the Princess of Wales and Heather Belle, we learn that the Prince Edward Island Steam Navigation Company have purchased a new and powerful Steamer for service in the Gulf. This indicates financial healthiness on the part of the Company, in whose prosperity the inhabitants of this Island feel a warm interest. In the event of the rumored withdrawal from this route of the Boston Boats, we would express the hope that the Island Company will feel themselves warranted in running a boat between Charlottetown and Boston, and intermediate Ports, to supply the place of those which it is said are about to be withdrawn. After experiencing the benefits of direct steam communication between this Colony and the United States for many years, a return to the old system of a precarious packet communication is neither a desirable nor a pleasant prospect and our hope and belief is that the Colony has made such advances in material prosperity and commercial enterprise, as to justify the Island Steam Navigation Company in placing a Boat on that route, and preventing a relapse to a state of affairs only suitable to a by-gone age. The Princess of Wales and the Heather Belle will make their first trips for the season, next week—the Princess going to Shediac, and the Heather Belle to Pictou, on Monday.

It is anticipated that there will be a change of Ministry in England, on the Irish Question, on the re-assembly of the Imperial Parliament after the Easter holidays. The Conservatives, who are now in power, desire the postponement of the question until next year, whilst the Whigs or Liberals, and the majority of the people of the Empire, urge the immediate abolition of the Irish Church Establishment, and the settlement of the Land Question. We will revert to this matter at an early day.

The Alewives Fishery Bill, passed this Session by the House of Assembly, has been thrown out by the Legislative Council, in consequence of no petition in reference thereto, having been presented to that Body.

In our next issue, we will give an outline of the amendments introduced into the Education Act this year. The Act is much more simplified than formerly.

The Legislature is to close its proceedings for the Session on Friday next, and will then be prorogued in due form.

The steamer Alhambra is to leave Boston to-day for Halifax and Charlottetown.

The Nova Scotia prospect does not seem to be very encouraging, if the following is correct:— OTTAWA, April 6.—Private letters received within a day or two ago, from London, state that the Hon. Joseph

Howe had had an interview with the Duke of Buckingham, Colonial Secretary, in relation to his repeal mission, and that the Duke after hearing him at length, quietly replied that the Union was at present the policy of the Empire, and that the Government could not, upon the representations submitted by Mr. Howe or the other Anti-Union delegates whom he understood to be in London, undertake to stultify itself in this early day, by reversing the deliberate and well considered course arrived at when it advised the Queen to sanction the British North America Act of last year. It is also understood that the Duke referred to the unconstitutional course adopted by the Repealers, inasmuch as the resolutions passed by the Nova Scotia Assembly, while purporting to be the expression of the Nova Scotia people, had not received, or been submitted, for the concurrence of the Legislative Council and Lieutenant Governor of Nova Scotia.

At the Annual Meeting of St. James' Church, on Monday night, the following gentlemen were elected Trustees for the current year, viz.: J. W. Morrison, W. R. Watson, Arch. Kennedy, A. Brown, J. D. Mason, James Anderson and H. M. McLeod, Esquires. After the transaction of the usual financial and other annual business, the Chairman, Hon. Col. Grav, on behalf of the Congregation, presented their popular and esteemed minister, Rev. M. Duncan, with a handsome and valuable gift, and a resolution was passed, that the Rev. gentleman be obtained three months leave of absence, and in a few weeks intends to revisit his native land, so as to be present at the meeting of the General Assembly of the Church of Scotland in May next. We understand the young men and women of Mr. Duncan's flock also intend to present him with a purse previous to his departure. This, with £25 of additional stipend, is highly creditable to both pastor and congregation. The Address and Reply shall appear in our next issue.—Pat.

All Sorts of Paragraphs.

THE BITTER FRUITS OF REBELLION.—There is too much exultation in the following description of the fearfully changed condition of the aristocracy which slavery created and enriched, and which by its own pride and presumption, brought retribution upon its own head:— "In a trip through the Southern States at the present time one can see nothing amid the wreck more salient than the rapid decadence of the planting noblesse. Their spreading mansions, circled by graceful verandahs, and set in little Edens of fadefless hedges and trees, have an air of decline, like a woman richly dressed but out of the fashion. The houses need paint, and the hedges trimming. The stepping stones, whereon so many dainty feet have patterned between the carriage and gate, have the stains of disuse upon them. The favorite creams are gone like the slave who rubbed their glossy coats. The woe of poverty fills between the neglected shrubs and covers behind the ambitious stuccoed columns. It is not hard to identify one of the former class of cotton darlings. Bitterness and sadness dwell in their faces. The young men once accustomed to horses, guns, dogs, a slave for every whim, and spending money in unreckoned wants; the young women, lovely as a tropical flower, as languid as a lily on a breathless lake, and fragile in beauty as either; his feudal pride, his shoals of sleek slaves, his resounding palaces, his hospitable country palace and his prodigal cheer—all are alike bewildered by the pitiless revolution that has stricken them with decay, even as the husbandman deadens the forest that he may have fields instead of embering groves. We do not doubt that the once haughty and powerful slave aristocracy is passing away. Emancipation girdled that tree. The woodman does not wait to see the leaves wither on the oak around which he has cut the fatal notch. He knows that the work is done."

A PRINTER'S TOAST.—The following ingenious sentiment was given by Mr. Henry L. Williams, at the third annual dinner of The Typothete, February 20, 1866, at the Maison Dorée:—"The Printer.—An Epitome of many Trades and Professions.—Like the Lawyer, he practices at the bar, and handles capital as well as lover cases; like the Moralist, he gives plain rules to guide him; like the Bravo, he sticks daggers into many forms; like the Astrologer, he reads the stars; like the Jailer, he is great on locking up; like the Witch, he has dealings with the devil; like the Cheat, he is versed in all the arts of imposition; like the Hunter, he knows all about the chase; like the Forger, he has a strong eye always ready; though his profession is not as old as Adam's, yet, like the Gardner, he must be able to handle a Hoe, and, unlike the original gardener, he never wants clothes with a Taylor in his office; like the Soldier, he can handle the shooting-stick, arrange columns, and set up canon; like the Dandy, he is fond of a dish; like a King, he has plenty of pages; like the base-ball Player, he catches on the fly; like the Milliner, he keeps a small stock of small caps, bonnets and flowers; like the Jeweller, he can set a pair, ruby, agate, diamond; like the House-keeper, he has a supply of furniture, beds, Blankets and sheets; he never wants for music, with so many excellent papers in his profession. Finally, like the Clergyman, he sees his most perfect forms, after he has corrected all errors, carried off, and their beautiful faces covered with clay."

A NEW REPUBLIC.—The Settlers at LaPrairie, Manitoba, Red River, about five hundred, have revolted from the government of the Hudson Bay Company and formed a Republic of their own. T. Spence has been elected President of the Republic, and a despatch has been addressed to the Secretary of State for Colonial Affairs in England, praying that favorable recognition be given to their Government, it being simply their aim to develop their resources, improve the condition of the people, and advance and preserve British interests in that rising part of the far West. In the despatch, the boundaries of the new Republic are defined as follows:—North—From a point running due north, from the boundary line of Assiniboine, till he strikes Lake Manitoba; thence from the point, stuck a straight line across the said Lake to Manitoba Port; thence by longitudinal line 51, till it intersects line of latitude 100. West—By line of latitude 100, to the boundary line of the United States and British America. East—The boundary line of the jurisdiction of the Council of Assiniboine. South—The boundary line between British North America and the United States. This is the first open defiance of the authority of the Hudson Bay Company.

THE DUKE OF EDINBURGH IN AUSTRALIA.—The Duke of Edinburgh started three weeks in South Australia, and 200,000 people there kept holiday during that period, to celebrate his visit. Twenty-five steamers, containing 10,000 persons escorted his ship Galatea to the bay to Melbourne, in Victoria. 150,000 persons thronged the streets of that City to welcome him. The address of the city to him was presented in the presence of 30,000 spectators; 11,000 children sang the English National Anthem to him; a free public banquet was given to 30,000 persons in the open air, in honor of the Royal visit; hundreds of addresses were presented to the son of the Queen of England, expressing loyalty and affection. Towns and villages were filled with Germans and Chinese vied with people of English descent, in expressions of loyalty and attachment towards the Prince and his mother. Balls, fireworks, and illuminations celebrated the royal visit, and joy fires blazed on every hill for fifty miles around. The Galatea was to be escorted up Sydney Bay by nearly fifty steamers, containing 20,000 persons. The Prince laid the foundation stone of a public building with a trowel formed of solid gold, ornamented with precious stones.

A correspondent of an English paper proposes to settle the Irish question by a plan similar to that of the "Marriage Fund Association." He wishes the Government to offer a bounty to every person of Irish descent who marries one of English or Scotch ancestry, and pay a premium of £10 for every child born of such marriages.

Mr Charles Dickens' account of the 'thieves' den' in Oliver Twist, has found a parallel in New York city, where the police have just succeeded in breaking up a large gang of thieves, consisting of two men, two women, and nine boys. The headquarters of the family in Crosby street, and here is where the 'Fagin' of the company, Frank Oliver, marshalled his young candidates each morning, and assigned them each a district in which to ply their vocation. Each morning the newspapers were read to ascertain if any large meetings were to be held, and if so, a special force was dispatched to the place. The plunder, consisting of jewelry and every kind of wearing apparel, from beautiful velvet and chinchilla cloaks and dresses down to a pair of silk gloves or a pocket handkerchief, was all handed over to Oliver, who paid a certain per cent., to the operators for their services. The organization, it seems, was still in its infancy, having been going on for a little more than a month. The stolen goods found in their possession amounts in all to over \$5000, most of which has already been identified and restored to the owners.

A brute has been executed in Virginia for having murdered three persons in a family of four. He confessed the murder, was devoutly thankful that Providence had prevented him from perpetrating the fourth, —was profuse in his declarations of forgiveness for all his enemies, and hoped that neither his family nor his countrymen would suffer from the disgrace he had inflicted on them. He seems to have made as pious and edifying an end as butchers and brutes of his class usually do. These exhibitions which are becoming so frequent, are simply disgusting. The whole system of public executions ought to be reformed. — From the time a murderer is sentenced to death, he ought to be absolutely unseen and unknown to the outside world.

When stumping some of the counties of Ontario, Mr. McDougall stated that the Government were then in correspondence with the Governments of Newfoundland, Prince Edward Island, and British Columbia, and that even within a few weeks, one, if not more, of these Colonies would join the Confederacy. Mr. McKenzie moved for copies of the correspondence, and Mr. McDougall had to admit that there was no correspondence; but, he said, it was well known that the Governor of Newfoundland was in Ottawa, at the opening of Parliament, to confer with the Government about the admission of that Colony. It so happens, however, that he did not come to Ottawa until after Mr. McDougall had made the statement, which had its foundation in fancy and not in fact.—Ottawa Correspondent St. John Freeman.

MR. GEO. PEABODY AT ROME.—A letter from Rome in the London News says that Mr. George Peabody and Hon. Robert C. Winthrop were recently presented to the Pope. His Holiness was fully aware of the character of his visitors, whom he requested to be seated in his presence, an unusual mark of distinction. A delicate token of Pope Unno's appreciation of Mr. Peabody's universal benevolence was afforded by the Latin quotation from Holy Writ, showing the blessed quality of charity, which he wrote with his own hand under some photographic likenesses of himself, which he presented to the party as souvenirs of the visit.

We find the following paragraph in the Quebec Gazette of March 20th, in reference to the Dominion 'standing army' that is to be:—"There is stated to be a project in contemplation to establish a standing military force throughout the Dominion, according to the population in each Province, as follows:—Ontario, 2 regiments, 4 battalions, 600 men each, 2,400; Quebec, 1 regiment, 2 battalions, French, 1,000; Quebec, 1 regiment, 2 battalions, English, 600; Nova Scotia, 1 regiment, 2 battalions, 600; New Brunswick, 1 battalion, 400.—Total 4,600.

In reference to the blowing up of the Parliament building, we find the following in a despatch to the Montreal Gazette:—"The opinion gains ground that the murder was the result of a deep laid conspiracy in which a large number of persons are implicated, and fears are entertained for the safety of the Parliamentary Buildings. Some persons holding that the large quantity of nitro-glycerine which was recently obtained in New York on a forged order was destined for use in this city, as part of the plot which has resulted in the death of Mr. McGee."

ROBBERY AND MURDER ON THE GRAND TRUNK RAILWAY.—On Tuesday we published a short account of a robbery and murderous assault committed on the person of a respectable and inoffensive man, a drover named Sykes, on the Grand Trunk Railway, near Prescott. The unfortunate man has since died from the effects of the injuries he received by being thrown from the car; but he survived long enough to give the particulars of the diabolical outrage, and the name of one of the parties—the man who demanded his money.

The Montreal Daily News says that private and reliable information has been received of a Fenian movement in the neighbourhood of Malone. Numbers of men, supposed to belong to the organization, and all of whom possess arms of some kind, have been gathering at that point for some days. It is there a matter of common belief that their presence is the result of a plan with mal-content on this side of the line are not so ignorant as good loyalty would require them to be.

An extraordinary tragedy has lately been enacted at Todmorden, England.—The Rev. Mr. Plows, Mrs. Plows and several of their servants were attacked during the night of 2nd ult., by a suitor of one of the maid servants, who had been discharged on account of his visits. He was armed with a pistol and an axe, killed one of the servants on the spot, and inflicted such dangerous wounds upon Mr. and Mrs. Plows that they are not expected to recover.

The Lynchburg Virginian dislikes the Peabody educational scheme, and says:—"Better let our children go uneducated, and live in the woods, communing there with nature and with nature's God; than to accept of instruction in Schools where New England politics, philosophy and religion are to substitute in any measure the traditions of our good old State."

The Maryland Legislature has passed a law to the effect that no liquor shall be sold in the State on Sunday, except when prescribed by a physician. It is fearful to think of the amount of sickness that will hereafter prevail in Maryland on Sundays.

A writer in the Portland Press states the following very interesting facts:—"From Chicago the distance to San Francisco by the Pacific Railway is 2,338 miles, which makes the line across the Continent from Halifax to San Francisco 3,979 miles."

During the discussion in the House of Commons the other day, Mr. Rose said he had reason to believe that Mr. Sherman's bill, now before the United States Congress, assimilating the American coin to the French, would be adopted.

Reliable intelligence per Atlantic Cable has been received, which leaves no doubt that Dr. Livingston, the African Explorer, is still living. A letter from himself has been received in London, stating that he is in good health, and expects soon to return to England.

Mr. Dickens is to conclude his readings in the United States with a series of five in New York, beginning on the 13th, and ending on the 29th of April. Two days later he is to sail for England.

Mr. Peabody, the American banker, had a pleasant interview with his Holiness the Pope recently, and on his return to his hotel sent back a cheque for 1,000 francs, in aid of the funds of San Spirito Hospital.

Since King George arrived at Athens, on the 30th of October, 1863, the Government of Greece has been conducted by sixteen different Cabinets, including that which held office when His Majesty arrived.

Queen Victoria has twelve grandchildren. Her eldest daughter has five children; the Princess of Wales, three; Princess Alice of Hesse, three; and Princess Helen of Prussia, one.

A recent cable despatch announced the capture of Capt. Denzey, the Fenian, in some part of Ireland, while the Boston Journal of a late date says he is now doing duty as a policeman in the city of Lawrence.

The news from Newfoundland Seal fishery is encouraging. The steamers Mastiff and Retriever have arrived at Harbor Grace with full fares. The Mastiff had nineteen thousand seals.

There is to be an Intercolonial Maritime Exhibition at Havre in June next. The Exhibition embraces forty-three classes figuring in the programme in the five following groups: Navigation, Goods, Fishing, Agriculture, and Complementary classes. Sailing, rowing, and steam regattas are also proposed.

At Montague River, on the 12th inst., Hugh McLean, aged 46 years.

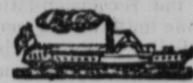
