

U.S. Committee Renews Its Attack On Canadians

WASHINGTON (CP)—Ignoring protests by Canada and its own state department, the U.S. Senate internal security sub-committee Thursday renewed its attempt to link E. H. Norman, Canadian editor, with Communist activities in the United States.

The sub-committee made public the record of a secret March 21 hearing which quoted committee counsel Robert Morris as saying the FBI has given the states a "parliamentary immunity" which confirms his previous charges that Norman had been a Communist.

The sub-committee fired its new blast at Norman, in whom the Canadian government has expressed complete confidence, in the wake of a sharp Canadian protest against the earlier allegations and in the face of a state department request that such material not be released because "it might be damaging to our friendly relations with Canada."

State department officials, obviously embarrassed by the sub-committee's action but powerless under American law to do anything about its activities, said they could say nothing about the FBI report mentioned by Morris but indicated they knew nothing about it.

WRITTEN TO NO AVAL
They did say that underscrewing Christian A. Herter had written obviously to no avail—to the sub-committee several days ago asking that such material not be made public because of its effects on Canadian-American relations.

Thursday's episode marked the third time in two weeks that Morris and the sub-committee have attempted to smear the Canadian diplomat, who has been investigated and cleared by the Canadian government after the sub-committee published similar allegations in 1951.

On March 14, the sub-committee released the transcript of a secret hearing with John K. Emmerson, U.S. diplomat stationed in Lebanon, who was questioned closely about his relationships with Norman, a personal friend. Emmerson said repeatedly that Norman had said or done nothing that would indicate he was a Communist.

Wednesday, in open hearing, the sub-committee questioned Tsuru Shigetou, a Japanese professor, about his associations with Norman in a group of students making a study of American capitalism at Harvard University in 1937.

The transcript released Thursday covered a second appearance before the sub-committee by Emmerson, who was questioned by Morris in a one-man hearing attended only by Senator Arthur Watkins (Rep.-Utah), sitting as sub-committee chairman.

REITERATED STATEMENT
Emmerson reiterated that he had no reason to think that Norman was a Communist.

The record quoted Morris as saying the sub-committee had asked the state department if the Canadian government's decision, after its 1951 inquiry of Norman, was to the effect that they covered that Norman had been a Communist and that he is no longer one.

"The department has informed us," Morris added, "that has never been the effect of any advice given them by the Canadian government."

Morris recalled that Prof. Karl A. Wittfogel of Columbia University had charged before a sub-committee hearing in 1951 that Norman had been a member of a Communist cell there in 1940.

If the Canadians held that Norman never was a Communist, Morris continued, "not only would they be saying professor Wittfogel's testimony was false, they would be saying that this FBI information that has been delivered to the state department is, by the same token, false—which is entirely different."

Senator Watkins remarked that FBI information on such a matter comes from "humans," NOT from documents or circumstances alone, and therefore must be regarded "as hearsay evidence."

"But that is neither here nor there," the senator added. "We are not trying anybody in this type of proceeding."

This proposition of keeping a particular defender out of the lead keeps popping up all the time. The practical declarer must many times discard the so-called normal line of play in favour of one which avoids crossing swords with the more dangerous defender.

A simple illustration of this hand, where the South who played missed the point and lost the game.

Declarer was obviously conscious of the danger of permitting West to gain the lead, but he did not carry his precautions far enough. It's clear from the time dummy is at the table that not much prospect of making nine tricks unless the club suit is utilized.

All efforts to develop the suit must therefore be so shaped that any club donor West may have cannot serve as an entry to his established spades. If West has the Q-10 of clubs guarded, nothing can be done about it and defeat must be assumed.

Either of two plays should be made to guard against West having one club honor. A low club can be played at the first round of playing the eight if West plays a low club. Or, the king of clubs may first be led, followed by a low club toward the A-3, intending to finesse the nine if West follows small.

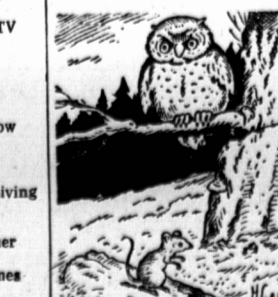
Both plays offer a tremendous chance of success, each better than the method chosen by South. West is a foeman who must be avoided at all costs.
