Russian Relief
Owing to the various activities on behalf of Russian famine relief considerable misunderstanding has apparently arisen concerning the precise character and extent of the operations of the Save the Children Fund. In order to dispel this misunderstanding, the following facts are issued by the Canadian Committee of the Save the Children Fund organization.
This organization is working in co-operation with the British Save the Children Fund, which is one of the relief organizations in Great Britain lately merged with two other organizations and unified under the general chairmanship of Sir Benjamin Robertson, K. C. M. G., the international authority on famine conditions in India. The two organizations referred to are the Russian Famine Relief Fund, under the chairmanship of Lord Emmott and with whom is associated Sir Arthur Stanley, Chairman of the British Red Cross Society and the Friends' Relief Mission (British Quaker Organization). This unification of relief forces followed on a visit of inspection to the famine area by Sir Benjamin Robertson in February of this year. This inspection was undertaken with the concurrence of the British Government, and on his return Sir Benjamin Robertson was requested to accept the chairmanship of the All-British Relief Committee and direct the administration of relief in the district of Saratov which was allotted to the British organizations.
The Save the Children Fund organization originally undertook the responsibility for feeding 250,000 children in Saratov. At the urgent request of Sir Benjamin Robertson the number has been increased to 300,000 children in view of the fact that the district was increasing. There are two and three-quarter million people in the district of Saratov where the British relief is operating, through the medium of feeding stations. The distribution of food in the famine area is supervised by British Russian-speaking officials of the fund.
Donations by the Canadian public are received through the medium of the churches, subscriptions through the press, banks, local committees, and direct contributions from the public. All money subscribed is spent on Canadian foodstuffs in Canada. The foodstuffs are shipped to the famine area via London and Riga. The foodstuffs therefore are under the supervision of Canadian and British officials right from Canada to the Children's food bowls.
With the exception of paid stenographic help no salary is paid to any officials of the fund. Their services are given freely to this humanitarian work of rescue. This applies also to the officials of the local committees. There are no expenses of this nature incurred. The Save the Children Fund is the only organization working with the approval and cooperation of

the Canadian Government. This co-operation is effected by means of office space, stationery, supplies at headquarters, and the transportation and freight charges on foodstuffs is shipped to the famine area. This co-operation is not extended to any other organization, nor is the Save the Children Fund Committee affiliated, associated or in any way connected with any other organization soliciting funds on behalf of Russian relief.



Proceedings in the Provincial Legislature
Election Act Passed With Amendments. Concluding Business of the Session.

May 2, Evening Session. (Continued.)

House in committee on Election Act. Clause 13 setting forth the qualifications for membership as Councillor or Assemblyman was considered.
Mr. Speaker Duffy said that to avoid any contention and out of respect to the Premier, who did not see eye-to-eye with other members, it was decided to withdraw the amendment that a Councillor or Assemblyman need not return to the country for election to executive office with salary. He believed, however, that the day would come when the government would regret that it had not been forward enough to make this change. He took objection to Section 3 which read as follows:
"13 (3) Nothing in this section shall render ineligible as aforesaid, any person holding a postmastership under the Post Office Department of the Dominion of Canada, whose salary and emoluments from such postmastership do not in the aggregate exceed the sum of one hundred dollars per annum."
This section, Mr. Duffy believed, might be struck out and provision made that nothing in the section shall render ineligible any member accepting the sessional allowance or indemnity paid to members of the Assembly.

Mr. Higgins did not think the clause regarding Post Masters should be cut out. There are some of good ability filling postmasterships at small salaries. Their children are often competent to do the work for weeks at a time, and there should not be anything to prevent him running for membership in the Legislature if he chose.
Mr. Saunders said there was nothing in the Act to prevent a postmaster running for the Legislature.
Premier Bell: We ought to specify that the receipt of \$500 as sessional allowance for members, and the receipt of \$1,000 or less by the executive, will not disqualify members from sitting or voting in the Assembly. If I don't see that it is absolutely necessary to do it, but I think that while we are at it we might as well do it.
Mr. Saunders: What about those gentlemen who have no desire to take the \$500?
Premier Bell: We will put it at less, then.
Hon. Mr. Hughes: We might disqualify them.
Premier Bell: The reason for putting it in is that we are making an Act which is subsequent to the Act of 1919, and as we are dealing with the matter now and can make it safe and beyond doubt, my suggestion is that we put it beyond doubt.

Hon. Mr. Hughes: There is a statute already passed providing for that amendment.
Mr. Higgins: My ruling was that when a statute was in force the committee could not deal with it, and I can't agree with the Premier that it is necessary to insert this provision.
The Chairman: It might be put in as an addition to Section 2.
Premier Bell: Well, I will move that nothing in this section shall render any person ineligible as aforesaid by reason of his being paid any annual allowance or indemnity of \$500 or any less sum or shall render—
Some hon. members: What's that for?
Premier Bell: That is to cover the member for York: "Or by reason of his being paid as Premier, Attorney-General, Commissioner of Public Works, Provincial Secretary, and annual salary of \$2,000 or any less sum."
Mr. Brodie: Why less? I haven't heard of any of them giving up part of their salaries yet. (Laughter.) Here's one fellow I don't just waste \$2,000 on him.
Premier Bell: Who is that?
Mr. Brodie: The Secretary-Treasurer in that office below.
Premier Bell: In what office?
Mr. Brodie: Down below.
Premier Bell: The Secretary is sitting right here by that post over there (pointing to Hon. Mr. Lea).
Mr. Brodie: I don't mean that one.
Premier Bell: Who do you mean?
Mr. Brodie: I mean the secretary down in Mr. Newbery's office—paying him \$2,000 of a salary? He doesn't need it anyway.
Premier Bell: We are not talking about him at all.
Mr. Speaker Duffy: Inadvertently, no doubt, the Premier has suggested that either himself or some members of the executive are going to reduce their salaries. It may be that this, like some of other diseases, is contagious. I may say that I have listened with a great deal of interest to the debate—I was in the chair and I was not in a position to leave it, and I would gather from the remarks of the hon. members that PERISH THE THOUGHT! It is the word that would be used by every member if there was any suggestion made to reduce the salaries of the executive because there has not been any objection raised about the ability and supreme fitness of every member of the executive for their respective posts; and I can't understand just why the hon. Premier should throw out this suggestion in the wording of his amendment. Every member has made it perfectly plain that HE earned more than he was getting! It would only be gratitude to suggest, therefore, an increase on these salaries rather than a reduction. It is really strange to think that the Premier should be the first to suggest a reduction in these salaries which are so well earned! We will admit that it shows a

great deal of self-denial in it. Self-denial seems to be the order of the day among some of the members of the Legislature, and it is apparently developing more and more all the time. If there was any active reason for self-sacrifice, I would have no objection to it, but I think you might provide in the amendment "that nothing shall render any member accepting the sessional indemnity ineligible for running for councillor or assemblyman."
Hon. Mr. Hughes: There is no provision for the members of the executive who have no portfolio. They are not paid for their services. Again, it must be remembered that the indemnity is not really an annual salary—there might be two or three sessions in the year. There are at least two members of the executive who do not get paid for their services.
Dr. D. C. McDonald withdrew his amendment to Section 21 (1) that the wife of every property holder holding property to the value of \$1,000 should have the second vote. He had no objection to the amendment to interfere with this Council vote means an amount of detail that it would not be possible to finish up. There is a statute here which says that in order to change the qualification for Council voters we must have a two-third vote of the Legislature, and that will mean endless argument. But I want it to be understood that this will be one of the first things that will be taken up next session. In the meantime I hope the little talk we had on the subject will set the women's ambitions for the Council vote. I know by the feeling of this House that it will carry when put to the motion.
Hon. Mr. Hughes also withdrew his amendment. "I believe mine was better than his, and I believe next session it will carry."
Mr. Stewart: The vote has never been put. Perhaps my hon. friends have lost courage. I am a little disappointed.
Mr. Dewar: I feel like pressing it on for the time it would take. I still believe in the principle of it, and I don't see that there is much objection to a two-thirds vote because when Mr. Peters put that into the Act in order to please the Councillors he must have known that it could never bind this Legislature.
Hon. Mr. Cox: I want to announce that I am not backing down. I am favorable to it, and I am very sorry my hon. friend has not pressed the point.
Mr. D. C. McDonald: I haven't backed down.
Hon. Mr. Cox: I know it would be all right. There is a two-thirds vote right here now. They are all here—except those that are not here. Anyway, I am not going to say any more than to say that I did not back down. (Laughter.)
Hon. Mr. Johnston: The motion cannot be withdrawn without full consent of the House.
Mr. Dennis: The amendment and the amendment to the amendment was withdrawn with the full consent of the House.
Hon. Mr. Johnston: Not according to these gentlemen.
Mr. Dennis: I presume it is still open for anyone to make another amendment and if so I will support it.
Mr. D. C. McDonald: I believe this motion would carry, but at the same time the statute says a two-thirds vote of the Legislature and it was put there for the purpose of safeguarding the Council vote, and therefore the question would immediately be raised. We have vacant seats, some of them representative of Council voters, and the question would be raised if the motion were legal. We intend to carry it next session. I resent the insinuation that I have backed down.
Mr. Metherell: I haven't backed down either, but I am quite willing to give way if it will not take too much time to decide the point.
Hon. Mr. Johnston: I take this point, and I would like to have a ruling on it. An amendment cannot be withdrawn without the full consent of the House.
Mr. McArthur: When the amendment was withdrawn there was no objection to it.
Hon. Mr. Johnston: Well, when they stand up one after another and say they don't recant, it doesn't look as if they were giving their consent to its withdrawal.
Mr. McArthur: They said why they were withdrawing the amendment.
Hon. Mr. Johnston: Well, they are very easily satisfied.
On motion of Premier Bell the following interpretation clause was added to the bill:
Section 249: In construing this Act, words importing the singular number only include male persons of the same kind and females as well as males, and the converse.
Hon. Mr. Johnston asked in the name of common sense what this meant. The whole Act, which was a very lengthy and important one, had been hastily rushed through the House, and he was afraid the House would have to take a grave responsibility in the matter. "We have had trouble already over the election law. And the very last thing, this absurd interpretation clause, is inserted. What does it mean, or was there any meaning to it?"
Premier Bell: It cannot be very absurd when it was copied from another Act.
Hon. Mr. Johnston: Many absurd things are put into Acts. There was a prohibition Act here—it must have been very absurd when the Supreme Court declared it ultra vires.
Hon. Mr. Lea: The whole Act was copied word for word from other Acts. Only the amendments were different, and they were carefully considered in committee.
Hon. Mr. Johnston: There has not been very much debate on them, anyway.
Mr. McArthur: The Attorney-General wasn't in the House when the debate was on.
Mr. Stewart: The mistake was made at the very beginning. If short amendments had been drawn up dealing with the new provisions we would have been able to discuss them more fully. We would have saved the time spent in reading over the long sections which we did not wish to change, and we would have had a better Act as a result.
Premier Bell: At any rate if there is anything wrong with the Act we will have a whole year to consider it.
Hon. Mr. Johnston: You will have to squash it like the Law Reform Bill.
The bill was agreed to with amendments and the House adjourned until 10 o'clock the following day.

May 3, Morning Session.
The House met at 11.20.
Mr. Stewart asked another question, what was the attitude of the Government with respect to the proposed soldiers' memorial.
Premier Bell replied that delegations representing the Associated Boards of Trade and the G. W. V. A. had visited the Government and requested a grant of \$15,000 towards the erection of a monument in memory of the soldiers who lost their lives in the war. The attitude which the Government took in the matter was this: They spoke of their sympathy towards the object, but they said that at the present time money was scarce. There was none in the provincial treasury to make the grant, and more than that, so far as present appearances were concerned, the difficulties instead of diminishing were increasing this year. Owing to the scarcity of money in the country and the difficulty of collecting taxes, there was no prospect of the financial conditions being better in the immediate future. This was the answer given by the Government to the delegation.
The following report, signed by five Liberal members of the Public Accounts Committee, was presented by the chairman, Mr. McArthur:

To the Honorable The Speaker and Members of the Legislative Assembly:
Your committee appointed to report on the Public Accounts for the year ending December 31st, 1921, beg leave to report as follows:
We have had several meetings of our committee and at these sittings carefully investigated the several questions that were under consideration. In regard to the insinuations and hints of irregularities against the Honorable Walter Lea (Commissioner of Agriculture) in connection with the purchase of ten pure bred Holstein cattle in Ontario in 1920, your committee held a thorough investigation. Proceeding who purchased the cattle in question, was asked to appear before the committee and his sworn testimony and the documentary evidence, proved conclusively that the ten head of cattle in question were shipped from Merrickville, Ont., September 19th, 1920, and arrived in Charlottetown September 22nd, 1920. A certified copy of the manifest was produced signed by Mr. McDonald, of the Freight Division of Charlottetown, giving every detail of the billing and also papers were produced showing that the ten cattle and fourteen sheep were received and taken delivery of at Charlottetown—there being absolutely no possibility of their being any stop-over, transfer or diversion of the car en route. Receipts were produced from C. E. Knapp, of Merrickville, Ont., Robt. J. Maley, of Oxford Mills, Ont., and W. H. Murphy, of Oxford Mills, Ont., showing that the sum of \$2,300.00 was received by these men for ten Holstein cattle. The pedigrees, certificates of transfer and

other papers of record produced give positive identification of these cattle. In view of the above mentioned facts, your committee come to no other conclusion than that the insinuations and hints of irregularities against the Honorable Walter Lea (Commissioner of Agriculture) are absolutely unfounded. Several other important matters were carefully gone into and found to be in order. We have given special attention to the Provincial and External Auditor's Report and find, as stated therein, a surplus for the year of \$2,030.12, and that the total liabilities of the Province (exclusive of highways debentures of \$125,000) is \$1,198,461.76, which is an actual decrease of liabilities since September 8, 1919, of \$101,346.31. We also find outstanding assets of \$91,678.89. Your committee find that the various departments have been carefully and economically administered with due regard to a proper Public Service and the finances of the Province in a healthy condition. arrived at the age of ten years. Whether they were justified in coming to this conclusion or not might be a matter perhaps of doubt.
Mr. Stewart said it was the deaf and dumb school that he referred to.
Premier Bell: My remarks will apply to both. It is not advisable to send children to any of these schools until they have arrived at an age when they can be reasonably expected to take advantage of the instruction. The sending of a child to that school involves a payment by this province of about \$400. Another question has arisen as to whether or not a child should be sent to the school who was only partially deaf or partially blind. There was nothing to determine this question. The point then came up as to how far the capabilities of the parent to educate the children should be considered. In cases where it was very clear that the parties making application for their return were perfectly able to send them to the school, the conclusion was arrived at that they should at least contribute to the expense a reasonable amount. The Government had no precedent to guide them in this question. A case arose where persons in Charlottetown applied in connection with the road and inquiries proved that they were able to pay their own way. The Government asked that they contribute either in whole or in part, and the parents offered to send the child to Halifax and pay for the teacher. The school, however, would not take the child un-
