CITES ARGUMENTS IN FAVOR OF FLUORIDATION OF WATER SUPPLY

Strong arguments were advanced in favor of fluoridation of the City Water supply by Dr. E. J. O'Meara, Director of Health, Department of Health and Welfare, in an address given before the Home and School Association of Queen Square School last night.

In support of his statements Dr. O'Meara quoted numerous resolutions of medical and dental associations in which they strongly endorsed the fluoridation of communal water supplies under proper supervision and safe guards.

In remarking on the present position in Charlottemont, Dr. O'Meara said, "As you probably know, the City Council, last August, voted against a resolution for fluoridation. This was perfectly understandable under the circumstances because at that time they did not have all the information to hand on this matter. It would have been wrong of them to recommend something of this importance unless they were perfectly certain that it was in the interests of the City to do so. What I have to say then is not intended as any criticism of their action but rather to give an explanation on those points about which they expressed some doubts."

Memorial Window To Be Dedicated At Zion Sunday

The dedication of the Memorial window to the late Rev. G. Carlyle Webster in Zion Presbyterian Church will take place on Sunday morning next, the service being conducted by the minister, Rev. W. H. Brown, M.A., and the sermon preached by Rev. Canon J. T. Ibbott, Rector of St. Paul's Anglican Church.

The Memorial is a beautifully designed window twenty-three feet high and eight feet wide, consisting of three panels with Christ at the center figure standing at the table and a disciple seated at each end. The theme of the scene is "The supper at Emmaus", and is captioned, "He was known of them in the breaking of bread."

At the base of the left panel there is an insert showing the two tablets of the law and on the right there is an open Bible. The centre insert is a crown with a cross and anchor. The inscription at the base of the inserts is "Which hope we have as an anchor of the soul."

The overall inscription reads "To the glory of God and in loving memory of the Reverend G. Carlyle Webster, Minister of this church, August 21, 1931 to March 22, 1953. Erected by the members and friends of the congregation."

The unveiling will be performed by Miss Margaret Webster, daughter of the late Mr. Webster.

The Investment Dealers' Association was formed in 1916. It is a regulatory body set up for the protection of the general public and the many investment dealer members from coast to coast. The Association has 211 offices across Canada who have affiliations with it.

"We deplore the operation of share pushers and stock racketeers" said Mr. Young, in an interview with a Guardian representative yesterday. He went on to say, "It is surprising how many people do not differentiate between the bona fide investment dealer and those who try to make a racket out of the business". He pointed out that information is available from any member of the Association to any investor no matter how small or large, absolutely free. He particularly mentioned a booklet issued for the purpose entitled, "How to Share in Canada's Growth".

Mr. Young made the observation that 80% of the invested capital in Canada's northern development projects is Canadian. He also noted that since the War one and a half billion dollars has been invested outside of Canada which goes to show that the country's economy is in a very healthy state. Speaking of "risk capital", Mr. Young said, "There is a place for such investment, but let it be presented to the public as "risk capital".

The Investment Dealers' Association is co-operating with the various colleges and universities in arranging a course of studies along investment lines. Today Mr. Young and Mr. Kingsmill will confer with Right Rev. R. V. MacKenzie, rector of St. Dunstan's University and Dr. Frank MacKinnon, principal of Prince of Wales College. They will also meet with Premier A. W. Matheson, Hon. Walter Dar-

by, Attorney General and Mr. P. S. Fielding, Deputy Provincial Secretary.
