found the fortunes of the day against him. The King's body was recognized by the British captives when released.—Theodore's two sons were taken prisoners, and all European prisoners set free. The interior of the fort of Magdala presented an extraordinary and splendid sight, the place was glowing with barbaric splendor. The British troops plundered it at once. The men found four Royal Crowns made of solid gold, twenty thousand in silver, thousands of silver plates, several lots very rich jewels, and a number of other articles of great value. Gen. Napier took by his victory the 28 large guns used against him, five thousand stand of small arms, ten thousand swords, ten thousand spears and many other articles of war.—The British captives will start for home on the 14th April. Gen. Napier's army will re-organize, fall in, and return to India and England at once.

LONDON, April 27.—The weather is delightfully favorable for the crops. The Abyssinian news imparts better feeling in financial circles, and money easier. Consols 94; Breadstuffs quiet; Corn declined to 38s.; other articles unchanged; provisions and produce steady.

LONDON, April 27, eve.—Great joy prevails throughout the nation on the glorious news from British troops in Abyssinia, and safety of Prince Alfred. To-day has been observed as a sort of impromptu holiday. At the stock exchange to-day national hymns were sung and enthusiastic cheers for the Queen given. The press and people everywhere exultant.—Still later advices have been received from Sydney, Australia, to-day, Farrell, who attempted to assassinate Prince Alfred, was indicted, found guilty, and sentenced to death.

LONDON, April 28, 2 A. M.—Both Houses of Parliament, without a dissenting voice, voted an address to the Queen, upon the recent attempt to assassinate Prince Alfred at Sydney, expressing the sympathy of the British nation with the Royal family in the untoward state which has filled them with sorrow, and the country with horror; and hope that the prince may soon be established to health.—The trial of the Fenians charged with the Clerkenwell explosion closed to-day. Barrett was convicted; all the others acquitted.—Consolidated; breadstuffs firm and unchanged.—Gold 139.

LONDON, April 30.—The trial of Burke, Shaw and Casey, for treason and felony, in being concerned in the Fenian attack on Chester Castle, was resumed in the Court of Queen's Bench yesterday. A Mr. Keylock, the proprietor of a gunshop in Birmingham, was sworn, and testified that he sold to Burke in December, 1865, a quantity of caps and pistols. He also swore that 500 rifles were bought by Burke of Mr. Hill, together with moulds for bullets, to the amount of two thousand pounds. Mr. Hill gave evidence concerning that of Keylock, stating that Burke represented to him that the arms purchased of witness were for use in South America. The trial will probably occupy several days.

LONDON, April 30, eve.—The trial of the Fenians Burke and Shaw has been concluded, and the former been sentenced to fifteen, and the latter to seven years imprisonment. Proceedings against Casey were discontinued.

MIDNIGHT.—In the House of Commons to-night, the debate on the Irish Church was continued. None of the leading members of either party took part in the discussion.

Spencer H. Walpole opposed the resolutions of Mr. Gladstone. In the course of his remarks he acknowledged that it would be unwise at this time to erect Established Churches in Ireland, but declared it would be a far more serious thing to destroy such an Establishment. All the arguments brought to bear in favor of such action were equally valid against the existence of an Established Church in England. He warned the House against the consequences which would follow the destruction of the Irish Church.

LONDON, April 27, eve.—The trial of the Fenians, Burke, Casey, and Shaw, commenced this morning in Court of Queen's Bench, Judge Bramwell presiding. The court room was crowded with spectators. Great interest is manifested in the trial. It is considered to exceed in importance the trial of the Clerkenwell prisoners.

LONDON, April 27, midnight.—In the House of Lords to-night, Lord Derby made a speech, in which he attacked the resolves of Mr. Gladstone on the Irish Church, and accused Lord Russell of vacillating opinion on that question. Lord Russell replied; said he was amazed to see Lord Derby opening his question in the House of Lords while it was pending in the Lower House. He declared with earnestness that the peace of Ireland was the aim of his life. He defended his course on the question, saying that inconsistency in means was not incompatible with consistency in the end sought. He acknowledged he preferred his own plan for the solution of the difficulties in Ireland, but he accepted the plan of Mr. Gladstone as the most practicable under the circumstances. If the resolves pass the House he should submit an appropriate bill. He would be sustained by the House of Commons and by the public opinion of the country, and would without doubt, command the assent of the House of Lords. He expressed the hope that the Ministry would not attempt to influence the crown adversely to the House of Commons, as a collision between the crown and House of Commons would be deplorable.

In the House of Commons Mr. Disraeli, in reply to a question from the opposition benches, said the Ministry wished for the fullest discussion of the Irish question. Mr. Gladstone hoped the debate would not delay the business of the House, and in that light he deplored the time wasted last night in party recriminations.

It is supposed that in consequence of Mr. Disraeli's defeat on the Irish Church question, the present Parliament will be dissolved and the country tested on the matter. In that case, we feel morally certain that the Premier will sustain a more significant defeat than he has in the House of Commons.

It is reported in Halifax that the Hon. Mr. Howe is to succeed the late Sir Domnick Daly in the Governorship of South Australia. It is also reported that the case of Nova Scotia, in the matter of Repeal, is to be referred to a Royal Commission for investigation and settlement.

The Easter Term of the Supreme Court commenced yesterday—their Lordships Chief Justice Hodgson and Judge Peters presiding. There appears to be a good deal of business on hand—that is judging from the number of Lawyers in attendance.

The Steamer Princess of Wales, on Monday last, made the trip from Picton to Charlotteville in 3h. 49 minutes. The Boat is in excellent condition, and under command of Capt. Evans, is a favorite with the travel-lag public.

We see it stated in the Ottawa papers that the Dominion Parliament will not be prorogued before some time in June, in consequence of the large amount of business yet to be disposed of.

Mr. Langevin was made a C. B., and not a K. C. B., as first announced. Mr. Carier is created a baronet, which puts him a step above Sir John A. McDonald, whose title is for life only.

In the House of Commons, a few days ago, Sir John A. McDonald announced that it was the intention of the Government to establish a Court of Appeal for the Dominion.

The impeachment of President Johnson closed on the 2nd instant, and a decision will be arrived at to-day.

Last evening the new building was lit up with gas from the basement to the attic, and presented a very fine appearance.—Herald Reporter.

We would not be at all surprised to hear the report confirmed that the British Government has conferred a Governorship on the Hon. Joseph Howe. It is stated that one of the Australasian Colonies, lately presided over by a distinguished Colonial statesman now deceased, will be tendered to Mr. Howe. We have no doubt that Mr. Tupper, who is at present in England and who in company with Mr. Howe passed a few days at the residence of the Duke of Buckingham, will use his influence in favor of Mr. Howe. The appointment would be satisfactory to all parties in this Province.—Herald.

We are sorry to learn that Mr. Andrew Downs, so well and favorably known not only to our citizens, but to many abroad who have visited Halifax, is about to leave us. We understand that he has accepted an appointment of the Commissioners of the Central Park in New York to take charge of the Zoological Gardens about to be established there, at a salary of \$3,000 per annum. QUEEN'S COUNTY Volunteer Rifle Association. AT the Council Meeting of the above Society, held in the Court Room, Colonial Building, Charlottetown, on Thursday last, the following arrangements were decided upon for a Shooting Match, to take place in the beginning of July next. The President, Colonel the Honorable John Hamilton Gray, presiding. The first regular Shooting Match of the Association, is to commence on Monday, 6th of July next, 1868, to be held at the new Rifle Range, Kensington, Charlottetown Royalty. A SILVER MEDAL is to be forthwith ordered from England, by the Association, and that, together with the sum of \$50 will constitute the first prize. The Medal will be the absolute property of the Winner. There are fifteen prizes to be competed for, the first five beginning as follows:— 1st Prize, The Association Medal and \$50 2d Prize, 30 3d Prize, 20 4th Prize, 16 5th Prize, 12 The remaining Prizes will be of the same amount, \$10 or \$5 each, according to the amount of funds in hand on the day of competition. At least \$200 will be expended in prizes. The ranges are 200, 400 and 600 yards. Five shots to be fired at each range, and in case of ties, one shot at the last range to decide. All competitors must appear in the Uniforms of their respective Companies. There will be an All-Comer's Match, after the regular match is decided, particulars of which will be made known hereafter.
