THE CORRECTOR CORRECTED.

The Grit organ seems to exist for two simple purposes: firstly, to overwhelm the representative men of its party, from Sir Louis Davies down to Mr. D. A. McKinnon or Mr. D. P. Irving, with the most nauseous and fulsome flattery; secondly, to snarl and snap at THE EXAMINER. If the blarneying of Sir Knight and his relatives is doing these gentlemen as little good as the abuse of THE EXAMINER is doing us harm, a deal of labour is being expended for nothing.

Last week, after THE WEEKLY EXAMINER was sent to the mails, we noticed that some extracts we had made from the Railway laws of Canada did not bear on railways constructed by the Government. This fact was observed before the article dealing with the subject appeared in the Daily—except in the case of a few copies that were inadvertently printed—and of course we struck out the irrelevant extracts. The action we took was just such as any honest journal would pursue, under similar circumstances.

But THE Patriot, acting under the fond delusion that its time had come to score a successful point against THE EXAMINER, charges us with a deliberate attempt to mislead the people, coupled with such epithets as "fraud," "garbling," "deception," and "crime." Before discharging this volley of expletives, THE Patriot writer showed that he knew THE EXAMINER was not guilty of any intentional misrepresentation. Here is what he said:

"The Smart Alec that quoted from the Railway Act did not seem to know that the statute only applied to railways built by private corporations."

Therefore the charges of "fraud," "deception," "crime" and "garbling" were made while the accuser knew that, at the worst, it was only an honest mistake. We leave the public to judge between us in this matter.

Now, we shall deal with THE Patriot's knowledge of law. THE Patriot says:

"Knowing that the building of the Belfast and Murray Harbor railway was a work under the Government Railways Act of 1881, we have turned up that statute and had as follows:"

Then come extracts from section 5, of the above Act.

What will the public say when we tell them that the Act of 1881 is not now in force, and that a part of sub-section 15 of section 5, which THE Patriot quotes, was not inserted in the Consolidated Act of 1886 which supersedes the Act of 1881!

If THE EXAMINER were built like THE Patriot, there would be our chance for charging "fraud," "deception," "crime," etc.

But the bearing of the law on the question of rights of way is only a side issue. The main point must not be lost sight of. Why was Supt. Sharp sent to Lot 48, etc., to negotiate for rights of way in the midst of this election contest, while everybody knows that the land will not be required until spring, if at all? Ordinarily those having to do with Governments know that there is much delay in effecting settlements. The plans, etc., on which tenders are to be based will not be ready until

(the 27th inst. The time for receiving tenders extends until the 18th of December, and then the department does not bind itself to accept any tender. There is not the slightest possibility of any grading or other work being done this winter. Mr. Sharp was not sent out on this errand, at this time, from business considerations; and it is more than likely that in the extreme haste employed, the locations, descriptions, titles, etc., of the lands affected were not sufficiently examined to enable him to do accurate work.

This dickering with the land owners is intended for nothing else than to influence the election; and if the Minister of Railways ordered the negotiations, we are furnished with fresh evidence of the public character of Mr. Blair.

THE ASYLUM CONTRACT.

Mr. WALTER LOWE's letter, published in another column, corrects one of the many misrepresentations set afloat by Government canvassers in Belfast and Murray Harbor. A settlement of the asylum contract matter has not been effected. The Government will not permit Mr. Lowe to go on and do the extra work required upon the conditions set forth in the contract. They will not allow Mr. Lowe to sue for the heavy damages sustained by him as a result of their stupid inaction. They will not do anything towards affording to Mr. Lowe the justice that is his due or relieving the pent up and uncomfortable conditions of the unfortunates confined at Falconwood Asylum. Their ability as men of business consists in letting the building materials placed upon the ground by Mr. Lowe go to destruction and forcing the poor lunatics to pass yet another winter under such conditions as have been described before the Asylum commission and in THE EXAMINER. They are able to let contracts for supplies so that the public money will flow into the pockets of their unscrupulous supporters; they can manage to make just a sufficient number of perfunctory visits to the asylum to enable them to draw their allowance as trustees; they can be so careless as know to nothing whatever about the cold which the patients have suffered or the bad food that has been supplied; they knew enough to punish with instant dismissal the attendant who made a formal complaint and set forth the facts,—but they can't and they won't settle with Mr. Walter Lowe or take the first step, practically, towards the enlargement of the asylum which is the first essential in the reform that is demanded. Altogether their conduct in regard to the asylum has been disgraceful and scandalous. Can the electors of Belfast and Murray Harbor endorse and confirm with their votes the neglect and incapacity exhibited by the government in regard to the asylum? They can, and they will, if they vote for the government candidates—Irving and McKinnon.

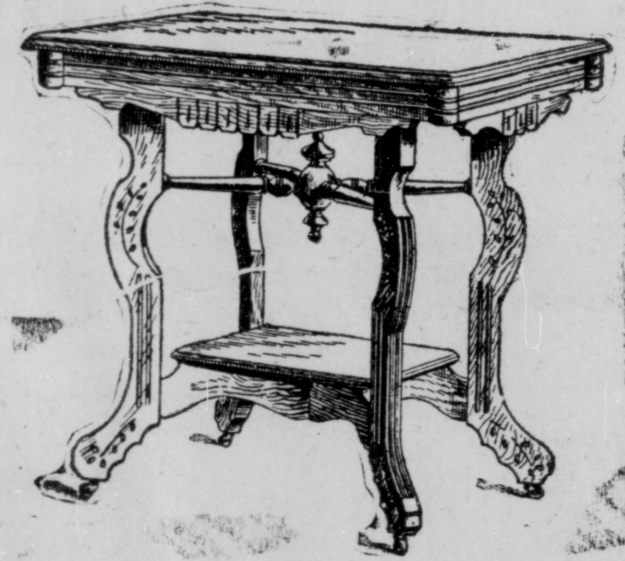
