

armed countries of the Confederation in the struggle which she will have to maintain against Russia.

The Times Paris correspondent writes—Independently of the treaty of the 3rd of December, between England and France and Austria, there exists, it appears, a document between the same powers to this effect: First, If within twenty days Russia does not accept the propositions of Austria, the power will enter into diplomatic relations with her. This condition will, as previously mentioned, have been executed by this. Second, In case the refusal to accept these relations with her, in the event of Russia still refusing to accede to the same, the other states of Europe, inviting them to co-operate. And, thirdly, A notification will be made to Prussia, declaring that she will not be admitted to future negotiations for peace, except on condition that she will accept the propositions adopted by the three powers; that she will formally announce the same to Russia, and, in the event of Russia still refusing to accede to all diplomatic relations with her, and recall her ambassador. I cannot inform you, what measures will be taken with respect to Prussia, in case the refusal to accept these conditions, but it is certain that her position will be one of the most critical kind. Some time since, France and England requested Denmark to send a fleet to assist in the operations of procuring provisions, in two of her ports. Denmark positively refused. A note I am told, has been transmitted to the Danish Government on the subject, and in terms, not merely energetic, but menacing—with what effect, remains to be seen.
