THE GOVERNMENT ON TRIAL.

WHEN counsel in an ordinary trial drag in outside issues, indulge in ad captandem statements, call their opponents liars, hypocrites, blackguards and slanderers and brag that they are sure to win, it may be taken for granted that they have a bad case. It is, of course, but natural for the prosecutors to make statements which the defence believe to be untrue. But if the defence be a good one, the attorneys will quietly and in moderate language, point out the flaws in the indictment and bring forward proofs to substantiate their statements, leaving the jury to weigh the evidence between the parties.

THE DEBENTURE MATTER.

THE matter which most deeply excited Mr. H. H. Davies last evening was that of an alleged discrepancy of \$806.09 in the statements of the Government and the Committee of Public Accounts respecting the sale of debentures. Mr. L. H. Davies imagined a charge of theft against Messrs. Peters and Kickham, and was greatly indignant and rightly so. It is needless to say that no such ridiculous charge has been made. If there is anything in the charge the matter can easily be explained. But Mr. Davies did not explain. The Government certainly did submit statements showing that the discount from the debentures amounted to \$6,310.00, and the expenditure in connection with the issue and sale of the debentures to \$258.15, making a total of \$6,568.15. The Committee of Public Accounts did, as certainly, state in their report that "the cost of printing, discounting and negotiating" the debentures was \$7,374.24. There is, evidently, here, a difference of \$806.09. Mr. Peters stated in the House that no brokerage was paid. Mr. Davies stated last night that the Premier "didn't pay one dollar of commission to any broker or any one else." Then, where was the money gone? Mr. Davies did not explain. But he wavered wretchedly because some anonymous writer had insinuated that it went into the pockets of the negotiators. There was no suggestion of theft; on the contrary, it was suggested that the negotiators had paid themselves for what they did, as they were clearly entitled to do, though not at this excessive rate. The matter is one about which an explanation is demanded. It is not sufficient for Mr. L. H. Davies to charge an anonymous writer with slander, and to declare that he would be sent to the penitentiary if he were known.

HOW MUCH DID HE RECEIVE?

FOR expressing the opinion that Mr. L. H. Davies was paid \$30 or \$40 per day as assistant counsel in the McPhee-Shaw perjury case, THE EXAMINER was last evening advised by Mr. Davies not to "lie so egregiously." Mr. Davies did not say how much he really did receive from the Government for that unsuccessful service; but he left it to be inferred that he had rated him at a higher figure than he ought to be rated. If Mr. Davies be a cheaper lawyer than we supposed, we regret the expression of our opinion. But anyone can see that THE EXAMINER is not, as Mr. Davies charged, guilty of "a delicate lie" in this regard. Of course we cannot say exactly how much Mr. Davies actually received, whether \$25 per day or \$35, or \$50; and we did not pretend to do so, though we estimated it at \$30 or \$40. It is too much to expect that Mr. Davies will now say how much he received. Mr. Peters "went to the country" at this juncture, rather than a month or so later, in order that all his financial transactions of this year may be kept in the dark till after the election. Therefore Mr. Davies will be silent about his cost fees. But the people, all those who speak for them, are at that account justified in forming their opinions from such data as are available.

AN EXPLANATION.

THE omission from THE EXAMINER of news respecting the Winnipeg election is easily explained. The news was placed in our printers hands on the morning of the day on which it appeared in the Guardian and Patriot. But in the press of matter incident to an election campaign here, it was, without the knowledge of the editor, crowded out of that day's issue. Having been published to the city by the two dailies named, the news would have been stale for next day's issue; and so we held it over for THE WEEKLY EXAMINER. We regret the omission goes without saying. It is not the habit of THE EXAMINER to pass by any news of interest. It will be admitted that the great contest going on here is of much more importance to our people than the election in Winnipeg. But Mr. Davies had to try to divert attention away from the charges made against the Peters Administration, and so he vigorously advertised THE EXAMINER's lapse to the citizens and evaded the disfranchisement of officials, the gerrymander, the mortgage vote, and other matters involved in the issue before the people.

GREAT MEETING AT DUNDAS.

James E. Macdonald and Cyrus Shaw, Esqs., Unanimously Nominated for Cardigan District.

Hon. D. Gordon and Archd. J. Macdonald, Esq., Nominated for Georgetown District.

No Government Candidates Proposed.

THE Court House at Dundas was packed to the utmost on Monday night, and many stood outside at the windows, which were opened, notwithstanding the cold, so that as many as possible should hear the candidates for Cardigan and Georgetown expressing their views. Among these present we noticed Hon. D. Gordon, Archd. J. Macdonald and Mal. McDonald, Georgetown, John McLean, M. P., Fredk. Morrow, Archd. Currie, The Kickham, Jas. Hughes, Samrict, Dr. Robertson, H. H. Beer, Daniel McDonald, Montague, Jas. E. Macdonald, J. J. Campbell, J. G. Scrimgeour, J. Sigworth, M. Casey and others for Cardigan Bridge, and the Kickham, Perth, E. Robertson, Farmington, D. Lawson, St. Peter; besides a great many from Dundas, Narrows Creek, Annandale and Lot 58.

Mr. John A. Cameron was appointed chairman, and Mr. Currie secretary. The chairman opened the meeting in a suitable manner and called on Hon. Mr. Gordon, who made a short, yet forcible address, showing why the Peters government should forfeit the confidence of the electors. He referred to the gerrymander of King's County, and expressed the satisfaction he felt at the success that Mr. Macdonald and himself had met throughout the canvass. Mal. McDonald, Esq., Georgetown, was next called upon, and occupied the platform for a brief period. He said that the present Government, when they came into power were the same as the Peters, left by their predecessors, and he approved of the way the Peters' government had met the difficulty. Issuing debentures at a low rate of interest, with provision for a sinking fund, so that the interest and principal should be paid at the end of a term of years was the best means for providing for a debt of that kind. He then showed that the Government had an indebtedness of more than 102,900; but both branches of the Legislature by which some \$5000 a year would be saved. Referring to the gerrymander, he said it was not fair that 200 electors in Georgetown should have the same privilege of electing two representatives as 900 or 1000 in country districts. He contended that the Dominion officials should be disfranchised as it was the law in the other provinces. He endorsed all the measures passed by the present Government, especially the reduction of the Legislature. There was too much expense for legislation and the reduction should be carried further. Fearing that the nature of the industry of this Province, and although farmers' interests had been neglected in the past, if he would not sacrifice their interests, but would do the best he could to save them. He proposed that only be obtained from a Liberal Government.

James E. Macdonald, Esq., the next speaker, said that he considered the financial question was the most important one at the present time. The public accounts show that we have an expenditure of about \$283,000 a year, with a probable income of not more than \$291,000. The Land Office, which yielded over \$70,000 in 1891, only collected \$43,000 in 1892, and this year the receipts will be little over \$20,000. There will be a probable deficit this year of \$109,000, and that with the indebtedness up to the end of 1892 will amount \$300,000 that must be paid by the people of this Province. How this money was to be paid was the great question for the people. Every candidate should be prepared to supplement the revenue, so that the expenditure should be met without deficits. This only can be accomplished by curtailing all unnecessary expenses and by a fair system of taxation.

Hon. Thomas Kickham followed, and as he is a member of the Peters Government, it was expected that he would be prepared to defend and justify the acts of the Administration. He said that the present Government had many difficulties to contend with on assuming the reins of power. The chief difficulty was the large debt left by their predecessors, and he commended the able financial management of Premier Peters. If they had imposed taxation, the people would naturally and properly object to it, and they had borrowed money to pay off the liabilities of the Province and obtained it at less expense than some of the other provinces. He claimed support because he was a farmer, as anything that would be a disadvantage to other farmers would be an injury to him. He referred to the late Government collecting taxes for three years although they promised to repeal the assessment act. He showed that the late Government had deficits, notwithstanding they had secured many windfalls from Ottawa. They had also drawn \$200,000 from capital and had paid \$32,000 between 1883 and 1889 for interest, without providing any sinking fund. The Land Office had been badly managed by the late Government, and they had to call in two gentlemen to audit the books, to find out who had robbed it of \$300,000, and this cost \$500,000 in the long run. He thought there had been allowed to run out of date, although in some cases precepts had been issued, and heavy expenses incurred, which the farmers had to pay.

The present Government had offered a liberal discount to the people who paid for their land, and the farmers got the benefit of it, although the Opposition say that it was the resources of the country. The Opposition complain about the expenditure on the roads and bridge; but he thought it better to spend money in this way, than to spend \$10,000 for consolidating the laws. He thought there had been more money wasted on jobs by the late Government than by the present administration. The extra expenditure this year was to give poor people who longed for last spring a chance to pay for it. He referred to some cases where money had been spent by the late Government, such as the bridge at Morell, where no right of way had been secured, and also the extra expenditure on St. Peter's Bay Bridge. No engineer would say that the Morell floating bridge had cost too much. After referring to Dominion politics, the Hon. gentleman took his seat; and the Opposition expressed their disapproval of the confidence reposed in him. After describing the claims that led to the defeat of the Peters Administration, he showed that the first act of the Peters administration was to pass a bill authorizing them to sell \$150,000 worth of debentures. He had opposed that measure as it was shown by a return laid on the table of the House on the 7th July, 1891, that the province owed the banks only \$57,000 that he had no objection to the Peters government passing the Debiture Act. If this Province had large tracts of land to open upon for settlement, or had other industries that required fostering, no such objection would be made to the imposing of a permanent debt on the country; but he contended that there was

necessity at that time to the Bill. Besides, the Government had shown the great incapacity in disposing of the debentures. They had issued no prospectus showing the desirability of the investment, and had taken no means, excepting a few advertisements in the papers, to draw the attention of capitalists. These debentures were sold at 96 or 4 per cent. below par, whilst debentures of the Water Works Commissioners of the City of Charlottetown, bearing the same rate of interest, had been sold at the same time at par. By the public accounts \$6,310 had been lost as discount on the sale of the \$158,000 of debentures that had been disposed of up to the end of 1892, and the Minister of the Government had refused to say who received the interest on the debentures, it was highly probable that Peters and Peters had pocketed the discount themselves, as they were sure to be very wealthy. Mr. Peters and Mr. Kickham went in a special car that cost the country \$46 to Georgetown on Sunday, and from thence to Halifax on the following Monday morning, and when they had Mr. Macintosh, the broker, the debenture, with one hand, with the other they gave him the money to pay for them. Besides the loss of \$6,310 for discount, we had a further loss of the public accounts committee in the House of Assembly in 1893 that the whole expense of negotiating the debentures was \$7,374. By a return brought down last session, it was shown that the printing and advertising cost \$258.15, so that there is the sum of \$806.09 unaccounted for. "Mr. Kickham should tell the meeting what has become of that money. If he has it in his pocket, let him place it on the table of this Court House, or if not, let him tell what became of it, before asking the people of Cardigan District to vote for him." Mr. Kickham finds fault with the cost of consolidating the statutes, but should not be forgotten that Mr. Yevo, the former leader of his party, had repeatedly demanded that this work should be done, and the Commissioners had worked for over three years in performing this onerous task imposed on them. The consolidating of the statutes would have law expenses to the people, for during the thirty years since the statutes were revised by W. H. Pope and E. J. Power, many changes and amendments had been made; and it was almost impossible to tell how the law was without consulting lawyers, and that is usually very costly work.

The United States Tariff Will Be a High One.

OTTAWA, Nov. 29. The Minister of Finance has stated that if the proposed United States' tariff passes in its present shape duties will still be higher, taken all around, than the present Canadian tariff. Mr. Foster stated that the Canadian tariff revision measure would be ready early in the session.

The N. Y. Herald on the Tariff.

NEW YORK, Nov. 29. The Herald says of the tariff bill: "While it is impossible to frame a tariff which would be acceptable to all interests, the principles on which this measure is framed are sound, and in the main have been justly applied." The Press says: "The bill will exterminate many forms of industry; cripple others; force down wages of workmen and enlarge imports beyond all precedent." In the main the bill justifies the claim that the committee has gone straight on as if the wishes of the people of the nation deserve no attention. It is distinctly a measure for the benefit of other countries.

The Murder of Reid, the Dynamiter.

DUBLIN, Nov. 29. The police have obtained evidence connecting members with the murder of Reid. The dynamiters doubted Reid's fidelity, and asked him to go to America, giving him 47 to leave. He refused, and a quarrel ensued, resulting in Reid's murder.

A Carpet Mill to Shut Down.

BOSTON, Nov. 29. The Roxbury Carpet Company will shut down on Wednesday for an indefinite period, thereby throwing 300 employees out of work. The corporation think it advisable to close the works until tariff matters are settled.

A Terrible Fire.

PITTSBURG, Pa., Nov. 29. A fire in Shields' restaurant, O. 1 City, destroyed a whole block. The loss is estimated at \$1,000,000. Mrs. Hugh Shields and three of her children perished in the flames.

Lost on Her First Trip.

LONDON, Nov. 29. The new British steamer, Sir John Hawkins, 1728 tons, foundered November 25th, on her first voyage from Plymouth to Manople. Crew drowned.

Boy Drowned at Sackville.

MOSCOW, Nov. 29. Freddie McCannel, 8 years old, while skating on Morris Lake, Sackville, slipped into an open place and was drowned.
