Ottawa Journal: Sir Thomas Lipton did not get the America's cup, but he evidently made a record in winning America's liking, and that is a still better thing for all countries concerned.

Montreal Gazette: President Kruger was not without some ground of confidence when, in his ultimatum, he ordered the British out of South Africa. He has an equipment of artillery and machine guns of the most improved type, that he could hardly have secured in the months during which he was negotiating with Mr. Chamberlain. The events in Natal, as well as the swiftness with which the Orange Free State proceeded to take up the Transvaal's cause, will strengthen the belief that the war was one of the things that had to come, because Mr. Kruger wanted it.

SUPREME COURT.

The Michaelmas Term of the Supreme Court opened this forenoon, the Chief Justice and Mr. Justice Fitzgerald on the bench.

The Prothonotary read the Commission under the Great Seal of Prince Edward Island appointing Donald A. McKinnon Attorney-General of Prince Edward Island. Mr. Harry R. McKenzie, an attorney of this court, was, on motion of Mr. Stewart, Q. C., called to the bar.

Mr. Anbin E. Arsenault, was, on motion of Mr. Hazard, Q. C., called to the bar.

The Queen vs. James A. McIntyre—Mr. A. Peters, Q. C., on behalf of Joseph Wise and James B. McIntyre, (bail for the appearance of James A. McIntyre to stand his trial Trinity Term 1900 who made default) moved that the amount for which they were liable be remitted or reduced. Court refused the motion.

Mr. Peters made a like application on behalf of Allen McEachern, one of the bails for Francis Murphy who was sent up for forgery but it was refused.

Susannah Ferguson, Appellant, and Jessie Hogg, Respondent—This case, which is still before the Court, is an appeal from the judgment of H. James Palmer, Superintendent Magistrate for Queen's County—whereby appellant was fined \$2. The cause of action was an assault alleged to have been made by Susannah Ferguson, the appellant upon Mary Bird, one of the Middlemore children, who was adopted by the Appellant, Mrs. Hogg, who is the agent for this province for the home from which these children came, was the prosecutor in the court below. Stewart, Q. C., for appellant, McKinnon, Attorney-General, for Respondent.

At the conclusion of this case the court will, owing to the illness of Mr. Justice Hodgson, adjourn till Tuesday, 21st November inst.

NOTES AND COMMENTS.

—Those locomotives for the Belfast and Murray Harbor Railway are first-class engines—on paper.

—Sir Louis Davies has been interesting himself in the matter of a direct steamer since his return to Charlottetown. Yesterday afternoon, after conferring with the Council of the Board of Trade, he telegraphed to the Eder-Dempster Company asking that the Lake Huron call here on her way from Montreal to Liverpool, or failing this that another steamer of the Line call here at the earliest possible date this fall. As soon as a reply has been received to the telegram a meeting of the Council of the Board of Trade will be called to take the matter into consideration.

—Le Soleil (Sir Wilfrid's Quebec organ) thinks that perhaps, after all said and done, it is as well that the contingent was allowed to go. True, there is the expense of transportation and equipment, "but what is that in comparison with what we shall get from the gratitude of England?" Already orders have been received for 800,000 six pound tins of canned meat, and all the hay Canadian farmers have to dispose of. If the war goes on a little longer what enormous orders for butter, cheese, potatoes to feed the English soldiers in Africa shall we not receive? As may be seen, it will have been extremely profitable for us to have done our duty, and to have remained true to the flag that shelters us. It is a wonder Mr. Tarte did not think of this. He usually takes a financial view of public questions.
