King seven diamonds and therefore bid it. West led a spade. Declarer ruffed in dummy, cashed the ace of diamonds, and then overtook the queen with the king. He now led the eight of clubs planning to let the club suit fall into line. It seemed likely on the bidding that East was void of clubs. But West covered the eight with the ten. Declarer finessed the king, cashed the ace, and ruffed a heart. West covered the six of clubs. West overplayed with the seven, and after 13 a queen in dummy had won, South returned to his hand with a heart ruff and led the nine of clubs. British Army Said Stretched Beyond Limit

LONDON (Reuters) — The problem of manpower shortages in Britain's army could be eased by Commonwealth participation in the defence of Southeast Asia and by Canadian acceptance of responsibility for the Caribbean area, according to a booklet issued here by the Army League.

Introducing the booklet, the Army League's chief executive, Richard Gale, former deputy supreme commander in Europe, said the British army is too small for the tasks it has to perform.

"Since the war the British army has been continuously on active service in Palestine, Cyprus, Malaya and now, as well as some of the emerging African countries. All this time it was stretched to the limit—and in many cases beyond the limit," he said.

Among the booklet's conclusions was that Britain's base in Aden should be maintained at all costs. It said, if it became

impracticable to keep a base in Malaysia or Singapore, the northern territories of Australia would provide an alternative. Garrisons such as those at Gibraltar, Cyprus and Hong Kong would still be required as they provided a deterrent to "hotbeds."
