The Democratic plan, offered by Senator John McClellan (Dem Ark.), would limit questioning of further witnesses to one hour for each senator and four hours for each of the opposing sides.

Senator Everett Dirksen (Rep Ill.) came up with the other cut-short plan. It calls for Stevens to leave the stand at once, for McCarthy to testify next and for the public hearings to recess as soon as the Republican senator leaves the stand.

He told how a delegation seeking assistance from the Federal Department of Agriculture had been told that if they would organize under the federal plan the department would help them out when aid would be needed. In June, 1953, when prospects for potato prices were discouraging a delegation from the board went to Ottawa and succeeded in having an agreement signed with the Federal Department of Agriculture and this plan had gained for the farmers the pool prices of from 45 to 55 cents per bushel instead of the market prices of 10 to 20 cents which would have been the selling price of the crop.

Mr. MacDonald also told how the Marketing Board had fought to have a one price shipping zone and had succeeded and have this year farmers in all parts of the island receiving the same price for potatoes while in former years the growers in West Prince and East Kings had received 10 to 20 cents per bag less.

He urged the growers to vote in the coming plebiscite according to their beliefs and stated that if the growers did not wish to have him as the head of the selling agency he did not wish to be there.

The question and answer period then followed and this proved to be very interesting under the capable chairmanship of Mr. Roland MacDonald. SUMMERSIDE TOWN EMPLOYEES TO GO ON FAST TIME FROM MAY 16

About 20 Summerside citizens interested in observing the Town Council in session attended the regular monthly meeting of the council last evening.

The meeting was presided over by Mayor Henry Wedge and all council members were present.

After lengthy discussion in which all councillors expressed approval of earlier opening and closing hours during the summer months, the following resolution moved by Councillors William Jenkins and seconded by Councillor Andrew Perry was unanimously approved:

"Resolved that for the benefit of the employees of the Town of Summerside, the town offices and all town departments will open one hour earlier and close one hour later than at present from midnight, May 16th, 1954 to midnight, September 26th, 1954, and further resolved that this apply also to regular monthly meetings of the Town of Summerside."

In whose Mayor Wedge described as "an awkward situation," he said it is not the intention of the council to break the provincial law in regard to "standard time," but, he said, this change in working time for town employees was being made in accordance with the majority wish of all concerned.

Express Opinion - On motion of Councillor Donald Lidstone, seconded by Councillor Jenkins, the citizens present were invited to express their opinions on the matter of so-called daylight saving time.

With a good cross section of merchants, business and professional men present, strong approval of adopting earlier opening and closing hours was heard by the several speakers taking part in the discussion, and it was suggested that while daylight saving time, as such, could not legally be adopted, several business firms intended to achieve the same effect by altering their present hours of business for the summer months.

Previous to any discussion on the matter, a letter from the Summerside Board of Trade was read which took the form of a resolution which had been passed at the last meeting of the Summerside Board of Trade requesting the Town Council to adopt a system of "radio time" similar to that approved by the Charlottetown Council.

The purchase of a power lawn mower for the use of the parks committee was approved, and the Ladies Aid of the Prince County Hospital were granted permission to hold a tag day on July 8th, 9th, and 10th.

Mayor Wedge expressed the pleasure of the council in having the large number of citizens present at the meeting and expressed the hope that citizens would continue to attend the council meetings and make council members aware of their opinions on municipal matters.

Water and sewerage extensions were approved for Maple Avenue, Coronation Avenue, and Lidstone Street.

Councillor MacDougall announced that the use of the auxiliary dump by the shore beside the west end of Water Street would be discontinued after May 24th, and Mayor Wedge suggested that the road to town dump should be made serviceable for use the year round.

The matter of streets and sidewalks came in for considerable discussion following which a resolution was approved that tenders be called for re-laying of asphalt paving on the following streets: Ottawa, Russell, Granville, Summer, Willow Ave., Poplar Ave., Cedar Street North, Cedar Ave., Market Street, Calhoun, and Water Street West.

New sidewalks are also to be laid during the present year on Victoria Road from Granville Street to the waterfront.

POTATO GROWERS DISCUSS PROBLEMS AT TIGNISH MEETING LAST NIGHT

At the first in a series of meetings sponsored by the Prince Edward Island Federation of Agriculture about 150 potato growers met last night in the parish hall Tignish, to discuss problems facing the industry.

Mr. John Wallace, Elmsdale, president of the Prince County Federation of Agriculture called the meeting to order and introduced the visiting speakers. After a short address in which he outlined the organization of the Potato Marketing Board he called upon Mr. Roland MacDonald, Southport, president of the P. E. I. Federation of Agriculture to preside.

Mr. MacDonald in his opening remarks told how without the Federation of Agriculture there never would have been a Potato Marketing Board and consequently the federal treasury would never have been forthcoming to aid in holding potatoes up to the pool prices of 45 to 55 cents per bushel.

The president then called upon Mr. Lincoln Dewar, secretary of the Federation to describe the accident insurance scheme sponsored by the Federation which for a premium of \$5.00 benefits of up to \$100,000 could be collected by the beneficiary.

Mr. Dewar also described other benefits gained for the farmers through the efforts of the Federation such as the support price under butter and freight assistance on feed grains which amounts to 60 cents per cwt. He urged the farmers to continue to support this organization if they wish to receive further benefits from its work.

Conference Hears

The Vietnam is ready to authorize evacuation of seriously wounded prisoners from Dien Bien Phu, overrun by the Vietnam last Friday. Bidault said the suggestion was "better late than never" but a difference of opinion developed later as to whether any agreement about evacuation, if decided upon, would include Viet Nam as well as members of the French expeditionary corps.

Delegates of Cambodia and Laos, two of the three associated states of Indo-China, rejected Vietnam statements that there exist in the two states what the Vietnamese call a "liberation movement" and "resistance governments." The Communists call these alleged governments Pathet Lao (Laos) and Khmer (Cambodia).

Other contributions to the debate on Indo-China were made by Eden and Gen. Walter Bedell Smith, leader of the United States delegation. Both hit back at what they termed the "distortion" of U. S. policy reflected in the Vietnam delegate's speech.

Eden said it was a travesty to say the U. S. threatened the liberty and independence of anyone. He reserved comment on the Vietnam cease-fire plan but endorsed the Bidault proposals, saying he hoped the conference would begin studying them as soon as possible.

There was no meeting on Korea Monday but Canadian sources hope the discussions will be renewed today. It is understood that the 16 non-Communist nations which fought in Korea are still trying to bring South Korea along with them in trying to arrange a settlement in the war-torn peninsula.

The heart of the apparent disagreement between the UN group and President Syngman Rhee concerns Rhee's reluctance to accept all Korean elections. Elections previously held in South Korea under UN supervision, Rhee holds that once he admits the possibility of a new vote, confidence in his government will be shaken.

In the Indo-China debate, the Vietnam delegate said Bidault's plan could not "serve as a serious basis" for peace. Of the Vietnam plan, a French spokesman said it appeared designed not to stop the war but to "set the stage for Vietnam to swallow all of Indo-China."

Soviet Foreign Minister Molotov, chairman for Monday's session, did not even call a meeting for today in adjourning Monday's session.
