No animal having formerly obtained a first premium, will be allowed to compete at this show.

No animal to compete for more than one prize.

No competitor to exhibit more than the required number of animals in each class. No prize to be awarded, unless the opinion of the Judges there be sufficient competition.

The Judges will begin their inspection of the Stock at 12 o'clock precisely, and all persons having Stock competing for a Premium, are particularly requested not to interfere in any way with the Judges during their inspection. No person will be allowed to exhibit Stock for competition, unless he be a Subscriber to the Society, or to one of the branches established under its direction.

Small Premiums will be given for improved Implements of Agriculture manufactured on this Island, provided the specimens exhibited are considered by the judges deserving of the same.
