Prime Minister Diefenbaker paid a fine compliment to the Canadian Women's Institutes by calling them the "architects of the future."

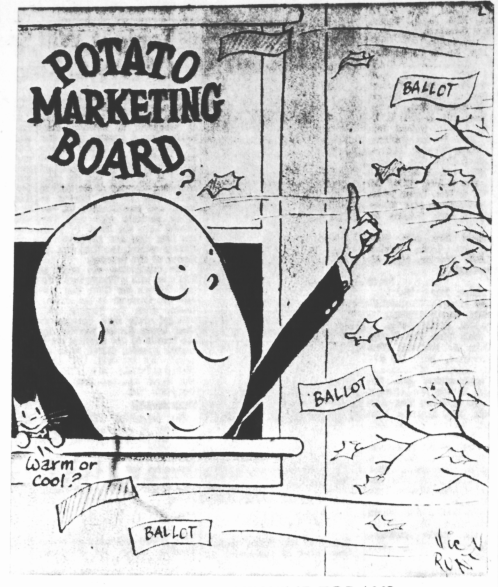
