The "Patriot's" Singular Course.

DOMINION PARLIAMENT

OTTAWA, May 3.

Gladstone Reserving His Strength.

LONDON, May 3.

Gladstone in a manifesto to his Midlothian constituents explained that the speeches of the Easter recess has obliged him to reserve his limited powers for the House of Commons, for that reason he uses his pen instead of his voice.

Gladstone's Tactics.

LONDON, May 3.

Rumors are in circulation that Gladstone will dissolve Parliament immediately after a division has been taken in the House of Commons on the second reading of the Home Rule bill, whatever the result of the vote may be.

Many of Gladstone's staunchest supporters openly express the conviction that the Land Purchase Bill will be dropped, and in the lobby a similar opinion prevails.

Two Men Roasted.

FREDERICTON, N. B., May 3.

The residence of James E. Cambys was to-day burned to the ground, and two men, Wm. Jennings, of Spring Hill, and Mack Craig, of Tobique, lost their lives while trying to save property. They were hemmed in by flames and burned alive.

New York, May 3.

The great trotting stallion, Maxey Cobb, died of gray of inflammation. He was valued at \$40,000.
