progress to go forward," Truman said in an address prepared for delivery over country-wide radio and television hookups. "No other course could have served both of these purposes."

Truman's speech was in reply to Attorney General Herbert Brownell's charge that White, now dead, was retained in an important government post despite reports that White was a Soviet spy.

Called As Witness
Truman related that results of investigation up to that time in 1947 were late before a federal grand jury at which White was called as a witness. The grand jury, he said, did not indict White although it was the same grand jury which indicated the 12 top Communists in the country.

He added that White resigned in April, 1947, from his office "referring to reasons of health."

"Although my recent official comment concerning his resignation was in error," Truman said, "the fact is that he was separated from government service promptly when the necessity for secrecy concerning the intensive investigation by the FBI came to an end."

Truman's talk was designed as he stated it, to "answer all the questions" which have come up since Nov. 5 when Attorney General Brownell accused the Truman administration of keeping White in office despite FBI reports to the White House that he was a Russian spy.

Tearing the actions of the present administration "shameful demagoguery," Truman said: "It has distorted a decision that enabled an investigation of great importance to proceed—as it did—unembarrassed, and with ample regard to the public interest, into an alleged harboring of Communists."

Open Verdict In Death of Tignish Man In August

A coroner's jury empaneled to inquire into the cause of death of Joseph Wilfred Arsenault of Tignish, P.E.I., who passed away at the Prince County Hospital on August 19th, 1953, last night heard the concluding evidence of four people and after deliberating on the evidence submitted, returned a verdict that the said Joseph Wilfred Arsenault came to his death as a result of a fall sustained on the night of August 18th.

The open verdict was that from the evidence submitted the jury were unable to decide by what means the injuries which caused his death were inflicted.

Those who gave evidence last night were Constable H. Z. Fortaine of the R.C.M.P. detachment at Alberton who had gone to the scene of the accident, accompanied by Ernest Arsenault, the driver of the car which had picked up the unconscious man on the Griffin Road on the night of August 18th.

He said he had examined the Arsenault car and had found evidence of dark blue paint on the bumper and grill, which later evidence showed had been sustained in a previous car accident in Toronto.

The evidence submitted by the remaining witnesses, Albert Arsenault, St. Louis, Cyril Bernard, DeBolis, Joseph Buote, St. Roch, was in respect to his recollection of the R.C.M.P. detachment at Alberton with the evidence submitted by previous witnesses on Friday evening, November 13th, when the inquest opened.

The inquest was conducted by Dr. Wilfred Callaghan and Mr. Donald Stewart, Q.C., appeared for the crown.

Members of the jury were Messrs. Roland Phillipson (foreman), George Harris, Gordon Sullivan, Roy Johnston, John Schurman, Norman E. MacLeod, George Clow.

"It is now evident," Truman said, "that the present administration has fully embraced for political advantage McCarthyism."

He added he was not referring to the senator from Wisconsin, saying "he is only important in that his name has taken on a dictionary meaning in the world."

"It is the corruption of truth, the abandonment of our historical devotion to fair play," Truman said.

"It is the abandonment of the 'due process' of law. It is the use of the big lie and the unfounded accusation against any citizen in the name of Americanism or security. It is the rise to power of the demagogue who lives on untruth; it is the spread of fear and the destruction of faith in every level of our society."

NEW YORK (AP)—Two young Puerto Ricans were accused Sunday night of attempting to resolve a love triangle by stabbing the girl they both loved, because she could not choose between them.

The victim, Yolande Rivers, 17, was reported in satisfactory condition early today at a hospital.

Armando Rojas, 20, and Angel Correa, 21, were held on charges of felonious assault.

Police quoted the youths as saying: They both loved the girl, and she professed affection for both but would not consent to marry either. They talked it over then decided to kill her.

In her furnished room Sunday night Correa seized her and held her while Rojas stabbed her over the heart. Correa then took the knife, a 12-inch hunting weapon which he owned, and stabbed her in the abdomen.

The youths were seized as they joined a crowd gathered at the hospital.

19 Feared Dead In Collision In English Channel

DUNGENESS, Eng. (Reuters)—Rescue craft pulled six survivors and five bodies from debris-strewn waters of the English Channel early today, but 14 other crew members of a sunken Italian ore carrier were unaccounted for and feared lost.

The 2,745-ton Vittoria Claudia sank within five minutes of being struck by the French freighter Perou. Many of the crew were hurt in the sea by the impact, while others were believed helplessly trapped below decks.

One of the rescued men died shortly after being picked up. The five others were treated in a hospital at Folkestone for shock and the effects of three hours in the cold water.

By noon today hope for the rescue of the 14 missing men had waned, though a large rescue force still combed the collision scene in the Straits of Dover. The Perou, reporting "some damage," headed for Le Havre after a fruitless search for survivors.

Temperance Federation To Provide Scholarship

Mr. Colin Waugh of Wilmot Valley was elected president of the P.E.I. Temperance Federation at the annual meeting in Summerside yesterday which went on record in strong protest against the operation of the liquor store at Borden, and called for its immediate closing.

The meeting also heard an inspiring report from Dr. Ross C. Eaton, field secretary for the Maritime Temperance Federation.

Authorization was given by the meeting to permit the executive to provide a scholarship of up to \$100 to enable some student of Prince of Wales College to attend the Intercollegiate School of Alcohol Studies in London, Ontario, next summer. The meeting also approved a gift of \$50 to a school of alcohol studies in connection with the annual meeting of the Canadian Temperance Federation in Montreal on December 2-3, and Rev. Howard Christie, Hunter River, Rev. R. A. MacLeod, St. Peter's, and Mr. Robert Carruthers of Summerside were appointed delegates to this meeting.

Yesterday's meeting was presided over by the retiring president, Mr. Gordon MacMillan, Cornwall, and reports were heard from the secretary, Rev. John F. MacKay of Vernon; the treasurer, Mr. R. S. Carruthers of Kensington.

Rev. Howard Christie of Hunter River tabled a notice of motion for next year's meeting which will increase from seven to five the number of executive members that constitute a quorum.

Temperance Education
Dr. J. A. Clark of Charlottetown reported on a meeting which he and other members of the Temperance Federation's committee on legislation and law enforcement had had with Premier Matheson to request the appointment of an instructor in the field of education, employed under the Department of Education, whose job would be to give instruction on temperance education throughout the Province. Dr. Clark reported that they had been favorably received by the Premier, and had his assurance that in the event that a decision was made to make such an appointment that the Temperance Federation would be consulted before the appointment was confirmed.

In addition to the resolution concerning the liquor store at Borden, other resolutions approved by the meeting: (1) Reaffirmed their belief in total prohibition; (2) in view of the widespread prevalence of the drinking habit, appealed to all church members to practice voluntary total abstinence; (3) called upon churches to observe worthily, World Temperance Sunday, the 4th Sunday in November; (4) encouraged all Sunday schools to use each year the full series of temperance lessons; (5) expressed deep appreciation for the outstanding leadership being given by Rev. Ross Eaton, Secretary and his wife, Dr. Ross Eaton, and pledged to them the wholehearted support of the organization.

In his report as Maritime Field Secretary, Dr. Ross Eaton stated that there were several objectives he has been seeking to attain. He said it was especially necessary to arouse the church people to the growing seriousness of the alcohol problem and arouse the Christian conscience in the matter and of sense of social responsibility. He said he has been trying to get the churches to attack the problem on the local front. In every community there is a drink problem, he said, and only as each church group accepts responsibility, especially the young folk, will the larger problem be solved. Dr. Eaton said there was a challenge to church members who may be moderate or occasional users of alcoholic beverages to get over on the other side of the line in order to bear a consistent Christian witness against a growing evil.

He said part of his work was to reach and save young teen-agers in the high schools to see the menace of drinking and the social custom of drinking and "do as everybody else is doing", to assume an attitude of leadership to help other young people away from the dangerous habits of drinking.

He said everyone interested in temperance should expose what he termed "the big lie", which has been built up now for several decades and which millions of people have come to accept namely "that alcohol is necessary to modern living". Such a "big lie" has been built up by many agencies. He said all must try to expose such a falsehood by showing that life is livable, lovable, and laughable without alcohol. He said "there are hosts of the most popular and successful people in the world who just 'don't drink'."

In his report Dr. Eaton stated that during the past year he and Mrs. Eaton had visited 228 churches and he had spoken in 97 schools in the three Maritime Provinces, and raised approximately \$10,000 for Federation purposes.

Dr. Eaton gave some of his impressions following his two years' work as field secretary, in which he said there is definitely an awakening interest within the Christian Churches today on the seriousness of the alcohol problem. He said there is a similar concern on the part of school principals and teachers about this danger confronting youth.

He stated that the area of the Maritimes is too large for one man, even with the assistance of a capable wife as secretary and public speaker. He said the territory allotted to him is so large that it would take five or six years to completely cover the whole area.

The cabinet had been required, by statute, to decide whether the proposed CPA service would be in the public interest at present. It had decided it was not.

"It means nothing for the future. I personally felt that it was quite in line with my profession of faith in the value, as a general principle, of competition in business."

He added: I am not at all sure that it would not have been a good thing for silk-hatted socialists, or any other kind of socialist, to have something to say about the duplicating of competing railway lines at the early part of this century."
