Mr. Palmer's Tunnel Plans.

The maps and sections accompanying the report of A. Palmer, C. E., are on exhibition in blue print in the window of Messrs. Hazard & Moore.

But, unfortunately, these diagrams do not fairly represent the facts of the case. The large diagram giving a section of the tunnel does not represent the tunnel designed and estimated on by Sir Douglas Fox.

Notes and Comments. Individuality is never to become eccentricity. Personality is never to stand for oddity.

The diagram of the tides is fairly copied from Bayfield's charts, and in this respect is interesting; but its bearing on the Northumberland tunnel is not apparent.

The Railway map gives Palmer's proposed short line from Cape Traverse to Charlottetown. As the bridges alone on this line would cost half as much as the present entire railway system of the island, the proposal to spend so much money on an accessory to a work the chief objection to which is its great cost, certainly does not appear judicious.

The geological map ought to be of value as explaining the relation of the geological formations to the tunnel bed. But to be of any service it must be correct. On this map, however, the distribution of the formations is distorted and misrepresented, and of the numerous anticlinals laid down, not one of them is anywhere near its natural position.

These inaccuracies are the more to be regretted, as the Government made provision for and received an accurate report on the geological formations, to which Mr. Palmer could have had access.

The people of the island attach too much importance to the tunnel scheme to quietly permit it to be played with. The Government nobly performed its part in giving an appropriation sufficient for a complete survey, and we cannot afford to have this appropriation misused.

The Patriot's Ancient History.

It is significant of the falsity of its contention that the financial management of the Sullivan-Ferguson Administration was "most creditable," that the Patriot is compelled to resort to "ancient history." Comparisons have over and over again been made between the results shown by the various Governments which have been in office in this Province since the date of Confederation.

In the interest of historic truth and the honest and able men who formed the Sullivan-Ferguson administration, it was perhaps expedient to expose the error of the infantile mugwump of the Guardian. But, apart from this, there is nothing to be gained by referring to records of eighteen or twenty years ago.

Confidence in the Government.

Charlton's Gross Misstatements.

OTTAWA, Feb. 23. After routine yesterday in reply to Mr. Davies, Hon. I do not ask for the olden times when our grandmothers were weavers, spinners and toilers from early morn till long past candlelight; but what a blessed thing would be a return to their simple modes of dress and the health-giving methods which gave them their strength and power of endurance. The invalids and semi-invalids among us far outnumber those possessing normal strength. I see no hope for this to change except through methods of home training and home living. The midnight dance, the exposure of décolleté attire, the torturing by tight bands and unnatural combinations, all tend to drag down the physical, mental and moral standard of the womanhood. These are time worn assertions, and may be unpleasant ones to many; but conditions justify them. I plead for the welfare of our homes, and these evils are robbing them of vitality and beauty. Surely it is time that we, as God-fearing women, shake off these fancies and declare for our loved ones and the right. Declare for home, and know that ours is the grandest calling on earth. Let us do our part cheerfully and well; then the question with husband and sons and daughters will be: "What can I do to keep our home always so bright and happy?"

The Crisp-Currie Case.

Crisp Acquitted by the Committee. CURRIE APPEALS TO CONFERENCE.

ST. JOHN, Feb. 23. The Crisp-Currie committee reached a decision last night. On the charge of adultery the committee acquitted Mr. Crisp by a majority of three to two; on the charge of conspiracy the committee were unanimous for acquittal; on the charge of deception and misrepresentation and falsehood, the committee by a majority of three to two found in favor of Mr. Crisp. The committee divided on the same lines in the first and third charges. On the conspiracy charge the argument for the defence was that no evidence had been produced to show that D. D. Currie was innocent, or that the finding of the Conference in respect to him was wrong, and that as Currie was still regarded as guilty, the conspiracy against him would not lie. It was not conspiracy to assist in convicting a guilty man. This argument seemed to have prevailed. The prosecutor, Rev. Isaac Howie, Chairman of the Fredericton district, stated that he would appeal the case to the annual conference which will meet in Moncton. According to discipline his revised case will then be heard by the full ministerial conference, numbering nearly a hundred, instead of by a committee, as when Currie was tried.

THE HOME RULE BILL.

Ulster Preparing for Armed Resistance.

LONDON, Feb. 23. It is reported from Belfast that the Orangemen in the North of Ireland are preparing for a forcible resistance to the Home Rule parliament should one be established. Excitement is running very high among the Ulster Loyalists. Many declare that in the event of the enactment of the Home Rule Bill civil war will inevitably ensue. Preparations against the Home Rule Bill are being offered in all Protestant churches of the diocese of Down, Ulster.

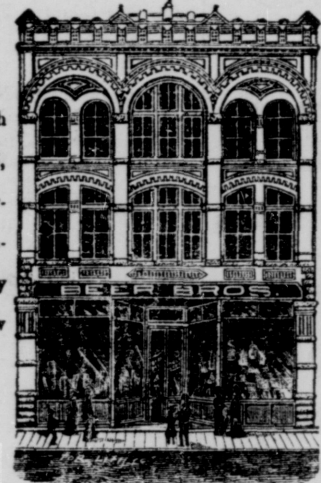
