(Continued from page 1) determine what the growth is. Such surgery was reported considered rejected because of the Pope's age.

The doctors seemed most concerned with the hemorrhaging that the disorder was causing, not the disorder itself. The L'Observateur Romano statement said:

"The hemorrhages caused by the chronic heterochromia has affected the Holy Father for about a year, after being arrested for several months. He has had an accentuated resumption in recent days."

"They have now been attenuated, and the organic consequences linked to them, are, therefore, limited and compensated by the curative measures adopted."

RESPONDING SLOWLY: These measures are transfusions and the use of blood clotting agents such as vitamin K. One informant said he was not responding to them as quickly as he had earlier in his illness.

One indication of the gravity of the Pope's illness was the L'Observateur Romano handling of its statement.

The newspaper had been playing down stories about the Pope's health. It carried two articles about the unusual seven-column, page one headline that said:

"The Pope asks prayers for the fulfillment of the will of God. Whether it be a sacrifice or the prolongation of his life, for the happy conclusion of the council, for the holy church, and for peace."

Jack Nicklaus Can Better Arnie's Mark

DUNEDIN, Fla. (AP)—Even as he is being hailed as a professional golf buff, he was saying it would be a long time before anyone appeared on the scene to rival Arnold Palmer.

But they hadn't taken a close look at a beefy young Ohio player, Jack Nicklaus.

According to the Professional Golfers' Association, the 23-year-old Nicklaus has won \$7,615 in 13 tournaments so far this year. He only has to win about \$24,000 more during the next six months to break Palmer's record earnings of \$81,448 for one season.

Nicklaus has won three of his entries and placed in the upper five money brackets four times. The PGA list of the 10 top money winners showed Tuesday.

Tony Lama, winner of the rain-deferred Memphis Open, is second with \$4,286. Gary Player, always a steady money winner, is third with \$39,063. Palmer is fourth with \$31,545 and Julius Boros is fifth with \$30,225.

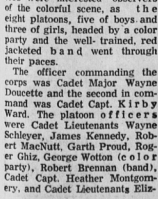
