### MARY HAWORTH

#### Wife Fears Difficulty With Estranged Mate

Dear Mary Haworth: My husband is British, living in England and I very much fear he is mentally disturbed. He sometimes drank to excess and always had an outside romantic interest.

He seemed to channel all his animosity towards me, blaming me for whatever went wrong. He was very authoritarian and said a family, like a business, could have only one head: therefore he would make the rules and if I didn't like them I could leave.

He asked me several times why I didn't leave. With a young child and no relatives, I didn't know what to do. Finally I confided in a friend, who welcomed me and my daughter to stay with her family until I could find work and make other plans.

That was last October. I placed my daughter in a fine small private school, justifying the expense in the knowledge of its wholesome environment during a critical time. This year she will attend public school in a fairly small class.

My problems are threefold: 1. Economic. I can't continue to carry a full-time job plus home responsibilities. I am well educated and hope to find suitable work in the educational field.

2. Legal: My husband has legal rights to visit our child, yet I am truly terrified of seeing him. He sends me \$60 a month and says that is all he is legally required to pay. Recently he refused to pay medical and other special bills for our daughter. I would guess that his income is between eight and 10 thousand a year.

3. Advice and counsel: I can't afford expensive physiological counselling, yet feel I must know if my fears are warranted. I would be most grateful if you could tell me where to go for the help I need.

We've lived overseas—in Asia, South America, Mexico, Italy and England—and I believed we'd feel most at home in Mexico, but I am not sure of finding employment there. Sincerely, E.P.

Dear E.P.: Taking into account your circumstances as de-

scribed, and the nature of your problems—economic, legal and psychological—I should think you'd be eligible for low-cost advisory help from either the Legal Aid Bureau or the Family Service, or both.

Both services are operative in the community from which you write.

The Legal Aid Bureau would know how to proceed to check the veracity of your husband's contention that \$60 a month covers his financial obligation to his child.

Also, it could help you determine the status or extent of his visitation rights (if any). Inasmuch as you feel him to be an unfit influence, a terrifying person, and hence may prefer to obtain protective full custody of the child, if possible, the Legal Aid Bureau might advise and represent you in working towards that objective.

The family service, on the other hand, is staffed to evaluate, with psychiatric understanding, the validity of your fears of your husband's hostile temperament or unstable personality.

Another routine aspect of its service consists in helping overburdened, economically insecure "parents without partners" plan most effectively, in terms of their resources, potentials and limitations (environmental, educational or whatever.) The Family Service in effect lightens the load, by bringing a knowledgeable, attentive, cooperative spirit to bear, on the client's problem of deciding what has to be done, and how to go about it.

The Family Service and the Legal Aid Bureau are experienced in working together when necessary, to search out the specific answers to specific questions, such as your brother-in-law's international marriage poses. So you wouldn't be prejudicing one by approaching the other first, as the starting point of your organized inquiry.

The local telephone Information Operator can give you the dial numbers, for reaching the offices to schedule an appointment for a face-to-face assessment of your situation.—M.J.

#### Strict Measures Taken In Brewing Fine Coffee

**FRUIT DROP COOKIES**  
(Makes 8 doz. Nice for Christmas gifts, too.)

1 (1-1/2) jar glass fruit mix  
1/2 c. sifted flour  
1 c. room-soft butter or margarine  
2/4 c. sugar  
3 eggs  
1 c. sour cream  
2 tsp. instant coffee powder  
3/4 c. sifted flour, additional

1 1/2 tsp. baking powder  
1/2 tsp. baking soda  
1/4 tsp. salt  
1 tsp. ground clove  
48 glucose cherries, halved or 90 pecan halves

Dredge fruit with half cup flour, tossing to coat well; set aside. Cream together butter and sugar. Add eggs, one at a time, beating well. Beat in sour cream. Sprinkle coffee powder over mixture and mix well. Gradually add 3/4 c. flour, sifted 3 times with baking powder, soda, salt and clove. Stir until batter is smooth; fold in floured fruit.

Drop by heaping teaspoons, about 2" apart, on lightly oiled large cookie sheet. Top each with half a cherry or pecan. Bake 8 min. in pre-heated very hot oven (450 degrees F.), or until the tops spring back when gently pressed with fingertip. Remove cookies while warm and cool on racks. Store in covered metal container.
