RAILWAY NEWS.—The winter time table comes into force on the 9th inst. It will be found elsewhere in to-day's issue.

Commencing on Wednesday next and continuing until the close of navigation, a special passenger train will leave here for Summerside at 6 o'clock each morning (Sundays excepted) connecting there with the steamer for Point du Chen, and leaving Summerside on return to Charlottetown on the return of the steamer in the evening. This train will run through to Tignish and return on Tuesdays and Fridays.

There will be the usual Thanksgiving fare on the Island Railway, as advertised.

THE GLOUCESTER FLEET.—The number of Gloucester, Mass. vessels is lost during the past year has been 12, of an aggregate tonnage of 245,73 tons, representing a value of about \$54,000, on which there was no insurance, mostly in the local offices, of \$40,238. An unusual feature of the record is the fact that no vessel has been lost with all her crew, and that the loss of life has been much below the average, viz., 46, including persons who have died at sea or in other ports while on fishing trips and fishermen drowned in the harbor. For the previous year the number of vessels lost was 17, averaging 1492.73 tons, valued at about \$50,000, and insured for \$72,800, and the number of lives lost 78. Angus O'Hanley, formerly of Souris, was the only Islander lost this year.

Canadian Drink Bill.

McLeod's Hall presented quite an interesting scene last evening on the occasion of an address delivered before Orient Division by the Rev. J. A. Gordon, on the financial aspect of the liquor traffic in Canada. Mr Gordon wished to indict the liquor traffic, and would do so on three counts: First—That it destroys man as such; Second—That it destroys our homes; Third—That it destroys the nation. These facts are conceded by all intelligent men, and it was hardly necessary for the Government of Canada to appoint a royal commission and handsomely pay them, in order to find it out. The liquor traffic for the year 1890-91 cost the Dominion of Canada \$40,000,000, and out of that forty millions wasted, or worse than wasted, the Dominion Government receives in the shape of duties, seven and a half millions. The figures were clearly shown and explained on a large chart, which must have cost the reverend gentleman a great deal of careful study and research. Quite an interesting discussion followed, after which a well merited vote of thanks was, on motion, tendered, and the meeting closed.

Benevolent, when sketching the Rev. Mr. Brewer and the Harbor Light a few weeks ago in this city, said "It is a pity that a christian clergyman holding so high a position as the Rev. gentleman should so far forget himself as to mix up on the temperance question, and perhaps it would be a good thing if he would forget himself in the same way." We have at least one other clergyman, the Rev. Mr. Gordon, who has badly forgotten himself in this regard and who is fearless in his advocacy of what he believes to be right.

Supreme Court.

Alex McDonald vs Chas Coles and others.—Plaintiff on appeal at Trinity Term last. The argument on return of rule nisi for a new trial was concluded this afternoon. The court discharged the rule with costs. A McLeod and D O McLeod for plaintiff; L H D-vies, Q C for defendant.

In re application of John Joy for certiorari to remove certain proceedings in the City Court in a suit wherein Donald A. Bruce was plaintiff and said Joy was defendant. On motion of Mr. Stewart, the court ordered that the hearing of the motion to quash be set down the first day of Hilary Term next.

Walter Lowe vs. The Eastern Insurance Company. A rule nisi was granted at Chambers to show cause why an umpire or third arbitrator should not be appointed under the provisions of the Common Law Procedure Act, 1873, for the purpose of assessing the damage sustained by plaintiff by loss from fire.

Mr. Morson showed cause against the rule; Mr. A Peters argued in support of the rule. Court discharged the rule with costs.

In re application of Nathaniel Jost for a writ of mandamus to William C White, Registrar of Deeds, to compel him to receive for registry and register a certain deed.—Mr W S Stewart moved for a peremptory writ of mandamus; Mr A Peters contra.

The court refused the writ, but granted a rule nisi, returnable first day of Hilary Term next, to show cause why a writ should not issue.

Court stands adjourned until the 6th day of December next.

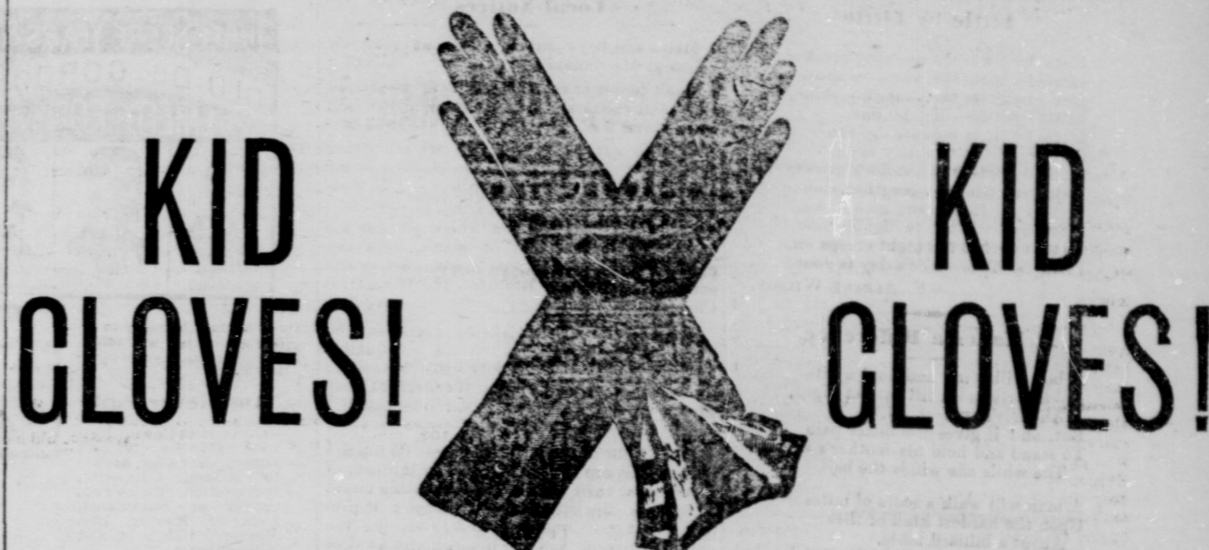
