

Glance Bay Man Is Assessed \$25

SUMMERSIDE — Magistrate W. Chester S. MacDonald dealt with a heavy docket in County Court here yesterday.

Robert Baker, Glance Bay, Nova Scotia was fined \$25 and costs on a charge of unlawfully causing a disturbance in a public place by being drunk.

Peter Juskie of Glance Bay, was sentenced to 30 days in Prince County jail on a charge of unlawfully stealing two coats, valued at less than \$50.

John Wayne MacPherson of Georgeville, Antigonish County, N.S., pleaded guilty to two charges of break, enter, and theft, electing trial by magistrate. He was remanded in custody for sentencing until October 11.

TWO DRIVERS FINED

John S. Burns of Kensington, and Emile Perry of Miscouche were fined \$75 each on charges of impaired driving. Burns pleaded guilty while the decision in Perry's case — heard earlier — was handed down yesterday also.

Joseph Cyrus Des Roches of Miscouche — who earlier in the morning had entered a plea of not guilty — changed his plea to guilty to the charge of unlawfully making a left turn. He was fined \$10 and costs.

Gordon MacPhee entered a plea of guilty to two charges of being overweight in connection with highway rate restrictions and was fined \$100 and costs (total).

Francis Joseph Perry was remanded until October 11 on a charge of theft in excess of \$50. Court was told that Perry stole the cheques from Seabrook Farm. The cheques belonged to Seabrook Farm employees, but there was no loss to the company, even though two cheques had forged signatures on them.

CASES ADJOURNED

Harold Douglas Barry of Summerside pleaded not guilty to driving without due care and attention, and the case was adjourned until October 25 for trial.

David Willard MacLeod of Northam had his case adjourned until October 25, when he appeared on a charge of dangerous driving.

Leon David Ellis of Northam, charged with impaired driving, had his case adjourned until Oct. 6, following crown evidence by Cst. Walter Pines of the Summerside Detachment of the RCMP. The accused was represented by Neil R. MacLeod.

Edward Thomas Cook's trial for care and control was adjourned until October 25, following crown evidence from two Borden RCMP constables. The accused was apprehended near Freetown.

Joseph E. Arsenault, 16, of Abram's Village, was remanded until October 11 on a charge of common assault. Court was told that the youth chased a partially mentally retarded boy and assaulted him.

Weather Summary Released

SUMMERSIDE — The month of September had 19 days of sunny skies, according to the monthly meteorological summary made at Summerside, and released yesterday.

The mean maximum temperature of 63.6 degrees was below the normal maximum temperature of 65.5, and the mean minimum temperature for the month was 48.8, compared to the normal minimum of 51.2. The normal temperatures are based on the period of records from June, 1942 to 1960.

Total rainfall in the month was 3.12 inches, short of the normal rainfall by 41 of an inch. There were eight days when only a trace of rainfall was recorded, and 12 days with no rain. The heaviest rainfall was on September 5, when .91 inches were registered, and on Sept. 15, with .81 inches. Other rainfall amounts during the month were: Sept. 1 (.06), Sept. 2 (.11), Sept. 4 (.03), Sept. 14 (.01), Sept. 16 (.03), Sept. 23 (.55), Sept. 25 (.25), and Sept. 30 (.36).

The lowest mean temperature (from maximum and minimum) was 48 on Sept. 27, when the temperatures ranged between 40 and 56. The highest mean temperature for September was a 68 on the 9th, when the high was 77 and the low 58.

The wind's average speed during the month was 16.7 degrees, compared to 14.8 as normal. The prevailing wind was from the West.

New Bargaining Approach Suggested At APEC Talks

HALIFAX (CP)—A new approach to collective bargaining within key industries in Canada was suggested Tuesday by a Nova Scotia businessman at the annual meeting of the Atlantic Province Economic Council.

A. E. Balloch, president of Bowaters Mersey Paper Co. Ltd. of Liverpool, N.S., proposed a national council consider claims for labor and management in such industries for wage or price increases and make specific recommendations as to what course should be followed.

He also suggested a national resources and information centre be established to provide statistics and analyses equally acceptable to both labor and management.

The New Glasgow native spoke at a panel discussion on labor-management and industrial growth on the final day of APEC's two-day annual meeting.

Dr. W. D. Wood, professor of economics and director of the Industrial Relations Centre at Queen's University, Kingston, Ont., also said the present bargaining process appeared in danger of breaking down.

Farmers Satisfied With Sale Prices

Satisfactory prices were received yesterday by farmers who took livestock to the weekly auction sale at the Exhibition Grounds.

One man told The Guardian he cleared \$45 on a 1,000-pound Holstein cow over what he had been offered at his barn last week.

"Plain steers — there were none that were even standard yesterday — brought as much as I was paid for steers, some of which would get into some of the top brands a week ago," the same man said.

A 10-day Holstein bull calf brought \$27.00 for Jack Rodd, Milton. "I'd probably get \$20 selling him locally," said the man who is provincial president of the Federation of Agriculture.

A smaller Holstein calf — this one was a heifer — sold for \$25.

A 1,520-pound Holstein cow sold for \$17.25 per hundredweight. A Holstein steer weighing just over 1,000 pounds brought 19 cents a pound on the hoof.

A grade Hereford heifer brought 20 cents a pound. She weighed 670 pounds.

A Holstein heifer weighing 1,000 pounds brought \$19.75, and a feeder heifer at 550 pounds, brought \$19.50 per hundredweight.

A beef cross heifer at 680 pounds brought \$21.25. Frank Mutch of Cherry Valley bought this one. Ordinary buyers took most of the stuff, with Bill Gorder, Truro, the biggest buyer, though several stayed in the province, with farmers buying several for feeders.

A black, dairy type steer — he weighed 840 — brought \$18.50 per hundred pounds.

A thin looking Holstein steer brought \$18.75. A grade Holstein cow brought \$14.50 per hundredweight. She weighed 1,345 pounds. A Holstein steer at 970 pounds sold for 20 cents.

A very plain dairy steer sold for \$17.50. A Holstein heifer brought \$19.25.

A 705-pound Holstein bull sold for \$18.25 per hundredweight.

The only thing that didn't sell was a six and one-half months old Registered Yorkshire boar. The animal seemed to be of good type but nobody wanted a boar yesterday, and there wasn't even a bid on him.

There were approximately two dozen head of cattle, including three calves. "It's too fine a day for farmers to be away from their work," one agricultural spokesman said. But several farmers who came long distances to see how this sale is going, said the prices are much better than they are offered at their farms. They'll be back with cattle for future sales, they told The Guardian.

Frank Berkelear is the auctioneer, and sale manager is George Lacey. Both are from Truro, though Mr. Lacey is a former Tracadie man.

The Island delegation will leave by train noon Saturday. The Convention arrangements committee, through liaison with Ottawa, has arranged schedules for committee meetings at the conference.

Chairman of the arrangements committee is Mr. Sigsworth; co-chairman are Mrs. Jean MacDonald and Mary Cullen, both from Charlottetown. Members of the committee include Lee Brodrick, Tignish; Eldon Jamieson, Montague.

North River Man Takes Hay Award

Wilfred MacKinley, North River had the grand championship sample of hay in the "Beat your neighbour" contest staged last August at the Provincial Exhibition here.

The grand champion award went to Mr. MacKinley's sample of legume hay that tested 21.9 per cent of crude protein. And that's fantastic, David Smith, P.E.I. department of agriculture told The Guardian yesterday.

The MacKinley hay had only 23 per cent crude fibre.

J. Lincoln Dewar, New Perth was second in the legume hay division and Taylor Brothers, Norton, N.B. were third. The Dewar sample had 17.3 per cent protein and 25.1 per cent crude

fibre. The Taylor sample had 20.9 per cent protein but their fibre content was up to 27.4 per cent.

TOP CLASS

Taylor Brothers topped the class for mixed hay, (legume and grass) with 19.2 per cent crude protein. The fibre content was 27.2 per cent. In second place was Ivan Turner, Winsloe with 12.5 per cent crude protein and 35.1 per cent crude fibre. Third was Wilfred MacKinley with 12.6 per cent protein and 34.2 per cent fibre.

Arthur Wheatley, North River topped the class for grass hay with 6.1 per cent protein and 36.2 per cent fibre. Second was Russel Wheatley, North River with 6.1 per cent protein and 40.5 per cent fibre. Third was Ivan Turner with a sample that tested 8.7 per cent protein and 37.1 per cent fibre.

The testing was done by the agronomy services of the Nova Scotia department of agriculture.

\$25 Penalty Is Imposed

A Nova Scotia man, Harvey R. Cormier was fined \$25 and costs or 10 days when he entered a plea of guilty to a speeding charge before Magistrate A.J. Haslam, QC, in City Police Court yesterday.

James MacNevin, Charlottetown, was fined \$10 and costs or five days for failing to stop at a red traffic light.

Brian David Foley was fined \$15 and costs or five days for failing to yield right of way to a pedestrian.

Two persons appeared on charges of being drunk and incapable. One case was remanded until October 5 and the second person was fined \$10 and costs or five days.

Another man pleaded guilty to a charge of illegal possession of liquor and was fined \$100 or 30 days.
