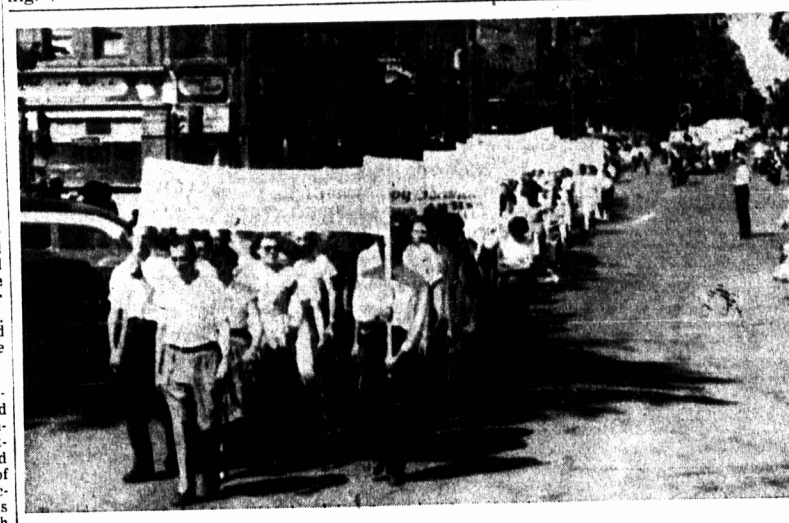

Quoted Data On Fluoridation

Dr. H. K. Brown, Dental Consultant to the Department of National Health and Welfare, Ottawa, who is at present visiting Charlottetown to present the latest facts in relation to fluoridation to the dentists attending the Maritime Dental Association here.

He said the following statement about his study of the dental conditions in Brantford.

Brantford has now been fluoridating its water for more than 10 years. During those years there has been a steady and spectacular reduction in tooth decay.

Children here who were born since fluoridation began, have only about one third as much decay as those of the same age in the average Canadian community. No ill effects of any kind have been seen by either the dental or the medical profession.

Water fluoridation is recommended by the Canadian Dental Association, the Canadian Medical Association, and the Canadian Public Health Association. More than a dozen Canadian cities and towns are now fluoridating, and many others are preparing to do so. In fact Saskatoon is commencing fluoridation this week.

Held Responsible In Montreal Death

SEPT-ISLES, Que. (CP)—Jean Du Paul, 35, of Montreal Monday night was held criminally responsible by a coroner's jury for the strangulation death of Isidore Rheume, 50, also of Montreal.

Police testified Rheume was found dead Sunday in his hotel room. They said he and Du Paul had had a violent argument over money during a drinking bout.

Du Paul will be flown to Quebec City and held in jail pending his arraignment in court. Police said it is not yet known what charge will be laid against him.

The men were both employed on the kitchen staff at a construction camp near this town, 350 miles northeast of Quebec.

Hints Next Federal Election Will Be 1957

OTTAWA (CP)—A hint that the next federal general election will be held in two years' time was dropped Tuesday by Prime Minister St. Laurent in the Commons.

Questioned by Opposition leader Drew about sale of butter to Communist Czechoslovakia at a price below that paid by Canadian consumers and about the pending sale of wheat to Red Poland largely through a government-backed bank loan, he said if they turn out to be unfortunate the government will bear the consequences.

Mr. Drew interjected that Canadian taxpayers will pay, not the government.

The prime minister replied that Mr. Drew will have "an occasion in a couple of years to point out many things to the Canadian taxpayers."

Mr. St. Laurent's reply was taken to mean that there will be an election in two years' time, in 1957.

Injured Model Finds Happiness

TORONTO (CP)—After a six-year convalescence from multiple injuries caused by a hit-and-run accident, a former Toronto model found happiness here last week.

Heleen Billson and her fiance were struck by a car Jan. 30, 1949, as they walked together on a Toronto side-street. The fiance was killed instantly. Miss Billson was taken to hospital where teams of specialists worked to rebuild her maimed body.

She stayed in hospital 14 months and underwent 12 operations on her left leg alone.

This week the petite blonde is honeymooning with her husband, Patrick Finigan, their marriage June 25 came to light only Tuesday.

Aim New Blow At Hitler Myth

MUNICH (Reuters)—The Bavarian high court Tuesday aimed a fresh blow at the Hitler survival legend. It ruled a lower court had the right to declare the Nazi dictator dead.

Legal arguments over Hitler's death began in 1952 when Austrian authorities sought a death certificate in order to dispose of Vermeer's painting "The Artist in his Studio." This was the Fuehrer's only known property in Austria.

Tuesday's ruling said that the lower court sitting at Berchtesgaden, Hitler's mountain retreat, had the right last October to issue a certificate.

A series of investigations found that Hitler died April 30, 1945, in his Berlin bunker chancellery the day after marrying Eva Braun. Several witnesses testified they died together in a suicide pact.

Yet the myth of Hitler's survival persists among some Germans. Those convinced he is dead claim the survival legend is deliberately spread by former Nazis in an effort to restore the Third Reich.

For the first portion of his program Dr. Bell chose six religious numbers which were sung with great feeling. Included in this group was a Negro spiritual which was rendered with the rhythm which is typical of the colored race. The presentation of "The Lord's Prayer" in song will long be remembered by Charlottetown citizens.

It would be difficult to single out any particular number of last night's program because of the fine quality. But much was added to the singing by Dr. Bell's clear verbal interpretation of each before it was sung.

Twenty-nine girls took part in last night's appearance. One of the group was taken ill with appendicitis just before leaving Toronto. Dr. Bell when asked what requirements he looks for in a girl aspiring to become a member of his chorus, says that the first is a good voice. Ability to read music is important and, of course, appearance is a matter of consideration. The girls in the chorus range in ages between 18-25. He says there is an abundance of material to choose from, since Toronto is the mecca of young folk seeking a musical career. In certain appearances in and around Toronto his group numbers as high as 60 songsters.

U. N. Bars Allied Newsmen From Red News Conference

PANMUNJOM (AP)—The United Nations command Tuesday barred allied newsmen over their protests, from accepting a Communist invitation to a press conference in the 1,000-yard circular joint security area near here.

The refusal came after the command told the Reds in some of the strongest language it ever used at a Military Armistice Commission meeting that their recent "sweet talk" and "peaceful propaganda" was in marked contrast to "your continued willful and flagrant violation of the (Korean) truce agreement."
