

Youths Arraigned in School Break

Three youths, two from Summerside and one from Egmont Bay appeared before Magistrate W. Chester S. MacDonald in Prince County magistrate's court yesterday on charges of breaking and entering the Wellington centre school house and committing an indictable offence therein January 14. The youths are Martin Joseph Gallant, Egmont Bay, Dieu Donné Fournier and Joseph Edward Heckbert, both of Summerside.

Heckbert pleaded guilty to the charge and the other two youths pleaded not guilty. Heckbert is counselled by Melville Campbell; the other two have no counsel.

On a second charge of stealing a brown blanket valued at less than \$50, the property of Schurman Peters, Lennox Island, all three pleaded not guilty. The two last were brought before the court on a charge of stealing four tires, four cars, a car, jack and battery, the property of Agnes Myrtle Campbell at Kinross, Heckbert and Gallant had pleaded guilty to the charge, with Fournier pleading not guilty. This case was adjourned, together with the other two cases, to January 29. Bail for Heckbert was set at \$500 on one surety.

Gallant was fined \$10 and costs or five days when he pleaded guilty to a charge of operating a motor vehicle with license plates not issued by the department for the current year.

TWO FINED \$100
Two young St. Roch men, Ernest Joseph DesRoches and Raymond Joseph Blanchard, were each fined \$100 and costs or three months in Prince County Jail when they pleaded guilty to a charge of having possession of a still suitable for the manufacture of spirits, without having obtained a license to do so.

Two-Week Remands Given in Wife Threatening Case

Bail was set at \$1,000 and a two-week remand given in the case of Richard D. MacKinnon, 2 Bright Road, Charlottetown, charged with having telephoned his wife and threatening her with death or injury to their children if she did not return home. The case was heard before Magistrate A. J. Haslam in city police court yesterday.

The accused, counselled by Allison Gillis, pleaded guilty to the charge but asked to have the crown witness (his wife) put on the stand. Alan K. Scates acted for the prosecution. Plaintiff in the case, the wife of the accused, Mrs. Mary MacKinnon took the stand, testifying she had been phoned by Eleanor Hughes, at present keeping house for the family's five children, and had been told by her the children were asleep and well. She then heard her husband's voice on the phone threatening to kill the children, as he had a knife at the back of one of them, if she did not come home, the court was told.

BECAME HYSTERICAL
Mrs. MacKinnon then stated she became hysterical and could not stop screaming. She said she thought they were all dead and did not know they were safe for 45 minutes or more.

On cross-examination, Mrs. MacKinnon stated she had been married to the accused for 14 years, and had never in that time time hurt or threatened to hurt any of the children.

Mr. Scates tried to talk to him any time to discuss their marriage, because he was not in good faith when he wanted to discuss the subject, she said.

Mr. Scates then called Eleanor Hughes, who testified she was at the MacKinnon home with the children and Mrs. MacKinnon, and put through a call to Mrs. MacKinnon, telling her the children were fine. Mrs. MacKinnon then yelled into the phone and she hung up. She said she told him he shouldn't have said it and then phoned back at his residence.

FILIPINO ARRIVES
LONDON (Reuters) — Philippines vice-president Emmanuel Pelaez said Tuesday on arrival for talks with the British government that Communist subversion "poses an active threat to the security of our region."

Marguerite Maloney, wife of Dr. J. H. Maloney, whose home the plaintiff has been staying for the last two weeks, was the final witness. She stated that she had been

present with Mrs. MacKinnon at the time of the first phone call and had seen her shaking and screaming. Mrs. MacKinnon prepared to stand without support, the witness said.

When asked by Mr. Gillis how long it took before the police were notified, she stated it had been some time as it was his duty to find out what happened over the phone.

Summarizing the case, Mr. Scates pointed out that the accused had pleaded guilty, and also the serious nature of the indictable offence was shown by the 10-to-18-year sentence it carries.

Mr. Gillis, in his closing remarks, explained to the court the children were still with the accused, and if Mrs. MacKinnon really believed they would be hurt she would not have left them with him.
