New Peace Talks Are Arranged In Steel Strike

PITTSBURGH, July 14 (AP)—Apparently nudged by the White House, the steel industry and the striking United Steelworkers Union (C.I.O.) arranged new peace talks tonight on the heels of reported rejection by the union of latest settlement offers.

The Office of Price Stabilization also turned down demands of three steel companies for price boosts ranging from \$5.00 to \$8 a ton to cover recently-granted wage boosts.

Presidential Assistant John R. Steelman announced arrangements for the meeting at 10 a. m. EDT here tomorrow. A union spokesman said the session will be attended by U. S. W. President Philip Murray and Vice-President Joseph Larkin of the Bethlehem Steel Corporation, who will speak for the big six of the industry.

Negotiations were called off after union officials showed displeasure with an offer by the industry during week-end peace talks.

A union spokesman said rumors that Murray has called his big policy committee—union governing body—to consider the offer are not true.

Terms of the newest industry offer to settle the strike, now in its 43rd day were not officially disclosed but are believed to call for one industry spokesman said is "a watered down" version of the modified union shop which was part of a separate strike-ending agreement with Pittsburgh Steel Company.

Says Barkley Is Democrats Man To Watch

(By Don Whitehead) CHICAGO, July 14 (AP)—The camp of Senator Richard B. Russell of Georgia, pointed to Vice-President Albert Barkley of Kentucky today as "the man to beat" for the Democratic presidential nomination.

But as top strategist for Senator Estes Kefauver of Tennessee contended a "tide of support is coming Kefauver's way." It became clear the Kefauver backers are counting on television at the Democratic national convention next week to boom his chances of victory.

On both sides, however, there was evident uneasiness over what President Truman is going to do, and hope that Truman will throw his influence their way.

Senator Edwin C. Johnson of Colorado, Russell's campaign manager, named Barkley as the man to beat, but he predicted Russell will be the winner on about the 10th ballot. Russell himself thinks he can turn the trick in six ballots.

Johnson told a press conference that Barkley is tremendously popular with the United States people and his popularity would be in his favor at the convention.

Kefauver's campaign manager, Gael Sullivan—insisted a wave of Kefauver support could come on the second ballot.

The seven Democratic presidential hopefuls have split up the 1,200 delegate votes to the point that a first-ballot victory for any of them appears out of the question. The avowed candidates are Russell, Kefauver, Mutual Security Administrator Averell Harriman of New York, Barkley, Senator Robert S. Kerr of Oklahoma, and Senator Brien McMahon of Con-

Magistrate's Court of Queen's County

In Queen's County Court yesterday morning before Magistrate Gilbert A. Gaudet, a Charlottetown man from Cambridge, Mass., was sentenced to nine months in jail for breaking, entering and stealing a sum of money from the store of Wm. Otis Meyers at Stanley Bridge. He pleaded guilty of taking a car without the owner's consent in the city, and was sentenced to three months for this offence.

A city resident for having stolen goods in his possession was bonded over for \$1,000 to keep the peace, and make restitution. His sentence was suspended for two years.

For having in his possession a preparation containing alcohol, without being duly licensed, a city resident was sentenced to 12 months in jail.

For having liquor in a place other than his residence, a man from Cambridge, Mass., was fined \$20 and costs or 30 days, and for consuming liquor in a public place near Covehead, a man from the city was fined \$30 and costs or 30 days.

A resident of Tracadie for being intoxicated in a public place near Scottford, was fined \$20 and costs or 30 days, also a resident of Breadalbane for a similar offence at Hunter River was similarly dealt with.

A resident of MacNeill's Mills was fined \$20 and costs for having liquor in a place other than his residence, for consuming liquor in or near a motor vehicle, at Covehead, a resident of Covehead was fined \$20 and costs or 30 days.

For operating a motor vehicle near Belvedere without a car licence a resident of Freetown was fined \$3 and costs or 5 days and for speeding near Tea Hill, a city resident was fined \$10 and costs or 10 days.

For inspection. The car had 1951 Nova Scotia registration plates, but during an interview in the hospital Mr. Notting had told him that he had a temporary permit and proof of ownership at home.

Driver On Stand—Taking the stand to make a voluntary statement despite a warning from Crown Investigator John Nicholson, John Notting told the court that he had been driving between 40 and 45 miles per hour during the trip from this city. He and his companion had gone to the Rocky Point ferry but learned that the boat was not operating and started to drive around the West River Bridge. They had stopped at the vendor's and obtained a case of beer, but neither had touched any of it.

Earlier, about noon that day, he had two drinks with a friend in his home, but nothing afterwards.

During the drive he noticed that the car, which he had bought in Nova Scotia only about two weeks previously, was pulling to the right. At the accident scene it pulled left to the right and left the road. As nearly as he could remember he recovered consciousness while lying in the ditch. He then went to a nearby farmhouse for help. He did not agree that there was five inches of play in the steering wheel, he thought there was only three inches.

As a result of a post mortem examination Dr. Harold Shaw, Provincial Pathologist, stated in a report that he found death due to a fractured skull with damage to the underlying brain tissues.

Father Enright Returns To Holy Redeemer Parish

Rev. Father W. J. Enright, above, who was a member of the Staff of Redemptorist Fathers in the Holy Redeemer Parish here from 1933 to 1939, is being heartily welcomed to the city where he is resuming Parochial duty. "I feel as if I were returning home," said Father Enright, in an interview yesterday, "and already I am enjoying the friendly spirit which characterized my former ministry in Charlottetown. My first Parochial work was here, and after six years, followed by another six years as Padre in the Army with a great many Island contacts, it is not to be wondered at that my affection for it's people is very real and enduring."

Father Enright signed up with the Army in 1939 and was District Chaplain in Newfoundland and at Headquarters at Saint John, New Brunswick, until the cessation of hostilities, when he was released and resumed ministerial duty with the Redemptorist Fathers at London, Ont. He remained there until his transfer back to Charlottetown.

Frequent visits to Ottawa made it possible to meet Islanders there, notably Hudson Morrissey, who was an officer in the P. E. Island Highlanders at the time Father Enright was Chaplain. He also recently had a chat with Reg. Peters and his wife, the former Evelyn Connors, as he met them coming out of church at St. Maria, Ontario.

ing, with the usual precautions, up to 8:30 in the morning instead of 8 o'clock as at present on the Lower Water Street railway line.

At the beginning of the meeting yesterday afternoon, Dr. Wendall MacDonald, City Health Officer, gave his report and said that chlorination of city water should be started here as the dental problem was becoming acute. Dr. O'Meara, Dental Officer, who was present, said that chlorination of the water could produce a definite reduction in tooth decay that was effective in youngsters to the age of 6 years. He added that it would have no effect on the taste of the water and no effect on those drinking it.

The report of Police Chief Charles MacArthur showed that there had been 60 arrests last month. Two of them were for assault with bodily harm, one breaking and entering with intent, one for theft of a motor car, one for vagrancy and the balance for drinking offences. Of those arrests there had resulted 55 convictions.

During the month there were 16 bicycles reported stolen and 10 of them were recovered. At the same time the Chief noted that 603 bicycle licenses had been issued to date this year. There were \$78.00 collected in fines for meter violations and another \$30 for other traffic violations. He added that conditions have been normal in the city with very few serious law infractions.
