THE GOVERNMENT APPOINTMENTS.

The Royal Gazette teems with the notices of new appointments to various offices under the Government of this Island. Nearly half a hundred new Magistrates were gazetted last week; and we understand that another batch will be announced in the next Gazette. Nearly all the Road Commissioners and Collectors of Excise under the late Government, have been displaced: and, strange to say, even judicial officers, such as Commissioners of Small Debts, have been cashiered, without a fault being assigned against them. The public interest has likewise been sacrificed to the demon of party in the removal of most competent and trustworthy keepers of some of our Light Houses, and in one case particularly even the poor excuse cannot be alleged that the victim was a political partisan; but on the contrary, he was a harmless, inoffensive, efficient, and indefatigable public servant, who never took any part in political strife, and enjoyed the highest character from the pen of the late Governor.

We observe that Henry Hazard, Esq., has resigned the office of Colonial Secretary, and that W. H. Pope, Esq.,—brother of Hon. J. C. Pope, an Executive Councillor—has been appointed to the place. We all know that, for several months past, Mr. Hazard's removal was a foregone conclusion; and rumour states, that it was with great reluctance and some difficulty he was prevailed upon to give up the office to Mr. Pope, to whose appointment the late Governor would not consent. We were at a loss to know how Mr. Hazard got to be appointed in the first instance—it is still more difficult to understand how the public service is to be benefited by the late change; and what is more incomprehensible than anything else is to perceive how Mr. J. C. Pope—the Executive Councillor and member of Parliament—can have the face to prattle about legislative independence; as illustrated in his own person, when he is bound by the strongest ties to do all he can to keep his brother in office.

We shall take an early opportunity to group together the various dismissals and appointments since the change of Government, and to ascertain, if possible, how the public interest has been promoted thereby.

A DISTINCTION WITHOUT A DIFFERENCE.

We take the following short paragraph from an article in the last *Islander*—
"With regard to the statement that the sum of £200 has been already expended by the new Committee, of which the Hon. Colonel Gray is chairman, we can as confidently tell the Editor of the *Examiner* that he is in this matter also equally mistaken, not one shilling of this sum having been yet drawn for."

Now, the *Islander* must not attempt to impose upon us or the public by such shallow mystification as the above extract discloses. It may be true that the money voted for the repairs of Government House has not been "yet drawn for," but is this any proof that the work has not been done, and that the money is not due to the amount of at least £200? Indeed, we know the work has been performed, and if the tradesmen have not been paid, it is their own fault, and the Government is guilty of most culpable neglect in keeping them out of their honest dues.

THE LIBEL CASE.

The case of William McGill, Esq., vs. the Proprietor of the *Islander*, was tried before a special Jury on Wednesday last. This was an action for an outrageous and unprovoked libel, published against the plaintiff shortly after his appointment to the office of High Sheriff in the spring of last year. The defendant charged Mr. McGill with fraud in his private capacity as a merchant, without the shadow of foundation, and attempted to show thereby that the Government did wrong in appointing him to the office of Sheriff. Unable to justify the charge, the defendant's counsel pleaded the general issue, and rested his defence on the silly plea, that in assailing Mr. McGill's private character, it was not the intention of the *Islander* to do him an injury, but to censure the Government for appointing him. This was an extraordinary ground of defence, and if tenable, would lead to the most dangerous results. According to the argument adduced by the learned counsel, any public journalist may invent and circulate what falsehoods he pleases against the private character of an official—may assert that he is a bankrupt and a swindler, a thief, a murderer, or any thing else; and if brought to account for his libellous attacks, may demurely say that he did not intend to injure the party assailed, but to redress a public wrong. On the Jury there were eleven persons politically opposed to the plaintiff, and only one whose principles were in harmony with his own. Our readers will not be surprised, therefore, to learn that no verdict was agreed to—the Jury were discharged; and the case stands over for further investigation. We believe that a report of the trial was taken, and as soon as the speeches of counsel shall be given to the public, we may offer some further observations upon it. The Hon. M. I. Wilkins, of the Nova Scotia Bar, with the Hon. Joseph Hensley, were of counsel for the plaintiff; and the Hon. E. Palmer for the defendant.

SUPREME COURT.

The following are the sentences pronounced by the Chief Justice yesterday (Monday,) against the several persons convicted of criminal offences during the present term of the above Court. It will be seen that the notorious Ewen Amos, whose exploits in the forgery line we had occasion publicly to advertise last winter, and who appears to have transacted a wholesale business as the maker of fraudulent notes—has been happily brought to the end of his tether, having been convicted on two indictments for forgery, and sentenced two years imprisonment.

The Queen vs. Ewen Amos.—Forgery. The sentence of the Court is, that you, the said Ewen Amos, be imprisoned in the common Jail of this County for twelve calendar months.

Same vs. same.—2nd offence. The sentence of the Court is, that you, the said Ewen Amos, be imprisoned in the common Jail of this County for twelve calendar months. This period to commence at the period of the expiration of your former sentence.

The Queen vs. Mary Burns.—Larceny. The prisoner sentenced to six months' imprisonment.

The Queen vs. Philip Coyle.—Assault on a Constable in the execution of his duty. The traverser sentenced to three months' imprisonment.

The Queen vs. Andrew Hand.—Sentence deferred until to-morrow.

The Bazaar, in aid of the funds of St. James's Church, came off on Tuesday last at the Temperance Hall, and was a splendid success. The room was tastefully decorated for the occasion. The tables were loaded with an endless variety of elegant and useful articles, cake, fruit, &c. Large crowds of ladies and gentlemen (including General Williams and suite, Governor Dundas, His Worship the Mayor, &c.) attended the Bazaar, and made purchases during the day. The sum realized amounts, we understand, to £240.—M.

THE VOLUNTEER COMPANY OF ARTILLERY, commanded by Captain Pollard, was, on Friday last, July 8, inspected in the Barrack Yard by Major General Sir W. Fenwick Williams, Commanding Her Majesty's Forces in British North America, accompanied by His Excellency the Lieutenant Governor and Mrs. Dundas. After having fired a salute with great regularity, the men at each gun were addressed by the Major General, who complimented them on the very efficient appearance of the corps—so recently raised—and remarked particularly on the very plain manner, involving a very trifling outlay, in which the new volunteer forces in Great Britain are equipped, and that a simple uniform is now universally adopted, where men possessed of thousands a year enrolled themselves; so that a very little expense would render their appearance quite in unison with the fashion of the present day. After three cheers had been given for Her Majesty the Queen, three for General Williams, and three for the Lieut. Governor and Lady, they left the ground.

We hear that it is in contemplation to attach a certain number of Riflemen to the corps. Captain Pollard's Company fired a salute on the landing of Sir W. Fenwick Williams on Tuesday last.—Com.

MELANCHOLY ACCIDENT.—Seldom has it fallen to our lot to record a more painful incident than now devolves on us. The Yacht race of Tuesday, which was looked forward to with so much pleasure by the lovers of aquatic sport, and which so well commenced a glad, unfortunately, a future connected with it which has cast a gloom over a large circle in our community, and one that will be painfully recollected in after years. One of the boats in the race, named the *Firefly*, had on board Hon. Ernest Cochrane, (son of the Earl of Dundonald), John H. McNab, Esq., Harding Stewart, Esq., and two Midshipmen belonging to the *Indus*. When off the Asylum the boat, while in stays, was struck by a squall and capsized; she sank almost immediately; the parties in the boat were precipitated into the water, from which the two Midshipmen were rescued by persons in Mr. John Wallace's boat, Lt. Cochrane and Mr. McNab were taken into Mr. S. A. White's boat, and Mr. Stewart was picked up by Mr. Fishwick, who was sailing in a boat near where the accident occurred. When Mr. McNab was taken out of the water he was nearly exhausted; he was supported for a considerable time by Lt. Cochrane, who is an expert swimmer. He was taken on board the *Indus*, where every effort was made by Dr. Domville and other medical gentlemen to restore animation to the body, but, we regret to say, without effect. The thought is a painful one to reflect on. In a moment, in the prime of life, buoyant in spirits, beloved by all, this man has passed from our view, and the place and friends that knew him so well will now know him no more in this life. We deeply sympathize with the family of the deceased in their sudden and sad bereavement.—*Halifax Sun*.

UNITED STATES.

An attempt was made on Monday evening, by a party of citizens in the 7th Avenue, New York, to hang a man named Wm. Jordan, who had committed an infamous outrage upon a little girl six years old. A gallows was prepared, when the police interfered just in time to save his life. He is now in custody under the protection of the police, as the excitement against him is intense.

A young fellow in Detroit went to the house of a lady to invite her two daughters to a dancing party. She refused to allow them to go. A quarrel ensued between the boy and the girls on one side, and the old lady on the other. The young people finally threw the mother upon the floor, choked her till she was nearly dead, and then went off to the ball. The boy was sent to Jail.

The San Diego *Herald* says that Gen. Wm. Walker has resigned filibustering, and that he intends to unite his destinies with a lady of Lower California, who once saved his life. She is said to be abundantly rich, but objected to the alliance in consequence of a difference of religion. That has been obviated by the ceremony at Mobile.

The number of dogs put to death in New York, the present season, up to last night, was 2000, besides 158 puppies. The amount paid by the city for this canine slaughter is \$1034 50.

On Friday afternoon two unknown men fell dead in New York. One was an aged man, well dressed, and having in his pocket a draft for \$347. The other was a laboring man, of about thirty years of age.

A man named Lee has been arrested at Ithaca, N. Y., for poisoning his wife, to whom he had been married but five weeks.

The Brig *RAYMOND*, Raymond, master, of Yarmouth, Nova Scotia, from Richibucto, bound to Belfast, Ireland, laden with Deals, ran on to the reef of the North Cape of this Island, on Thursday, the 30th ultimo, and is a total wreck. She is advertised for sale for the benefit of all concerned.

ANOTHER GREAT BATTLE.

The following important Telegraphic Message was received on Friday, July 8:—
Liverpool dates to the 25th ult. have been received at Newfoundland.

Emperor of Austria had removed head quarters to Valcejo; he had two hundred and eighty thousand troops at the Ticino.

Swiss troops sent from Rome to Perugia to suppress rising—had a desperate encounter with the people.

Prussia demanded permission to march thirty thousand troops through Hanover to the Rhine.

Believed the basis of peace negotiations proposed by Prussia are not acceptable to France, and may involve Prussia in war.

Napoleon telegraphs to the Empress the following:—
"CANDIA, Friday Evening.—Great battle! Great victory! Whole Austrian army formed in line of battle, extending five leagues in length. We have taken all their positions, captured many cannon, flags, and prisoners. The battle lasted sixteen hours.

Vienna despatches confirm battle, but give no details.

RULES AND REGULATIONS.

NOTICE is hereby given, that in pursuance of resolutions passed by the Committee, the following alterations and amendments have been made in the Rules of the Society, viz:—
SQUARE TRUSS will be allowed for first footlocks and amidships, to an extent not exceeding one-half the length of the keel, in ships of the 6 years' grade. And for outside planking "from first footlock heads to light mark" in ships of the 6 years' grade; and from "light mark to wales" in ships of the 5 years' grade; also for "self-pieces, clamps, and lower deck waterway" in ships of the 5 years' grade.
TABLE A will be amended accordingly.
SECTIONS 39 and 62, requiring ships, the length of which exceeds six times their extreme breadth, to be fitted with a rider keelson or a pair of sister keelsons, has been amended as follows, viz:—"If a rider keelson be adopted, it is to be fastened with a through bolt (of the size required in Table D for keelson bolts) in every frame; or, if the owner prefers it, every intermediate bolt may be short, passing only through the main and rider keelsons." And such short intermediate bolts may be of iron in ships claiming an additional period for copper or yellow metal fastenings, under the Rules, Sec. 46.
It has also been made a rule that in all cases in which a rider keelson is fitted, it must be fastened as prescribed above, irrespective of the relative dimensions of the ship.
The Committee have instructed their surveyors to satisfy themselves of the efficiency of the caulking in the cases of new ships, by having pieces cut out of the bottom, as the only means of ascertaining with certainty this important point.
And to obviate the evils arising from grain-cut and knotty (greenish) timbers (the Committee considering that in all cases they should be made from cleft timber,) the surveyors have also been instructed to object to the use of such timbers.
