Hospital Ass'n Opens Two-day Conference Here

Executives from 15 Roman Catholic hospitals in the Maritime Provinces attended the 15th annual conference of the Maritime Council of the Catholic Hospital Association of Canada and the United States which opened yesterday in Notre Dame Academy.

The two-day conference opened with mass celebrated by the Right Rev. Msgr. G. J. McLean, vicar general of the Charlottetown Diocese and a sermon delivered by Rev. J. E. Burns, D. D. of Halifax.

At the opening business session a civic welcome was extended by Deputy Mayor B. Roy Holman. Delegates were welcomed on behalf of the diocese by Msgr. McLean, acting on behalf of His Excellency Bishop J. A. O'Sullivan, who is en route to Rome.

W. J. P. MacMillan welcomed the delegates on behalf of the Charlottetown Hospital of which he is chief of the medical staff.

Dr. MacMillan paid tribute to the Grey nuns who formerly managed the City Hospital and to the new order, The Sisters of St. Martha who are now in charge.

The annual address of President Sister St. Paul of the Cross was included in the business of the morning session. Reports were heard, too, from the Secretary and Treasurer.

A resolutions committee was appointed consisting of Mother Ignatius, Glace Bay; Sister Anna Seton, Halifax and Sister Stanislaus Charlottetown.

At the afternoon session the report of public contacts was delivered by Sister Cecilia of Halifax. This was followed by the report on nursing education by Sister St. John of Charlottetown.

In this report the Sister stated several schools of nursing are operating on an eight hour day, some on a straight eight hour plan and others on a divided day.

Sister Agnes of Helena, Montana, representing the executive of the Parent Association spoke on hospital administration.

The first such course to be given at a Catholic Hospital was at St. Louis, Missouri in July of this year. The course would be repeated annually, the speaker announced.

The remainder of the afternoon was taken up with a round table discussion of hospital problems.

In the evening the delegates were taken on a drive to the north shore of the Province, including a stop at Green Gables. A picnic lunch was served in the National Park.

Today's sessions of the organization will continue with the report of the resolutions committee and the election of officers being important items on the agenda.

FRENCH ARMY TAKES CONTROL OF RAILROADS

PARIS, Aug. 30 (AP)—The government tonight ordered all railroads turned over to the army as France put the finishing touches on its preparations for war while awaiting the outcome of German-British negotiations for peace.

The decree, which took effect at once, meant that all civilian passenger and commercial traffic will be either suspended or "curtailed" to meet the army's needs for transportation of troops, guns and supplies.

Even trains actually on the road may be shunted onto a siding at the next station and unloaded.

In further preparation for possible war General Maxime Weygand, 72-year-old Great War hero and former commander-in-chief of the army, arrived in French-mandated Syria during the day and was reported in military circles to have been chosen to be commander of the allied French, British, and Turkish forces in the near east if war should come.

General Weygand flew from Paris, where for the past three days he had been in almost continuous consultation with Premier Edouard Daladier and Foreign Minister Georges Bonnet as well as the Army General Staff.

The railway requisition decree was understood to have been decided by the Government this morning. Sources close to the government claimed that it was not to be considered by itself as meaning that the international situation had taken a turn for the worse.

The orders followed hard on the heels, however, of the Government's fourth urgent warning to all civilian residents of Paris to leave the city.

The fourth evacuation warning, which was made public only a few hours before the railroad requisition, still referred to "unhampered communications" and said its purpose was to prevent "unjustified protests" by travelers who failed to leave while transportation was still available.

At the time the requisition went into effect it was estimated that less than one third of the capital's 3,000,000 inhabitants had left.
