PARTY UPS AND DOWNS.

RECALLED BY MR. GLADSTONE'S LAYING DOWN OF OFFICE.

British Liberal and Conservative Majorities Since 1860—Successive and Interesting History of the Relative Standing of the Great Parties in the Mother Land.

The ups and downs of the Liberal and Conservative parties in England are interesting and the laying down of office by Mr. Gladstone is an historical event that calls for special attention. The general elections from 1859 have had a more or less appreciable effect upon the foreign relations of England, and it is for this reason that these events are noted abroad.
