\$8 Billion Investment Fund Seen From Que. Pensions

QUEBEC (CP)—The Quebec pension plan could have an investment fund of more than \$8,000,000,000 within 30 years of its inauguration, it is estimated in a report tabled in the legislative assembly Friday.

The report—first of three from teams of actuaries and economists—said the Quebec plan could provide a maximum premium of \$150 a year to persons 65 and over.

Premier Lesage tabled the report in the legislative assembly of the Quebec and federal government plans which he referred to the federal-provincial fiscal conference last week. The Quebec plan also provides for the federal-provincial fiscal conference last week.

Tables contained in the report estimated that if the plan took effect in 1966, it could have a fund of \$125,000,000 a year. This would expand to about \$5,000,000,000 by 1996, depending on the amount of money paid in, the amount paid in pensions and the cost of operating the fund.

The Quebec government sees the plan as an essential source of investment capital for the province's economy. Under the Quebec plan, an
