

ABDICATION OF THE SULTAN IS DEMANDED

Macedonian Troops Will Enter the Capital. The Ministry Totters. British Warships Hasten to Turkish Waters. Peace on Any Terms the Sultan's Plea.

LONDON, April 19—(Special)—The Macedonian troops intend to enter Constantinople and enforce their demand for the abdication of the Sultan. The new ministry is tottering. It is believed adequate steps have been taken to guarantee public order.

MALTA, April 19—The battleships Swiftsure and Triumph have sailed from here presumably for Turkish waters. BERLIN, April 19—(Special)—A Constantinople correspondent has been informed that the Sultan has sent the Chamberlain and Secretary to the Grand Vizier with orders that he make peace with young Turks on any terms without bloodshed. The Sultan declared that if his person was a hindrance to peace he was willing to offer himself in order to save the fatherland from catastrophe.

"THEOLOG'S" QUESTION DIVINITY OF CHRIST

NEW YORK, April 18—Four candidates for licenses to preach were examined before the Presbytery of New York at its annual meeting in the First Presbyterian church.

Three of the candidates, members of the senior class of Union Theological Seminary, were turned down, not absolutely, however. They will have an opportunity to confer with a committee of the Presbytery, who will examine them further as to their views on theology, Christ and the sacrament.

One of the three who failed to be sustained was Archibald Black, a brother of the Rev. Dr. Hugh Black, the well-known Edinburgh preacher. The two others who have got to toe the mark before the special committee are George E. Fitch and John Steen. The meeting was described as one of the most extraordinary for candidates. Some of the older members of the Presbytery, preachers of the old school, could scarcely restrain their tears in discussing the answers that the candidates made to some of the fundamental questions. The examinations and discussion took place, of course, in executive session, but many of the ministers talked freely of what occurred.

Candidate Steen, it was said, was the most outspoken in his beliefs. He questioned the miracles and accented the modern view of the divinity of Christ. He did not believe that Christ arose from the dead in His body. The

THREE DROWNED IN THE ST. LAWRENCE

GANANOQUE, Ont., April 18—A triple drowning accident occurred on the St. Lawrence, between here and Clayton, N. Y., Saturday afternoon. The victims are J. M. Taylor, aged 18, and Mr. and Mrs. R. Bolans, aged 23 and 27 respectively. The three left this town about one o'clock Saturday in a small skiff. It is not known how the accident happened, as nothing was seen of them until N. Pelon, who works on Club Island, on the New York shore, heard some one calling for help. He saw two clinging to the up-turned boat and hurried to aid them in the skiff of his own, but when he reached the place both had dropped off. The bodies of Taylor and Mrs. Bolans were recovered yesterday in 20 to 30 feet of water.

F. MARION CRAWFORD'S WILL IS FILED

NEW YORK, April 18—The will of F. Marion Crawford, the novelist, who died in Italy, was filed with the surrogate here last week on behalf of Arthur Terry, the brother of the testator, who is appointed his executor. The value of the estate was not indicated. Mr. Crawford leaves \$10,000 to his wife, saying that she has been amply provided for by the will of her father, General Hiram Borden. The residue of the estate is left in trust to his brother to pay the income to his two sons, and his two daughters, who reside at Sorrento with their mother, until they reach the age of 25 when the principal is to be equally divided between them.

A PREACHER AND THEOLOGIAN

HALIFAX, April 19—Rev. Professor James Denny, of Glasgow, was heard by very large congregation in Halifax yesterday. Dr. Denny has a very musical voice, his appearance and manner are pleasing, kindly and sympathetic, and, best of all, he is a cultured, thoughtful, earnest and impressive preacher. He is an outstanding figure in the theological world—probably none better known or more famous on either side of the Atlantic. His style is clear cut and convincing, possessing a fine literary charm, and his writings are in every complete library.

At Fort Massey church in the forenoon Dr. Denny's text was the well-known verse in Corinthians in which the apostle compares and contrasts the grandeur of "charity" with faith even of the kind that "removes mountains." Without this charity—love—the faith and other attributes are as nothing. What is this love? The preacher answered with a definition which he said he quoted from another writer, in these words:—"It is the identification of ourselves with God's interest in others." The other qualities are all very well, but without this love, this attitude towards others, we are useless in service to the Master.

COMMISSION FOR THE INTERCOLONIAL

MONTREAL, April 19.—Two important announcements were made on Saturday.

The first statement of Hon. Mr. Graham was that the Commission for the Government had decided to appoint to run the I. C. R. are to be Mr. J. Butler, Deputy Minister of Railways, David Pottinger, now General Manager, E. Tiffin, Traffic Manager, and Frank Brady, until a short time ago, the General Superintendent of the Lake Superior Division of the Canadian Pacific.

This Board, said Mr. Graham, would operate the road in the same way as a Commission now operates the Penna Lines. There has been a great deal of talk about selling out the International, but the Government was not in favor of either of these plans at the present time, and for a year would make a test of the new method, in the hope that it would produce better results. The other topic touched upon was Naval Defence. Hon. Mr. Graham was against the policy of building a Dreadnought for the British Navy or of giving a cash contribution towards the construction of ships. He fore-shadowed that the Canadian Government would build vessels for the Indian coast defence and continue the policy of home defence started when the Government undertook to garrison Halifax and Esquimaux.

Hon. Mr. Brodeur announced that he and Sir Frederick Borden would leave for London where they would consult with the Imperial authorities as to Canada's best plan.

UNWRITTEN LAW FINDS A VICTIM

Jealous Husband Kills Man Who Dying Protests He is Innocent.

PORT HURON, April 19—(Special)—Geo. McKinnon aged 31 years, was shot dead by Capt. Ralph Pringle of St. Clair in the latter town.

McKinnon died after remaining unconscious almost until the last. Pringle told the officers that McKinnon had flirted with his wife three years ago and he had vowed to get even.

Neither of the men were intoxicated at the time. Before breathing his last McKinnon said Pringle had no reason for the shooting.

SYDNEY FISHER'S ELECTION CASE

Defended on Technicality and Judge Demers Reserves His Decision.

MONTREAL, April 19—(Special)—trial of the protest against the election of Hon. Sydney Fisher took place at Sweet'sburg.

It was mostly of a technical nature. The plaintiff charged all the offences under the election law but the evidence was little and not sensational. The defence was only technical on grounds that writ was not served within the time allowed by law. Judge Demers took the case on deliberate.

FOUND EVELYN THAW PLAYING WITH SNAKE

NEW YORK, April 18—After a long hunt, process servers located Mrs. Evelyn Nesbit Thaw at a house on West Thirty-third street and served papers in supplementary proceedings in the suit of Miss Bliss Kattung, a milliner, who got judgment against Mrs. Thaw last September for \$253.

Mrs. Thaw was found playing with a snake, which was coiled around her left arm. When told of the proceedings she said:—"I'll be there, but the whole thing is a farce. I don't owe the money."

TERRIBLE UPRISINGS IN ASIATIC TURKEY

BEIRUT, April 19—A terrible uprising has occurred in Adana, Asia Minor. Street fighting has been going on for three days and 1,000 persons have been killed. The city is practically destroyed by fire. Two American missionaries named Rogers and Maurer are dead. All the other Americans in the city are safe. The British Vice-Consul, Major-Douglas-Wylie, is among the wounded.

At Tarsus there was less loss of life. The American quarter was destroyed. Four thousand refugees are housed in the American Mission. The need of relief is urgent, for shortly the fugitives will be on the verge of starvation. The conditions in Alexandria are also most alarming.

LONDON, April 19—It is unsafe to predict anything as to the surprising developments in the Turkish crisis. The present situation, however, seems to portend another triumph than that of the July revolution and unlikely this time, to involve the deposition of the Sultan.

While the army seems to be rallying to the Committee of Union and Progress, whose leaders already are gathering an imposing force with artillery almost at the gates of the Capital, with completeness, despatch, and secrecy showing the capacity of the organizing Generals, the authorities in Constantinople, both civil and military, display utter helplessness to meet the threatened invasion.

CONSTANTINOPLE, April 19—The telegraph line to Adana has been re-established, but owing to the fact that five of the clerks were killed the line is congested, and it is difficult to get messages through. Over 1,000 persons were killed at Tarsus and Alexandria. Massacres and incendiaries continue. The Saloniki army has six batteries of machine guns and one battery of light-bombing guns. They expect by this morning to number 30,000 men at Spatakuleh. Quiet reigns in Constantinople.

AN IMPORTANT OFFICE ABOLISHED

That of General Manager of Intercolonial Will be Merged in Commission. Mr. Brady From C. P. P. Accredited.

OTTAWA, April 19—(Special)—In connection with the announcement made by Hon. Mr. Graham that Messrs. Butler, Pottinger, Tiffin, and Brady would constitute the new Commission of management for the Intercolonial railway, it may be added that the position of General Manager, held since 1892 by Mr. Pottinger, is now abolished and the duties will be embraced in those of the new Board.

A HALIFAX FIRM REFUSES CANNED MEATS

MONTREAL, April 18—Twenty-five thousand tins of canned meat were on Saturday confiscated by the city health department as being unfit for human food. There will be other consignments destroyed in the city during the coming week. The consignment, which comprised 25,600 cans, originally came from Chicago and was sent to Toronto, whence it was sold to a Halifax firm, who refused delivery. The meat was then sent to Montreal and sold at less than half the wholesale price, but the city inspector got on its track before more than three cases were sold to a retailer. The meat was old and tainted and in many cases the cans had become rusted through, while fancy labels had been pasted over to give them a saleable appearance. Prosecution will take place on Monday.

NOBLE GIFT FROM PRIEST TO PARISH

ANNAPOLIS ROYAL, April 18—At the conclusion of the service in St. Louis' Roman Catholic church here, Rev. Father Thomas Grace made the announcement that he had that day presented the parish a sum of \$1500 to be used as a commencement for a building fund for a new church. The amount was the principal and interest of \$1,000 that was presented to him on his departure from the parish seventeen years.

FIRST MACKEREL CATCH

NEW YORK, April 18—Captain Chicester of the steamship Arapahoe, in from Jacksonville and Charleston, reports, having passed through immense schools of mackerel while off the Delaware capes and New Jersey coast the other night. There was school after school, each containing millions of the fish. One school alone, according to Captain Chicester, covered an area of more than a square mile. He said he had not seen so many fish together in years.

GROUND TO DEATH BY AN AUTOMOBILE

ELIZABETH, N. J., April 18—Being confused through the sudden approach of a trolley car, Annie Dazkesi, 17 years old ran directly in front of it, and she and the one-year-old child she was carrying were ground to death under the trucks. A crowd gathered and but for the prompt arrival of policemen the motorman would have been roughly used. Frederick Brown, the motorman, was arrested. He says he was running slowly when he hit the girl and the child.

WIFE OF BANK MANAGER FINED

OTTAWA, April 18—Mrs. W. J. Anderson, wife of the Ottawa manager of the Bank of Montreal, discharged a servant a few days ago. Now she was unpleasantly reminded of the fact by being fined in the police court for having partridges in her possession upon the dates mentioned in the information. It appears that the partridges were given to Mrs. Anderson by a friend and that they were accepted, not knowing that the laws did not allow the possession of the birds during the closed season. Under the circumstances the magistrate had no other recourse but to impose the penalty laid down by the statute.
