BOODLING EXTRAORDINARY.

SIR.—The farmers of this Province have a duty to perform and that is to unite, rise in their might, and hurl from power the Local Government that is now misruling and mis-managing the affairs of the Province. I understand that at Centre-road, Lot 22, there is now a piece of unnecessary public work expensiture. The road is shifted a few yards from its present location; so as to be made to cross a little stream, and requiring four new and additional bridges. The Public Works Department, and the leader Mr. Warburton, must be responsible for this. I am not aware of a public sale, but I am assured the contractor is now at work. Why should the Province be called upon to build and maintain four new bridges where none was necessary for the last fifty years? Is it to put money in some henchman's pockets? or is it to keep pace with that other piece of scandalous corruption and waste of money by the Dominion Government at Wiltshire. The hand writing is becoming visible upon the wall, and the guilty will be assuredly punished in due season. The Government of the country should make honor and duty the steady beacon lights that shall guide the affairs of the Province over the stormy sea of political strife; to do that which it is right to do, not because it will insure success, bring the best reward, or be the best policy, but because it is right and therefore ought to be done. The people must now wake up and make incessant war against this party of boodling and corruption, and labor to reclaim the affairs of the country from its spoilers and defamers, and place wise men as councillors at the head of affairs.

This must be the duty of every taxpayer, in this province. Public meetings should be called or a commission should be appointed to investigate the affairs of the province, take evidence of every mismanagement and boodling expensiture, and publish a report that cannot be contradicted. The opposition in the House of Assembly should compel the production of all books and papers, and memorialize the Lieut. Governor whenever they are refused. The accounts of the province should be published for the information of the people. It is reasonable and just to infer that this job at Hepe River was given or promised at the time of the last election, so that the work being performed now will not show in the public accounts till 1899, when the people will have plenty of time to forget the matter. How long will this state of affairs continue or last?

The pulpit and the press have a sacred duty to perform—they have to keep the people instructed in the way they should go, and the warning sounded in their ears is the duty of every faithful watchman. A snap verdict was obtained last year by treachery and deception, clearly proving the adage that the "mob loves humbug." I hope, sir, you will wake up and wield your pen with power that will make the citadel shake.

HOCKEY LAST NIGHT.

The Wanderers Win From the Victorias by Four Points.

The Wanderers, of Halifax, and the Victorias, of Charlottetown, crossed hurleys in Hillsborough Rink last night. The visitors won by four points, the score at the finish standing 6 to 2 in favor of the Haligonians.

The Wanderers left Halifax on Tuesday morning and expected to be in Charlottetown that night. But when they got to Pictou they discovered that the Stanley had left for Georgetown earlier than they calculated upon and they had to remain in that town over night. They took advantage of the stop-over to play a game with the Pictou team, to whom they administered a good coating of whitewash.

Yesterday they crossed to Georgetown in the Stanley, and arrived in Charlottetown a few minutes before eight o'clock, the time set for the match with the Victorias. Of course the inner Wanderer had to be attended to upon their arrival, and by the time play began it was past nine o'clock. The teams lined out as follows:—

The Wanderers defended the southern goal and the Victorias the northern. Stewart and McIntosh faced off. For the first ten minutes of the play there was no material advantage gained by either side, the puck being kept moving from end to end at a lively rate. Then Stephen broke the monotony by shooting a goal for the visitors, and later on the trick was repeated for the same side by McIntosh despite the efforts of the home team to even up matters. Before half time was called Stephen added another goal to the Wanderers string. Score: Wanderers 3; Victorias 0.

In the second half the Victorias put up a more aggressive game, and Weeks, after a brilliant dash, shot the first goal for the home team. Shortly after play was resumed, however, McIntosh scored for the Wanderers. The play then became faster, than ever, and some lively dashes were made for the goal posts. Stewart's good work in this connection bore fruit, and he secured the second goal for the home team. The Wanderers seemed to get on their mettle at the cheers for the home team, and they became more aggressive. McIntosh and Pickering each obtained a goal, and the home team failed to score. The score at the close of the game was therefore 6 to 2, in favor of the Haligonians.

The play throughout was capital. The Vics. made a highly creditable showing under the circumstances. Their defence was strong and their forwards did good individual work. But the Wanderers' clever combination play was too much for them, and won the game for the visitors. The Wanderers are experts in passing the puck, and did some very pretty work in this line last night although the rink was smaller than the one in which they are accustomed to play. Mr. L. B. McMillan made an excellent referee.

Tonight the Wanderers play a match game with the Summerside Club, and tomorrow night they will measure sticks with the Abegweit in Hillsborough Rink. The game will be well worth witnessing.

The body was taken to Pictou last evening, accompanied by his brother, Rev. Fenwick Fraser, and by the deceased eldest son Arthur, now a student at St. Dunstan's College. Dr. Fraser was 46 years of age at the time of his death. He was much respected and beloved by the people of St. Peter's Bay, among whom he lived and practiced his profession for a period of twenty years.
